## Recommendation

It is recommended that the Authority approve the I-680 Sunol Smart Carpool Lane FY2023-24 First Quarter Financial Report.

# **Summary**

This financial report provides a summary of actual revenues and expenses related to the I-680 Sunol Smart Carpool Lane for the fiscal year through September 30, 2023 compared to budget. Net toll and other revenue were \$3,137,032 or 65.1 percent more than projected revenues through the first quarter of FY2023-24 due to better than expected toll revenue collected during the first quarter. Operating expenses through the first quarter totaled \$1,194,283 or 22.7 percent less than budget mostly related to enforcement, due to other CHP priority projects during the first quarter, and an unused contingency allowance. These variances together result in an increase to net position of \$1,942,749 for an ending net position of \$29,420,427 comprised of investments in capital assets of \$21,260,815, maintenance and operational risk reserves of \$3,000,000, and unrestricted net position of \$5,159,612.

As of September 30, 2023, the I-680 Sunol Smart Carpool Lane had cash and investments totaling \$9.1 million.

# **Background**

The FY2023-24 operating budget approved by the I-680 Sunol Smart Carpool Lane Board in May 2023 included \$7.6 million of revenues which was offset by \$7.0 million of expenses, including depreciation, resulting in an increase of \$0.6 million to the projected ending net position for the fiscal year. The projected net position in the budget at the end of FY2023-24 was \$15.6 million comprised of \$11 million invested in capital assets; \$1.0 million

reserved for maintenance; \$2.0 million reserved for operational risk; and \$1.6 million of unrestricted funds. There was no capital budget proposed for FY2023-24.

**Fiscal Impact:** There is no fiscal impact associated with the requested action.

#### Recommendation

This item is to provide the Commission with an update on the operation of the I-680 Sunol Express Lanes from tolling commencement on March 31, 2023 through the first quarter of fiscal year 2023-2024. This item is for information only.

# **Summary**

The purpose of this item is to provide the I-680 Sunol Smart Carpool Lane Joint Powers Authority ("Sunol JPA") with an operations update of the I-680 Sunol Express Lanes from tolling commencement on March 31, 2023 through the first quarter of fiscal year 2023-2024 (March 31, 2023 through September 2023). The I-680 Sunol Southbound Express Lane originally opened to traffic in September 2010. After tolling operations were paused on the southbound lane during construction of a new northbound lane, both directions commenced tolling operations on March 31, 2023. Over 3.4 million trips have been recorded in the express lanes from March 31 through September 2023. See Attachment A for more detail.

# **Background**

The I-680 Sunol Express Lanes spans approximately 14 miles in the southbound direction, from SR 84 near Pleasanton to SR 237 in the City of Milpitas, and 9 miles in the northbound direction, from just south of Auto Mall Parkway to SR 84. The I-680 Sunol Southbound Express Lane originally opened to traffic in September 2010 as a controlled access express lane. Construction began in 2018 on a new northbound express lane and to convert the southbound express lane to a continuous access configuration. Beginning August 10, 2020, the southbound express lane began operating in HOV-only mode while this construction was taking place and to transition to a new toll system. The new northbound express lane opened to traffic, also in HOV-only mode, on October 29, 2020.

Tolling resumed in the southbound lane, concurrent with tolling commencement on the new northbound lane on March 31, 2023.

The Alameda CTC, acting as the managing agency for the Sunol JPA, operates the I-680 Sunol Express Lanes. An All Electronic Toll (AET) collection method has been employed to collect tolls. Toll rates are calculated based on traffic conditions (speed and density) in the express lanes and general purpose lanes. Single occupancy vehicles have the option to pay a toll to travel in the express lanes; registered clean-air vehicles receive a 50% toll discount; and carpools with two or more occupants, motorcycles, and transit vehicles enjoy the benefits of toll-free travel. California Highway Patrol (CHP) officers provide enforcement services, and the California Department of Transportation (Caltrans) provides roadway maintenance services through reimbursable service agreements.

Two communications efforts were conducted in early 2023 to announce the resumption of tolling operations and to remind drivers about toll tag requirements. Outreach was conducted using various media channels, including radio, print, digital, social media, and in-person events. The first effort lasted from February through May to educate drivers on the toll discount policies and requirements for the I-680 Express Lanes and encourage drivers to obtain a FasTrak Flex® toll tag to use express lanes. Subsequent communication efforts conducted from July through August reminded drivers to set their switchable toll tags to correctly match the number of occupants in the vehicle and that CHP enforces occupancy requirements or improper toll tag use.

Performance of the I-68o Sunol Express Lane from March 31, 2023 through the first quarter (Q1) of FY 2023-2024 are highlighted below and additional details are provided in Attachment A. Prior to tolling operations resuming earlier this year, significant traffic congestion has been observed to occur on northbound I-68o over the Sunol grade during the afternoon peak period. This congestion begins at the SR 84 interchange and extends as far back as Auto Mall Parkway, resulting in low traffic speeds that have impacts on express lane operations. Staff are closely monitoring traffic performance to adjust toll pricing and are working with CHP to provide enforcement patrols to discourage occupancy violations that degrade express lane operations. A data collection effort is currently underway to estimate travel times in the corridor and to estimate the percentage of vehicles in the express lanes that may be violating the occupancy requirements. The results of this effort will inform any proposed changes that may be required to improve express lane performance.

## FY 2022-2023 Q4 Operations Update:

- Motorists made nearly 1.7 million express lane trips during operational hours in Q4.
  - o Daily express lane trips averaged 27,000 a day.
  - o Paid trips totaled 905,000, or 14,000 trips per day.
  - o Toll-free trips made up 47% of all trips.
- On average, express lane users experienced better traffic conditions compared to all lanes, particularly during peak commute hours.
  - o Southbound peak period (7 AM 10 AM) express lane speeds averaged 7 miles per hour (mph) faster than all lanes.

- $\circ$  Northbound peak period (3 PM 6 PM) express lane speeds averaged 15 mph faster than all lanes.
- Solo drivers carrying clean-air vehicle (CAV) tags receive a 50% toll discount.
  - o Single-occupant CAVs were 1.6% of total single-occupancy trips taken during the quarter.
- The average assessed toll for single occupancy vehicle (SOV) motorists was \$2.91 and \$5.04 for southbound and northbound, respectively.
- CHP performed 315 hours of enforcement services and made 469 enforcement contacts during Q4.







# Southbound I-680 Corridor Speed Heat Maps



## Recommendation

It is recommended that the Authority approve the Sunol Smart Carpool Lane Joint Powers Authority Draft Audited Annual Financial Report for the Year Ended June 30, 2023.

# Summary

Pursuant to Section 8.2(iv) of the Joint Powers Agreement and Section 6505 of the California Government Code, an independent audit was conducted for the fiscal year ended June 30, 2023 by Maze & Associates Accountancy Corporation (Maze & Associates) with the objective of obtaining reasonable assurance about whether the financial statements as a whole are free from material misstatement and to issue an auditor's report that includes their opinion. All financial statements are the responsibility of management. As demonstrated in the Independent Auditor's Report on page one of the Draft Audited Annual Financial Report, the auditors of the Sunol Smart Carpool Lane Joint Powers Authority (Authority) have expressed what is considered to be an unmodified, or clean, audit opinion.

"In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the business-type activities of the Authority as of June 30, 2023, and the changes in financial position and cash flows thereof for the year then ended in accordance with accounting principles generally accepted in the United States of America."

# Financial Highlights:

 Total net position increased by \$22.37 million or 438.0 percent from \$5.11 million to \$27.48 million as of June 30, 2023, compared to June 30, 2022. This increase is mostly due to contributed capital assets received from Alameda County Transportation Commission on March 31, 2023 once tolling was activated following completion of phase one of Alameda CTC's Interstate 680 (I-680) Sunol Northbound Express Lane Project. Capital assets, net of accumulated depreciation, comprised \$21.26 million or 77.4 percent of the total net position at June 30, 2023.

- For the year ended June 30, 2023, cash and cash equivalents increased by \$1.79 million or 35.3 percent from \$5.07 million to \$6.85 million compared to June 30, 2022. This increase is mostly related to the resumption of revenue operations on the I-680 Southbound Express Lane and beginning revenue operations on the northbound lane on March 31, 2023.
- Operating revenue was \$2.95 million during fiscal year 2022-23. There was no operating revenue during fiscal year 2021-22 due to the suspension of revenue operations in August 2020 to allow for improvements to be made to the I-680 Express Lanes. The express lanes reopened for revenue operations just before the fourth quarter of fiscal year 2022-23. A small amount of violation revenue collected since returning to revenue operations is reflected in the operating revenue total for the first time this fiscal year and will continue in future years due to the implementation of an automated toll violation enforcement system.
- The Authority's total operating expenses including depreciation were \$2.31 million during fiscal year 2022-23, an increase of \$1.76 million or 323.1 percent over fiscal year 2021-22. This increase is attributed to the resumption of revenue operations on the southbound express lane and beginning revenue operations on the northbound express lane on March 31, 2023, resulting in a significant increase in operations and maintenance expenses. Operating expenses of \$2.31 million for fiscal year 2022-23 were primarily comprised of operations and maintenance costs.

As part of the audit process, Maze & Associates considered the Authority's internal controls over financial reporting as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing an opinion on the financial statements. They have not expressed an opinion on the effectiveness of the Authority's internal controls; however, Maze & Associates noted that they did not identify any deficiencies in internal controls that would be considered a material weakness.

**Fiscal Impact:** There is no fiscal impact associated with the requested action.
