Consider a Request by District Three Governmental Cooperative to Change the Funding Split of the Federal Transit Administration's Section 5307 Urbanized Area Formula Funds Appropriations for Fiscal Years 2019-2020 and 2023-2024.

ITEM BACKGROUND:

The Urbanized Area Formula Funding program, commonly referred to as Section 5307, makes federal resources available to urbanized areas for transportation planning as well as transit capital and operating assistance in the urbanized area. An urbanized area is an incorporated area with a population of 50,000 or more that is designated as such by the U.S. Census Bureau. Bristol Tennessee-Virginia has been designated as an urbanized area since the 1980 census. With each census, the urbanized area is redefined based on changes in population characteristics. Currently, the Bristol Tennessee-Virginia urbanized area includes the cities of Bristol Tennessee and Bristol Virginia, a portion of Sullivan County, Tennessee, a portion of Washington County, Virginia and the town of Abingdon, Virginia. Section 5307 funding is made available each year to eligible recipients. The funding formula is based on population and population density. Funds are available the year appropriated plus five years. Matching funds are required of 5307 funding. The federal share cannot exceed 80% for capital expenditures or 50% for operating assistance. The Bristol Tennessee urbanized area and the Bristol Virginia urbanized area receive separate apportionments. Bristol Virginia Transit provides public transportation service in the City of Bristol Virginia. District Three Governmental Cooperative, perhaps better known as Mountain Lynx Transit, provides public transportation service to Washington County and the Town of Abingdon. Mountain Lynx Transit also provides public transportation service to areas outside of the designated Bristol Tennessee-Virginia urbanized area. They receive other funding sources, including federal formula grants for rural areas, or Section 5311, to support service in those areas. The greater Abingdon area and the US Route 11/I-81 corridor between Abingdon and Bristol became urbanized as a result of the 2010 census and was designated as such around 2013. In 2017, Mountain Lynx Transit was made aware that they were mistakenly using rural funding, or 5311, to serve an area that had become designated as urbanized. At that time, they had no 5307 funding available. They were allowed to continue to use 5311 funding for a time and were able to transfer some of their buses to create an urban fleet. Since FY17-18, the City of Bristol Virginia and District Three Governmental Cooperative have been splitting the Bristol Virginia 5307 apportionment to enable both organizations to provide public transportation service in the urbanized area. Each year we jointly submit a "split letter" to the Federal Transit Administration advising them of how we have agreed to split the funding allocated to our region. Historically, the split has been 69% of the annual 5307 funding to the City of Bristol Virginia and 31% of the annual 5307 funding to District Three. This split amount was originally based on the populations of the City of Bristol Virginia and the town of Abingdon Virginia and did not include the portions of Washington County Virginia that were designated as urbanized area. Mountain Lynx Transit has five daily routes and two weekly routes which fall exclusively within the urbanized area.

These routes serve the town of Abingdon and its periphery as well as the US Route 11/I-81 corridor to the Bristol City Limits. Those seven routes are paid for exclusively with 5307 funding. David Richardson, the Deputy Director of Transportation for District Three, recently reached out to City staff regarding some capital needs to build up their fleet of vehicles for use on the aforementioned seven routes. They have requested that the Section 5307 funding allocated to the Bristol Virginia urbanized area for FY24 be split with 69% going to District Three and 31% going to the City of Bristol Virginia. They have also requested that the 5307 funding be divided more evenly between the City and District Three in future fiscal years. The City of Bristol Virginia is currently utilizing Fiscal Year 2018-2019 5307 funding for capital expenditures. Section 5307 funding lapses if not used within a specific time period. If we do not obligate all of our FY18-19 funding before September of this year, we lose the ability to use that money in the future. In order to ensure that the FY19-20 5307 funding allocated to Bristol Virginia is kept within our urbanized area, staff recommends that we also revise the previously agreed upon funding split for FY19-20 to give District Three the larger portion, or 69%. This will enable District Three to address immediate capital needs, and the City of Bristol Virginia will still maintain a sufficient amount of funding from the FY19-20 apportionment.



A POLICY FOR THE NAMING OF CITY OWNED PROPERTIES, FACILITIES, STREETS, AND STRUCTURES

City of Bristol, Virginia

I. INTRODUCTION:

In an effort to formalize a cohesive naming policy and make that policy more understandable, the City of Bristol has established a series of guidelines and an application to assist the general public, City employees, and local government members.

II. PURPOSE:

This Policy establishes a process and criteria for the consideration of requests by City of Bristol resident(s), business owner(s) or property owner(s) for the naming or renaming of City facilities.

III. POLICY:

The City of Bristol has a comprehensive program to safeguard City owned properties, facilities, and structures while satisfying the economic, recreation, and transportation needs of the community. It is important that suitable names be chosen for City Owned properties or facilities. School facilities will not be governed by this policy. The following guidelines shall serve as policy on this matter.

- 1. Requests to name or rename City owned properties, facilities, and structures shall be made in writing to the Department of Community Development and Planning, whereupon a Naming Request Application shall be transferred to the individual, organization, and/or corporation.
- 2. The person(s) who submitted the request shall provide background information into the rationale behind the request, including biographical information (if to be named after a person). Any letters from appropriate organizations and individuals, which provide evidence of substantial local support for the proposal, shall be submitted at that time.
- 3. All suggestions for the naming of City owned properties, facilities, streets & structures shall be submitted to the Director of the Department of Community Development and Planning (or their designee) for cursory review and distribution. Furthermore, the Director of Community Development and Planning shall forward all applications to the Director of the Department responsible for management/operation of that particular area, for initial acceptance or rejection, with a recommendation being transmitted to the City Council for approval.
- 4. As a general policy, City owned properties, facilities, streets, and structures shall be named in accordance with geographical, cultural, historical, or ecological features indigenous to the site or to the immediate vicinity of the site. Facilities may be named for an individual or corporation under the following conditions:

- General Criteria. Names of persons, groups, or organizations having a longstanding affiliation with the City of not less than thirty (30) or more years of significant community service, involvement, or contributions beyond the ordinary interest level for naming official City buildings and not less than twenty (20) years for the naming of other City properties provided said applicant shall have:
 - a. Enhanced the quality of life and well-being of City residents;
 - b. Contributed to the preservation of the City's history or culture;
 - c. Made exemplary or meritorious contributions to the City or its residents; or
 - d. Contributed to the acquisition, development, or conveyance of land, buildings, structures, or other amenities to the City or community.
- Deceased Persons. To be considered for a naming opportunity, the individual must have been deceased for at least three (3) years. Such individuals may include:
 - a. Historic persons.
 - b. National and/or local heroes. Those who have given outstanding service to mankind or who have worked over and above any ordinary interest level. A resident of Bristol who has attained local, state, or national recognition for parks and recreation work or work in the areas of public safety or public health, as appropriate to the facility, would be highly acceptable.
- Living Persons. Facilities may be named after living persons only after a study has been completed relative to the individual's background and qualifications pursuant to the criteria set forth above.
- *Groups and Organizations*. Facilities may be named after groups or organizations pursuant to the criteria set forth above.
- 5. Recreational facilities or designated areas within a park (i.e., trails, bridges, etc.) may be named for a corporation, organization, or an individual(s), living or deceased, who:
 - Has made a significant contribution to the protection and/or enrichment of a natural, cultural, educational, or horticultural resources of the City of Bristol, or
 - Has substantially contributed to the advancement of commensurate types of recreational opportunities within the City of Bristol, or
 - Has made a significant contribution to the betterment of a specific park, consistent with currently accepted best management practices and standards for the individual property in question.
 - Facilities may be named after living persons only after a study has been completed relative to the individual's background and qualifications pursuant to the criteria set forth above.
- 6. In support of this policy, nominations for naming of City owned properties, facilities, streets & structures shall be evaluated on the basis of the above criteria and upon appropriate documentation.
- 7. All costs associated with the naming, including the cost of any recording necessary and the cost of signage shall be paid by the person(s), organization, and/or corporation submitting the request. This cost may be waived by the City Council.
- 8. As a general policy, a named facility will retain that name as long as it exists. However, if a name is designated for a facility associated with a specific activity and that activity is subsequently changed, the name may be applied to a similarly used facility, if possible, and if not, to another facility
- 9. Bristol City Council shall have the right to make decisions that support the best interests of the City of Bristol, and shall either approve or reject the recommendation.

AN ORDINANCE TO ADD SECTION 86-207 TO CHAPTER 86, ARTICLE V, DIVISION 3 OF THE CITY CODE PERTAINING TO CAMERA SPEED MONITORING AND ENFORCEMENT IN HIGHWAY WORK ZONES AND SCHOOL CROSSING ZONES

CHAPTER AMENDED: 86 - TRAFFIC AND VEHICLES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRISTOL, VIRGINIA:

That Section 86-207 is hereby added to the Code of the City of Bristol, Virginia, and ordained to read as follows:

For purposes of this section,

"Highway work zone" has the same meaning ascribed to it in Code of Virginia, § 46.2-878.1.

"Photo speed monitoring device" means equipment that uses radar or LIDAR-based speed detection and produces one or more photographs, microphotographs, videotapes, or other recorded images of vehicles.

"School crossing zone" has the same meaning ascribed to it in Code of Virginia, § 46.2-873.

- (a) The Bristol Virginia Police Department may install and operate photo speed monitoring devices, within the boundaries of City of Bristol VA, in school crossing zones for the purposes of recording violations of Code of Virginia, § 46.2-873 and in highway work zones for the purposes of recording violations of Code of Virginia, § 46.2-878.1.
- (b) The operator of a vehicle shall be liable for a monetary civil penalty imposed pursuant to this section if such vehicle is found, as evidenced by information obtained from a photo speed monitoring device, to be traveling at speeds of at least 11 miles per hour above the posted school crossing zone or highway work zone speed limit within such school crossing zone or highway work zone, while such zone is active. Such civil penalties shall be \$100.00. Any prosecution under this section shall be instituted and conducted in the same manner as prosecution for traffic infractions.

Civil penalties collected under this section resulting from a summons issued by the Bristol Virginia Police Department shall be paid to City of Bristol.

- (c) If a photo speed monitoring device is used, proof of a violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1 shall be evidenced by information obtained from such device. A certificate, or a facsimile thereof, sworn to or affirmed by a law enforcement officer employed by the City authorized to impose penalties pursuant to this section, based upon inspection of photographs, microphotographs, videotapes, or other recorded images produced by a photo speed monitoring device, shall be prima facie evidence of the facts contained therein. Any photographs, microphotographs, videotapes, or other recorded images evidencing such a violation shall be available for inspection in any proceeding to adjudicate the liability for such violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1.
- (d) In the prosecution for a violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1 in which a summons was issued by mail, prima facie evidence that the vehicle described in the summons issued pursuant to this section was operated in violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1, together with proof that the defendant was at the time of such violation the owner, lessee, or renter of the vehicle, shall constitute in evidence a rebuttable presumption that such owner, lessee, or renter of the vehicle was the person who committed the violation. Such presumption shall be rebutted if the owner, lessee, or renter of the vehicle (i) files an affidavit by regular mail with the clerk of the general district court for the City that he was not the operator of the vehicle at the time of the alleged violation and provides the name and address of the person who was operating the vehicle at the time of the alleged violation or (ii) testifies in open court, under oath that he was not the operator of the vehicle at the time of the alleged violation and provides the name and address of the person who was operating the vehicle at the time of the alleged violation. Such presumption shall also be rebutted if a certified copy of a police report, showing that the vehicle had been reported to the police as stolen prior to the time of the alleged violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1, is presented, prior to the return date established on the summons issued pursuant to this section, to the general district court for the City adjudicating the alleged violation.
- (e) Imposition of a civil penalty pursuant to this section by mailing a summons shall not be deemed a conviction as an operator and shall not be made a part of the operating record of the person upon whom such liability is imposed, nor shall it be used for insurance purposes in the provision of motor vehicle insurance coverage. However, if a law enforcement officer employed by the City uses a photo speed monitoring device to record a violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1 and personally issues a summons at the time of the violation, the conviction that results shall be made a part of such driver's driving record and used for insurance purposes in the provision of motor

vehicle insurance coverage.

- A summons for a violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1 issued by mail pursuant to this section may be executed pursuant to Code of Virginia, § 19.2-76.2. Notwithstanding the provisions of Code of Virginia, § 19.2-76, a summons issued by mail pursuant to this section may be executed by mailing by first class mail a copy thereof to the address of the owner, lessee, or renter of the vehicle. In the case of a vehicle owner, the copy shall be mailed to the address contained in the records of or accessible to the department of motor vehicles. In the case of a vehicle lessee or renter, the copy shall be mailed to the address contained in the records of the lessee or renter. Every such mailing shall include, in addition to the summons, a notice of (i) the summoned person's ability to rebut the presumption that he was the operator of the vehicle at the time of the alleged violation through the filing of an affidavit as provided above and (ii) instructions for filing such affidavit, including the address to which the affidavit is to be sent. If the summoned person fails to appear on the date of return set out in the summons mailed pursuant to this section, the summons shall be executed in the manner set out in Code of Virginia, § 19.2-76.3. No proceedings for contempt or arrest of a person summoned by mailing shall be instituted for failure to appear on the return date of the summons. If the summons is issued to an owner, lessee, or renter of a vehicle with a registration outside the commonwealth and such person fails to appear on the date of return set out in the summons mailed pursuant to this section, the summons will be eligible for all legal collections activities. Any summons executed pursuant to and for a violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1 issued pursuant to this section shall provide to the person summoned at least 30 days following the mailing of the summons to inspect information collected by a photo speed monitoring device in connection with the violation. If the Bristol Virginia Police Department does not execute a summons for a violation of Code of Virginia, §§ 46.2-873 or 46.2-878.1 issued pursuant to this section within 30 days following the date of the violation, all information collected pertaining to the suspected violation shall be purged within 60 days following the date of the violation.
- (g) A private vendor may enter into an agreement with the Bristol Virginia Police Department to be compensated for providing a photo speed monitoring device and all related support services, including consulting, operations and administration. However, only a law enforcement officer may swear to or affirm the certificate required by this section. Any such agreement for compensation shall be based on the value of the goods and services provided, not on the number of violations paid or monetary penalties imposed. Any private entity contracting with a law enforcement agency pursuant to this section may enter into an agreement with the department of motor vehicles, in accordance with the provisions of subdivision B 31 of Code of Virginia, § 46.2-208, to obtain vehicle owner information regarding the registered owners of vehicles that committed a violation of Code of Virginia, §§ 46.2-873 or

46.2-878.1. Any such information provided to such private vendor shall be protected in a database.

(h) Information collected by a photo speed monitoring device operated pursuant to this section shall be limited exclusively to that information that is necessary for the enforcement of school crossing zone and highway work zone speeding violations. Information provided to the operator of photo speed monitoring device shall be protected in a database and used only for enforcement against individuals who violate this section or Code of Virginia, §§ 46.2-873 or 46.2-878.1. Notwithstanding any other provision of law, all photographs, microphotographs, videotapes, or other personal information collected by a photo speed monitoring device shall be used exclusively for enforcing school crossing zone and highway work zone speed limits and shall not be (i) open to the public; (ii) sold or used for sales, solicitation, or marketing purposes; (iii) disclosed to any other entity except as may be necessary for the enforcement of school crossing zone and highway work zone speed limits or to a vehicle owner or operator as part of a challenge to the violation; or (iv) be used in a court in a pending action or proceeding unless the action or proceeding relates to a violation of this section or Code of Virginia, §§ 46.2-873 or 46.2-878.1, or such information is requested upon order from a court of competent jurisdiction. Information collected under this section pertaining to a specific violation shall be purged and not retained later than 60 days after the collection of any civil penalties. The Bristol Virginia Police Department shall annually certify compliance with this section and make all records pertaining to such system available for inspection and audit by the commissioner of highways or the commissioner of the department of motor vehicles or his designee. Any person who discloses personal information in violation of the provisions of this subsection shall be subject to a civil penalty of \$1,000.00 per disclosure. Any unauthorized use or disclosure of such personal information shall be grounds for termination of the agreement between the department of motor vehicles and the private entity.

Conspicuous signs shall be placed within 1,000 feet of any school crossing zone or highway work zone at which a photo speed monitoring device is used, indicating the use of the device. There shall be a rebuttable presumption that such sign was in place at the time of the commission of the speed limit violation.

1. Approval of a Special Use Permit 02-2022, Multi-family Residential in a B-3 District, Randolph Street

Jay Detrick, Director of Community Development and Planning, gave the staff report. Mr. Detrick stated that Michael Bare has submitted an application for a special use permit to allow multi-family residential in a B-3 General Business District zoning district for property owned by Terry Moore and Patricia Henson. Bristol City Code Section 50-32 lists the permitted uses for this zoning district and multifamily is only allowed with a special use permit. Density and yard requirements for a permit allowing multifamily in a B-3 would be in accordance with the R-3 requirements. This is not a rezoning request. The special use permit allows for a specific use to occur without changing the zoning district. The site is property located between Randolph Street, Winterberry Drive, and Monroe Street. The property consists of 12 vacant lots and one lot with a single-family dwelling. The proposed project is to construct 30 to 35 townhouse units on the property, depending on engineering and utility capacity. The Planning Commission recommended the request for a joint public hearing with the City Council at its September 19, 2022 meeting. The joint public hearing was held at the regular meeting of the City Council on October 11. The Planning Commission recommended the special use permit for approval at its October 17, 2022 meeting by a 5-0 vote. Following the evaluation of the application, staff finds the proposed use would not negatively impact the surrounding area since multi-family is a less intense use than many of the by right uses in a B-3 District. The proposal also addresses a demonstrated need in Bristol for additional housing. Staff, therefore, recommends that the special use permit be granted.

2. Approval of First Amendment to Agreement for Purchase and Sale of Real Property.

Brandon Horne, a resident of Bristol, Virginia, addressed Council. Mr. Horne coaches the Bristol Virginia Junior Bearcats and they use the soccer fields on Bonham Road to practice. This property is a valuable asset to the children and he asked that Council find options for fields for the children if this property is sold.

Jackie Nophlin, a resident of Bristol, Virginia, addressed Council. Ms. Nophlin said that she lives in the vicinity of this land on Bonham Road and wants to know what is being considered for development on the property in question.

City Manager Eads gave the staff report. Mr. Eads stated that in 2018, Bristol, Virginia, and KBM Commercial Properties, LLC entered into an agreement for the purchase and sale of real property located at the corner of Old Airport Road and Bonham Road. This property, commonly known as the White Site, contains approximately 10.56 acres of land. This amendment contains

certain restrictions and amendments to the Agreement to allow for the sale of the property. Mr. Eads also reminded Council that approval of this will require a 4-1, supermajority, vote by Council.

Councilman Osborne moved for approval of the First Amendment to the Agreement for purchase; seconded by Hartley.

1. Approval of a Release Deed and Termination of Right of First Refusal for Real Property Owned by Bristol Brewery, LLC, located at 41 Piedmont Avenue.

Randall Eads, City Manager, gave the staff report. Mr. Eads stated that on August 21, 2014, Bristol Brewery, LLC entered into a performance agreement with the City and the Industrial Development Authority (IDA) for property located at 41 Piedmont Avenue. The performance agreement included a Note and lien on the Deed of Trust. Multiple performance expectations were included in the agreement, such as capital investments, employment requirements, job reports and audits, and certain sales tax requirements. One such requirement was that Bristol Brewery, LLC, would operate their business at the location for a period not less than ten years. Also, the agreement stipulated that Bristol Brewery, LLC would give the City and IDA first right of refusal to purchase the property if it was to be sold within ten years of the agreement. Bristol Brewery, LLC has met all of the obligations in the agreement except for operating the business at the location for ten years. In 2019, the City filed a Certificate of Partial Satisfaction for release of the Note after Bristol Brewery, LLC met all of the financial obligations of the agreement. The Deed of Trust, however, remained in force. Bristol Brewery, LLC, wishes to sell its property at 41 Piedmont and is asking for a release of the lien on the Deed of Trust and for termination of right of first refusal. An interested party wishes to purchase the property and operate a restaurant at the location.

Councilman Osborne moved for approval of a Release Deed and Termination of Right of First Refusal for Bristol Brewery, LLC; seconded by Nave.

Councilmember Osborne thanked Ken Monyak for what he did with his brewery as it was a fantastic business.

2. Approval to Allow SCS Field Services to Bid ITB# SW-23-010 Sidewall Odor Mitigation System that is currently out for Bid.

Randall Eads gave the staff report. Mr. Eads stated that on November 7, 2022, the City issued an ITB for the Sidewall Odor Mitigation System that is required by the Expert Panel Report to mitigate odors associated with the landfill. The City held a pre-bid conference on November 15, 2022, and no potential bidders attended the pre-bid conference.

Virginia Code § 2.2-4373 states "No person who, for compensation, prepares an invitation to bid or request for proposal for or on behalf of a public body shall (i) submit a bid or proposal for that procurement or any portion thereof or (ii) disclose to any bidder or offeror information concerning the procurement that is not available to the public. However, a public body may permit such person to submit a bid or proposal for that procurement or any portion thereof if the public body determines that the exclusion of the person would limit the number of potential qualified bidders or offerors in a manner contrary to the best interests of the public body." SCS Engineering prepared the ITB for the Sidewall Odor Mitigation System. Based on the lack of interest in bidding on the project, SCS Engineering has suggested SCS Field Services could bid on the project. However, pursuant to the above-mentioned code section, SCS Field Services is prohibited from bidding on the project unless the City Council "determines that the exclusion of the person would limit the number of potential qualified bidders or offerors in a manner contrary to the best interests of the public body."

On Friday, November 18, 2022, the City did receive a phone call from a potential bidder but they could not guarantee a bid would be submitted.

Councilman Osborne moved to approve SCS Field Services to submit a bid on

ITB #SW-23-010; seconded by Hartley.

Mr. Pollard said BCM was already given \$50,000 for work on the annex and that Council decided the payments to BCM had been satisfied.

Ed Harlow, a resident of Bristol, Virginia, addressed Council. Mr. Harlow said that Council made a commitment to BCM and we should fulfill that commitment.

Randall Eads gave the staff report. Mr. Eads said that in 2011, the former council agreed to appropriate \$500,000 to BCM over a five-year period. Due to budgetary constraints in 2017, the Council decided against appropriating the last \$100,000.

Councilman Hartley moved to appropriate \$100,000 to The Birthplace of Country Music; seconded by Nave.

Councilmember Hartley said this happened when he was on Council. Hartley said there is a need for these funds and we should honor our commitment to BCM.

Councilmember Nave said we should fulfill our commitment to BCM.

Councilmember Osborne said we should keep our word to BCM and give them the \$100,000. Mayor Farnum said he loves the museum, but we don't know how much the landfill remediation will cost and there are many other needs in the city.

1. Approval of Award to SCS Field Services for Sidewall Odor Mitigation System (Bid #SW-23-010)

City Manager Eads gave the staff report. Mr. Eads stated we have recently spent 3.1 million dollars on unbudgeted landfill projects. We have approximately 54.7 million dollars in projects at the landfill left to complete.

The Invitation for Bids for the Sidewall Odor Mitigation System Project (Bid Number: SW-23-010) was issued on November 7, 2022, with proposals due at 2:00 pm on November, 22 2022. Due to limited interest in the project, the bid due date was extended to 2:00 p.m. on November 29, 2022. One response was received. The bid was considered responsive; therefore, it is recommended by the City Manager, Procurement Specialist, and Public Works Director that bid SW-23-010 be awarded to SCS Field Services. The potential total bid received from SCS Field Services for completion of Phase 1 and Phase 2 of the project is \$11,998,080.00.

Moved by Neal Osborne to approve the award to SCS Field Services for the Sidewall Odor Mitigation System (Bid #SW-23-010); seconded by Bill Hartley.

Councilmember Wingard said we are in unchartered territory, and putting a mandate on something that hasn't been done before doesn't make sense. We need some sort of assurance that this project will work. We need to figure out how we will move forward without bankrupting the city.

City Manager Eads said no one is certain if this sidewall project will work. Mr. Eads stated there is only one clear solution to solve the landfill problem and that is to mine the entire landfill and take the waste somewhere else. The cost associated with this clean closure project would be around \$250,000,000.

Councilmember Wingard said that government has zero business being in the business of making money. This landfill will be the financial nail that buries the city, but, regardless, we have to move forward and keep working to fix the problems at the landfill.

Councilmember Hartley said we are under an extremely tight timeline to complete this sidewall project, and this is a huge amount of money.

City Manager Eads said \$8.7 million of the cost for the project will come from ARPA funds, \$2 million will come from the Virginia Department of Environmental Quality, and the remainder will come from the city's beginning balance.

Councilmember Nave said we need to continue to ask for and work for funding with our state and federal officials.

Councilmember Wingard said the reason we had to close the landfill was because of the odor and lawsuits related to that odor. If the odor stops and we can eliminate the gases escaping from the landfill, the City Council should consider reopening the landfill because of the high costs. The landfill will never be right until it is full and capped, Wingard said.

Councilmember Hartley said he would never vote to reopen the landfill. The landfill has lost \$150 million dollars and we should never consider reopening it.

2. Approval of Award to SCS Field Services for Landfill Gas Operation, Monitoring, and Maintenance (Bid #SW-23-011)

City Manager Eads gave the staff report. The City initially went out to bid for maintenance services in 2019 and we entered into a bid with SCS in January of 2020. The Invitation for Bids for the Bristol Integrated Solid Waste Management Facility Landfill Gas Operation, Monitoring, and Maintenance Services (Bid Number: SW-23-011) was issued on November 17, 2022, with proposals due at 2:00 p.m. on December 1, 2022. One response was received. The bid was considered responsive; therefore, it is recommended by the City Manager, Procurement Specialist, and Public Works Director that bid SW-23-011 be awarded to SCS Field Services. The cost for Task 1 is \$66,000 per month. The cost for Tasks 2 and 3 is dependent upon a time and materials basis according to SCS Field Services' current fee schedule, which was included in their response. City Manager Eads said this will be a three-year contract and the scope of services had increased from the 2019 bid.
