They are currently requesting a grant in the amount up to \$20,000 to help offset the cost of installation. The Public Art grant is a matching grant that can provide up to \$20,000 for acquisition and installation of public art on private property. Prior to overall grant approval the applicant will provide pricing for the installation cost of the sculpture and according to CRA policies the applicant can receive up to a 50% matching grant. The applicant is requesting the Public Art Advisory Committee to recommend grant application and designate the proposed artwork as Public Art.
