### **GENERAL NOTICE TO THE PUBLIC**

The City Council adopted new rules relating to the conduct of the public meetings, proceedings, and business in the City of South Gate on July 12, 2022, (Resolution 2022-38-CC) and go into effect on August 1, 2022. Resolution #2022-38-CC is available at the City Clerk's Office.

### **MEETING SCHEDULE**

Regular meetings of the City Council are held on the second and fourth Tuesday of each month, closed session meetings will commence at 5:30 p.m. unless posted otherwise on its agenda. The regular City Council meetings will commence at 6:30 p.m. Agendas are available at the following locations: City Clerk Office, Public Notice Boards at City Hall, and on the City's web page at <https://www.cityofsouthgate.org>

The Public can sign up to receive automatic notices of postings of agendas for the City Council or any other Commission or Board of the City of South Gate. Visit the City webpage and click on the Agenda & Minutes icon. That will take you the page where an individual can enter their email in the "Email Updates" box to register.

### **PUBLIC COMMENT/PARTICIPATION**

Any person may request to address a legislative body during a public meeting. The Presiding Officer will call upon those present in the Council Chambers first. After all speakers in the Chambers have spoken, the Presiding Officer will call upon those participating via zoom or teleconference.

Speakers are limited to three (3) minutes on any item listed on the agenda, including public hearings. Under Comments from the Audience portion, speakers are also limited to a single three (3) minutes time limit. Comments from the Audience is initially limited to 45 minutes at each meeting. Any speaker still wishing to speak, that did not speak, will have an addition Comments from the Audience opportunity after the last business item is finished. The Presiding Officer may extend the time limit as long as there is no objection from the City Council as a body.

To ensure that the public is able to participate, the City provides the opportunity to submit their comments in person, virtually, email, phone call, mail and any other method which may become

available. Methods of participation may be subject to change during other such times when a State of Emergency, Health Order or State Executive Order limits in-person participation.

## **CURFEW**

In absence of a motion duly adopted by majority vote of the City Council, the Presiding Officer may adjourn the City Council meetings at 10:30 p.m. The Presiding Officer may ask the City Council if any agenda items listed should be continued or dealt with during the meeting. For those items to be continued, the City Council can direct the item be placed on the next City Council agenda or the current meeting may be adjourned to a time certain at which time the meeting shall be reconvened as an Adjourned Regular Meeting of the City Council and action upon the published agenda continued.

## **STAFF REPORTS**

As a general rule, staff reports, or other written documentation are prepared/organized with respect to each item of business listed on the agenda. Meeting agendas and staff reports are available at least 72-hours prior to the scheduled regular City Council meeting and a minimum of 24-hours prior to a Special City Council meeting. There are times when the City Council receives written material, revised material after the posting of agendas, these materials are become a public record and will be available for public view within 72-hours after the meeting in which they were received. Those materials and any other public document can be inspected in the City Clerk's Office located at 8650 California Avenue, South Gate.

*Honoring one of South Gate's own for accomplishments  
made in the field of Sociology  
and achieving the status of a Tenured Professor.*

**WHEREAS,** Sylvia Zamora is a lifelong resident of South Gate, serving as South Gate High School Student Body President (1999-2000), Junior Class President (1998-1999), student member of South Gate's Youth Commission (1999-2000), and Executive Board Member of the student organization MEChA (1998-2000); and

**WHEREAS,** Sylvia Zamora received her Ph.D. in Sociology from the University of California, Los Angeles (2014), a BA in Sociology and Latin American Studies from Smith College in Northampton, MA (2004), and served as a Provost's Career Enhancement Postdoctoral Scholar at the University of Chicago (2014-2016); and

**WHEREAS,** As a Professor of Sociology, Sylvia Zamora's research, guided by questions concerning how Latino immigration is changing social, political, and racial dynamics in the U.S., has made an impact in the Social Science discipline and her award-winning research is published in numerous prestigious academic journals; and

**WHEREAS,** Sylvia Zamora's scholarly book, *Racial Baggage: Mexican Immigrants and Race Across the Border* (Stanford University Press) examines how the immigration experience can transform immigrant understanding of race and inequality in home and host societies; and

**WHEREAS,** Nationally, only 26.5% of university faculty are tenured, meaning they are appointed indefinitely, and Latinos make up less than 5 percent of tenured faculty at universities in the United States making this an almost unattainable accomplishment; and

**WHEREAS,** Sylvia Zamora, having overcome numerous obstacles, should be recognized for recently achieving the status of Tenure and promotion in rank to Associate Professor at Loyola Marymount University (LMU) and for being awarded an LMU Ascending Scholar Award recognizing excellence and promise in faculty scholarship.

**NOW, THEREFORE,** on this 23<sup>rd</sup> day of May 2023, I, Maria del Pilar Avalos, Mayor of the City of South Gate, on behalf of the City Council and citizens of South Gate, do hereby recognize Dr. Sylvia Zamora for becoming a Tenured Associate Professor and for all her extraordinary contributions in shedding light to topics that closely impact our community. ## PROCLAMATION

### *Declaring* **National Post-Traumatic Stress Disorder Awareness Month June 2023**

- WHEREAS,** in May, we are reminded not only of the human mind's immense strength but also some of its limitations. It is a reminder that we are not machines and that it is completely normal to feel the emotions that we do. And unlike machines, we have the strength to get better on our own by helping each other; and
- WHEREAS,** there are two types of trauma and they range in the severity of the causes and triggers: the 'Big T' is any type of trauma that has occurred due to a life-threatening situation like wars, natural disasters, physical assault, etc., while the 'Small t' is caused due to a disturbing event that is not life-threatening like divorce, abrupt relocation, financial woes, etc.; and
- WHEREAS,** many people recover from PTSD after a few days, weeks, or months. Yet, for others, the recovery road might mean one year or more. This mental disorder is highly treatable, but due to the lack of knowledge around it as well as the stigma attached to seeking mental help, many choose to ignore the problem and suffer through it; and
- WHEREAS,** June is National PTSD Awareness Month. Its goal is to raise awareness about said mental illness for people to recover from it by seeking better and effective treatments like group therapy, counseling, and antidepressants; and
- WHEREAS,** the more talk there is about PTSD, the more people will become aware of it, and the more people will seek treatment for it. The road to recovery may look different from one person to another, but it is always there.

NOW, THEREFORE, be it proclaimed this 23<sup>rd</sup> day of May 2023, that I, Maria del Pilar Avalos, Mayor of the City of South Gate, do hereby proclaim June 2023 as National Post-Traumatic Stress Disorder Awareness Month and encourage citizens to learn about the symptoms and available treatments for those suffering with mental health challenges.




