**a. Broward Health Coral Springs – *Spirit of Caring***

Broward Health, Coral Springs would like to install an art sculpture near the entrance of the hospital’s emergency room. Titled *Spirit of Caring*, the piece demonstrates coming together as a community in a loving and compassionate way after the MSD tragedy and the Covid-19 pandemic. As a hospital supports its community, the community also supports its hospital with a theme “we are stronger together.” The piece will have two adults, one male and one female, with a child. The three figures holding up a colorful heart. The figures will be made of stainless steel and the heart will have colorful reflective glass. The piece will stand 12’ from ground to base and the three figures will form 3 points on the ground. Artist Stephen Canneto, has previously worked with the City of Coral Springs and designed the *Color Play* sculpture, located on Atlantic Boulevard. The target installation date is February 2022.

**PAC Minutes: Monday, September 20, 2021**

Ms. Kalisher, Ms. Kirkpatrick, Ms. Mallis, and Mr. Cifuentes all expressed they liked the design but would adjust the female hands on the child. They felt the male was lifting the child and the female was holding the child down.

Ms. Kirkpatrick expressed the bent female leg looked broken. All agreed that the leg should be straightened with the foot touching the ground.

Mr. Cifuentes suggested adding a bench and relocating a few parking spots from the island to create more room for reflection when the public is visiting the artwork.

City staff will work with Broward Health and the artist on modifications. Updates will be presented to the Public Art Committee as the project moves forward.

## CALL TO ARTISTS: SCULPTURE ON SAMPLE/ARTWALK

NAME: Sculpture on Sample/ArtWalk  
LOCATION: Sample Road between University Drive and Coral Springs Drive;  
NW 31<sup>st</sup> Court ArtWalk  
DUE DATE OF APPLICATION: December 31, 2021  
TOTAL PURCHASE BUDGET: up to \$49,000.00 for final purchase of artwork(s); each artist selected for loan will receive \$2,000.00. up to 9 artworks may be selected for temporary display  
DESCRIPTION: The City of Coral Springs Public Art Program will temporary display up to nine (9) artworks. The City will then purchase one or more sculptures for the continued expansion of public art within the City. The purchased sculpture(s) will be chosen from the existing temporary display sculptures chosen for the Sculpture on Sample/ArtWalk Program.

### Public Art Project Description

Sample Road and the NW 31<sup>st</sup> Court ArtWalk are outdoor venues to display public art for the City of Coral Springs. Along the 1 mile of roadway on Sample Road and the 1600 linear-foot ArtWalk on NW 31<sup>st</sup> Court, up to nine (9) sculptures will be temporarily displayed. A flyer along with social media, press releases and local press will be completed on the artworks and artists selected. The city holds festivals throughout the year on the ArtWalk; the sculptures involved with this program will be featured during these events. Of the artworks on display, the Public Art Committee, with input from residents of the city, will select one or more pieces of artwork to purchase for their permanent public art collection.

### Already Existing Artwork

Artists should submit pre-existing artworks for purchase. The City of Coral Springs will only rent and purchase unique works of art, unless the series itself has a conceptual basis.

### Qualities of Artwork

The artwork must be capable of “holding its own” in the temporary location and the artwork’s final location at the NW 31<sup>st</sup> Court ArtWalk, Sample Road. or its final location as identified on the Public Art Master Plan. Artwork must be able to fit on a 4-foot by 5-foot pad. Vertical sculptures will be preferred.

The artwork should be durable and require minimal ongoing maintenance. South Florida has a sub-tropical climate and is hot and humid with an intense sun and seasonal heavy rain. Problems with rust and fading should be avoided. Resistance to high-speed winds is important. The artwork must be self-supporting on an open landscape or hardscape. If the artwork is selected for permanent display, final purchase approval is contingent upon inspection for wind load and compliance with the Florida Building Code, ensuring long-term conservation of the artwork.

### **Themes of the Artwork**

The City of Coral Springs theme for this year's "Sculpture on Sample/ArtWalk" program is to promote the City's mission statement: "The nation's premier community in which to live, work and raise a family" along with its branding, "Everything Under the Sun".

### **Artist Requirements Once Selected**

- Transportation and off-truck loading of the artwork to the specific site in Coral Springs;
- Installation of the artwork;
- Artist must supply power if required for installation;
- Recommendations of the design of the permanent site;
- One public lecture in Coral Springs.

### **Tentative Art Project Schedule**

- Call to Artists Posted: November 17, 2021
- Artist Applications Due: December 31, 2021
- Artist Selection: January 24, 2022
- Commission Approval: February 2022
- Artwork Installation: February 2022 through March 2022
- Program Officially Begins: March 2022
- Selection of Permanent Artwork: May 2022
- Removal of Temporary Artwork: July 2022

### **Artwork Purchase Budget**

The Public Art Committee will be selecting a minimum of one artwork for permanent display. The purchase budget established for the permanent artwork(s) is up to \$49,000.00. The price will include all taxes and fees. Within the fee, the artist will make recommendations to the city regarding the design of the permanent site and present a public lecture regarding public art. The public art program will pay \$2,000 to each artist selected for temporary display through the program; \$1,000 when the artwork is placed within its location and \$1,000 when the artwork is removed after the program is complete.

### **Artist Eligibility**

The project is open to any professional visual artist with experience implementing their ideas and work in the public realm. *Artist or Professional Artist* means a practitioner in the visual arts, generally recognized by critics and peers as a professional of serious intent and ability. Indications of a person's status as a professional artist include, but are not limited to, income realized through the sole commission of artwork, frequent or consistent art exhibitions, placement of artwork in public institutions or museums, receipt of honors and awards, and training in the arts.

Artists are NOT eligible who are immediate family or business partners of members of the Public Art Committee, the selection committee or program staff.

### **Application Process**

The application process is managed by the City of Coral Springs. The Coral Springs Public Art Committee serves as the selection committee, along with one business person and one general resident (or combination of the two) chosen by the Committee. Final purchase approval is contingent upon inspection for wind load and current Florida Building Code, ensuring long-term conservation of the artwork.

### **Selection Criteria**

The Public Art Selection Committee shall consider the following issues:

1. Appropriateness of the artwork to the goals of the program;
2. Appropriateness of the artwork to the site and site environmental conditions;
3. Experience and other qualifications of the artist;
4. Quality of the artwork;
5. Location of artist; and
6. Maintenance requirements.

### **Application Requirements**

The information and documentation below must be submitted through CAFÉ.

1. Cover Letter: A cover letter listing experience with similar or related projects (PDF)
2. Resume. A current professional resume (PDF)
3. Images of proposed Artwork
4. Purchase price of the artwork (total purchase budget for permanent artwork is \$49,000)

### **Other Selection Issues**

1. Florida “Sunshine Laws”: All meetings of the Committee are open to the public, are publicly advertised and are documented through written minutes.
2. Conflict of Interests: Artists with immediate family or business partners on the selection committee are not eligible to apply. A selection committee member may choose to withdraw from discussion and voting for any apparent conflict of interest.
3. Public Art Committee Contacts: Artist applicants should not contact Public Art Committee members between the release of the Call to Artists and the completion of the selection process. Contact the City of Coral Springs for all questions and information.

### **Coral Springs, Florida**

Coral Springs, Florida is located in Broward County in Southeast Florida, approximately 20 miles northwest of Ft. Lauderdale and 10 miles southwest of Boca Raton. Coral Springs was founded in 1963 as “the city in the country.” Today, approximately 134,000 people live in the 24 square miles of suburban Broward County. Coral Springs is 30 minutes away from Fort Lauderdale-Hollywood International Airport (FLL) and less than 60 minutes from Miami (MIA) and West Palm Beach (PBI) airports. To visit the Sample Road or ArtWalk site, use the Sample Road exit on any of the three major highways: I-95, Florida’s Turnpike or Sawgrass Expressway (State Highway 869). Travel east from the Sawgrass and west from I-95 and Florida’s Turnpike.

The locations for the artwork to be placed on Sample Rd. are between University Drive and Coral Springs Drive on the north and south sides. The ArtWalk is located along the north side of NW 31<sup>st</sup> Court, two blocks south of Sample Road between University Drive and Coral Hills Drive.

### Coral Springs Public Art Program

The program was established in 2003 and is funded by public art impact fees from private developers. No tax dollars are used to purchase public art or fund this program.
