#### 2. Museum Update (Jill Brown)

Museum Director Jill Brown provided an in-depth report on museum activities and the new fiscal year.

<u>Grants and Sponsorships</u>: The Cultural Division of Broward County will be confirming a \$81,500 for the second year of a grant. The State of Florida confirmed a \$91,000. An award of \$25,000 from the Cornelia T. Bailey Foundation. There are other grants currently in the works.

<u>Sustainability Efforts</u>: Moving more to electronic recordkeeping versus paper; upcycling more with materials; a new clay trap system eliminates drain clogs and allows the museum to dry out and re-wedge the captured slip into reusable clay for the youth and teen programs.

Upcoming programming and events were reported. Attendance in classes has increased. Ms. Brown supports the free admission to the museum. She has noticed generous donations with this practice. Many more updates were provided.

A board member suggested scheduling a museum strategic planning session.
