Guest Speaker: Katie Kober, Cerebral Palsy | FCC Adjunct Professor and Owner of Amber Hill Therapies

Cerebral Palsy: Overview and treatment

Questions & Answers:

Member Kamnikar:

For clients/patients with CP do you talk about what they personally want/their expectations vs. what parents want?

Ms. Kober:

Seeks patients' input–such as goals in school by coordinating with school. There are some students that do not want the accommodations. Therapist works to pre-plan preparation, e.g., contact student's PE teacher to find out about upcoming lessons to work on before lesson day.

Member Haughwout:

What is number of FCPS staff that are lift trained? How many staff would you (Ms. Kober) would like to see trained within a school.

Ms. Kober:

Depends on the school. Depending on how big the need is perhaps 4 or 5 for someone completely dependent. One person should not lift more than 50 lbs.

Member Barnett: What percentage of FCPS student population has CP? IEP? 504?

Mr. Keller: Data is not readily available at the meeting.

May 13, 2025 Frederick News Post: Schools can purchase digital hall pass system starting in July

Section, Afie Mirshah-Nayar...added that Individualized Education Plan (IEP) teams are using the database at the pilot schools to see when students have been out of class.

Mirshah-Nayar said that, for student achievement purposes, "it gives us another data point to share with students and their families."

Could you please help me to understand the outcome of what data is being tracked for special education students?

(Background - *Starting in July, individual schools in Frederick County Public Schools can choose to implement a digital hall pass system–Four schools in the district have been piloting the system: Tuscarora High, Frederick High, Monocacy Middle and Waverley Elementary...

The pilot was also paid for through school-based budgets...

Smartpass can support a digital hall pass system for up to 63 schools in the district.)

Question: RISE-Eligibility?

Mr. Keller: Currently 3-5. For students who have autism, like executive functioning concerns, but also not working on social communications piece, perspective taking.
