- d. Street Trees Policy

 - o This has not been a huge issue of late due to reduced traffic during pandemic.
 - o Parking enforcement has sent some correspondence around to move forward with putting language in the code specifying no parking in bike lanes.

 - o Hurley Ave and future projects plan to incorporate reticuline grates for catch basins in bike lanes.
 - o Should the City standardize reticuline grates for storm drains in bike lanes?
