Call To Order

Trustee Reeves called meeting to order at 5:30 pm

Roll Call

Election of Chairperson for 2022.

Trustee Reeves call for the election of a chairperson.

Motion Pautz/Goodden to nominate Trustee Reeves as chairperson, unanimously carried

Motion Pautz/Stockwell to approve minutes of January 27, 2022 meeting, unanimously carried

New Business

Summary of the Downtown Development Committee origins, past efforts and comments on current committee potential (Roger Walsh)

Motion Reeves/Goodden to open the Floor to Roger Walsh, unanimously carried Roger Walsh spoke to the group about the history and background of the Downtown Development Committee

Walsh suggested that a title search be performed on the two parcels of land in Kiwanis Park.

Discussed the implementation of the downtown strategic plan in 2018.

The Village Center Overlay District was described. Four people including President Winchowky were assigned the role to gather information, complete an architectural survey and gather information from the 2035 Comp Plan, which were put into the Downtown Strategic Plan.

Walsh stated that COVID then hampered a lot of the efforts of the group and kind of put stuff on pause. Ron Bittner formed a subcommittee for implementing some of the work started by the Committee. The bump outs were under the Downtown Strategic Plan's pedestrian friendly goal.

Walsh urged the Committee not to reinvent the wheel there was plenty of work left in the Downtown Strategic plan to complete. Walsh suggested building off the past. Walsh suggested getting in contact with WDEC and to understand the benefits of the Connect Communities program. Walsh suggested doing a restart of the work that had been done previously, rather than come up with a new agenda for the group. Walsh said that there was visioning exercise that FOTH put together previously and that should be reviewed. The WI DOT commented on that downtown plan. The DOT asked for detailed plan drawings. Walsh stated that the Committee should find out where the Villages is at with developing detail drawings for the downtown.

Walsh stated this is a recommendation committee, you make recommendations to the Village Board.

Walsh suggested partnering with the school district.

Walsh stated that the Village has a branding plan.

Walsh stated to seek community involvement.

Walsh question what happened to the downtown webpage. Walsh suggested to keep implementing the downtown plan.

Walsh stated that outreach to the community was critical to get people to commit. Walsh stated to keep working on small visible low-cost projects. Façade improvement and WDEC orientation, identify the building stock in the community.

Update on downtown planters

Group discussed recent developments. Planters are an initiative that the committee can adopt and take forward. The committee adopted the planters, flowers, water and the location of those planters. It was suggested to move the planters a couple of feet away from the telephone poles and to put some planters by the music store. It was suggested to put some media out on the initiatives that the DDC is working on, including the banners, planters and wayfinding signs. We need seasonable seasonal banners, not just in summer. Set up a process to determine who will pay for the banners.

Update on Wayfinding Signage

Group discussed wayfinding signs. The \$400,000 price tag was a surprise. Administrator suggested breaking it into four years - \$100,000 per year. Wamser suggested to start with the gateway signs in the community. Look at the trestles north and south for placement of the big incoming signs to the community; on the northside find a different location – the location that we have currently is not very visible. Put a gateway sign by Heaven City. Move the signs forward closer to the right of way. Wamser suggested to execute the entrance signs first and then work your way into the community a little each year. Put \$150,000 in the first year to do the gateway signs – phase 1 of the signage program. The two big signs 8 foot by 6 foot 13 inches at the north and south side and then on the east and west side do a 6 x 9 sign a smaller sign in year one.

Suggestion to create a beautification committee to focus on planting flowers and not only downtown but in front of other signs in the community.

Administrator Fred will get back to the group as to where the village is at with the \$82,000 R&M 60% design plans for downtown. Fred believed these were put on hold as the downtown development committee was not active and the DOT was not considering highway 83 in their six-year plans. Fred to find out if these funds for the design plans budgeted. Fred to let the group know where we are with the project and whether money was put away for this project.

Does the Village need a plan for design so that they can go to the DOT and get DOT approval? Stated that Robert Elkin is our DOT contact:
