Call to Order

Commission Chair Kenneth Johnson called the meeting to order at 6:00 PM.

Roll Call

Commissioners present were Johnson, Douglas, Sperstad, and McAdams. Commissioner Kettner was an excused absence. Mukwonago Police personnel also present were Chief Kevin Schmidt.

Announcement of Closed Session Pursuant to Wisc Stats § 19.85 (1)(c) read by Chair Ken Johnson.

Approval of minutes from the May 13th, 2021 meeting.

Motion by Sperstad, second by McAdams approved unanimously.

Motion by Sperstad, second by McAdams to reconvene into open session at 7:35PM.

A. Discuss Interviews of Police Chief Candidates, Selection of Successful Candidate.

Assistant Chief Dan Streit and Lt. Chris DeMotto from the Mukwonago Police Department had applied for the open Police Chief position and were interviewed for the position. Both Lt DeMotto and Assistant Chief Streit were asked to return to the meeting where Chair Ken Johnson thanked them both for their interest in the Chief's position and service to the village. Chair Johnson then informed the two that by unanimous vote of the present Commissioners, Dan Streit was selected to be the next Chief of Police for the Village of Mukwonago effective June 11th, 2021.

B. Establish Salary for Police Chief.

Per Village resolution, the Police Commission is to set the wage for the new Chief for the first two years. The Commission decision on salary for Chief Streit is starting pay of \$95,000. At 6 months that salary would increase to \$96,500 and at the one year anniversary date of June 11, 2022 Chief Streit would be elevated to \$99,000 annually. Thereafter Chief Streit would be evaluated by the Village and compensated accordingly.

We use the minimum force and authority necessary to accomplish a proper police purpose. We demonstrate self-discipline, even when no one is listening or watching.





Message from the Chief

I am pleased to share with you the Village of Mukwonago Police Department's 2020 Annual Report.

Your Village Police Department consists of 15 officers, which includes command staff, 7 dispatchers/clerks, and currently 10 Police Reserve Officers who assist the department at special events.

The department provides police service to the Village of Mukwonago 24-hours-per-day, 7 days-per-week. Our dispatch center provided dispatch service to the Village of Mukwonago PD, the Town of Mukwonago PD and boat patrol, the Town of Eagle Boat Patrol, and the Mukwonago Fire Department.

Even in these incredibly trying times, every member of the department remains committed to our core values (Competence, Courage, Integrity, Leadership, Respect, and Restraint). We strive to achieve our vision of a community where all citizens can live safely and without fear. We are dedicated to our mission of providing professional law enforcement to all by being responsive to the community needs, be proactive in crime prevention and community involvement, be impartial in our contacts with everyone and work together with all members of the community.

I would like to thank the Village Board, Police Commission and all other employees of the Village of Mukwonago. Together we can and have made a difference. On behalf of all the members of the department, thank you for providing us with the resources to complete our mission.

In 2020, we said goodbye to three employees. Officer Robert Melo retired in March after 32 years with the department. Bob started as a Reserve Officer for 2 years and was then promoted to Police Officer. During his career, he was involved with SWAT, hostage negotiations, liaison with Waukesha County Metro Drug Unit and director of the Police Reserve Program. Dispatcher Jennifer Dorschner resigned in August after 8 years with the department. Her computer skills and work ethic were very much appreciated. Dispatcher Kathleen Haines also resigned after 14 months with the department. We have missed each of them.

Traffic Safety Grants

Once again the Southern Waukesha Traffic Task Force, consisting of the Village of Mukwonago, City of Muskego and City of New Berlin Police Departments, were targeted by the Wisconsin Department of Transportation - Bureau of Traffic Safety (BOTS) for three traffic safety grants. The three grants targeted impaired driving, aggressive driving, speeding and lack of seatbelt usage. The goal is to help reduce traffic crashes and injuries from those accidents. We also participated in all three national mobilizations; Click It or Ticket, Drive Sober Get Pulled Over and Drive Sober Winter.



Over the last 3 years, there were 4,503 crashes reported, with 13 fatalities and 1,318 injuries in our three jurisdictions. Three of the fatalities were alcohol related and 179 total crashes were flagged as alcohol related. 293 crashes had a seat belt flag and 616 crashes had the speed flag. There were also 65 crashes that had the drug flag. Our task force will provide extra patrol within our communities for primary enforcement of seatbelt violations, speeding violations, OWI and reckless driving violations. These deployments will focus on the areas that are most impacted by crashes and traffic related issues. Higher visibility and adding the additional officers to primarily focus on traffic related issues will help to work towards lowering the amount of traffic crashes and enforcing seat belt violations. Our task force will monitor Community Maps and crash data to focus deployments in the areas that are believed to have the greatest amount of issues.

Civilian Response to an Active Shooter Event





Law enforcement officers and agencies are frequently requested by schools, businesses and community members for direction and presentations on what they should do if confronted with an active shooter event. The Civilian Response to Active Shooter Events (CRASE) course, designed and built on the Avoid, Deny, Defend (ADD) strategy developed by ALERRT in 2004, provides strategies, guidance, and a proven plan for surviving an active shooter event. Topics include the history and prevalence of active shooter events, civilian response options, medical issues, and considerations for conducting drills.

In 2020, the Village of Mukwonago Police Department presented Avoid, Deny, Defend to 71 students, before having to cut off classes due to COVID 19. Even in the pandemic our school resource officers and patrol officers attended at least 16 hours of training, presented by ALERRT.






Police Chaplain Program

Having received formal training in police and fire chaplaincy and Critical Incident Stress Management, our chaplains are available whenever a crisis arises.


They are also proactively involved in the police and fire departments by:

Suburban Critical Incident Team (S.C.I.T)

The Suburban Critical Incident Team has 31 tactical officers, 2 K9 handlers, 3 command positions, and 15 negotiators. These officers are from nine area police departments; City of Brookfield, City of New Berlin, City of Muskego, City of Delafield, Village of Mukwonago, Village of Pewaukee, Village of Chenequa, Village of Hartland and the Village of Elm Grove. Officer Melo, until his retirement in March, was assigned to the team as a hostage negotiator and Officer Cory Kirkpatrick is assigned as a tactical operator.

To join SCIT; officers must demonstrate skill, knowledge and competence at their department to be selected by their supervisor to apply for the team. There are three main phases to the application process; physical fitness, marksmanship and an oral interview. Failure in any one area results in removal from the process however officers may be able to participate in the application process the following year. If an officer is selected to join the team, they attend a basic swat training class and will continue to training with the team until approved by command to be operational, which can take a year.

2020 was the busiest tactical deployment year since SCIT was founded. There were 18 deployments with only 1 dignitary protection detail. Activity was diverse to include two High Intensity Drug Trafficking Area (HIDTA) high risk warrants, 2 significant area searches for suspects who shot two police officers, five total riot deployments and an active shooter response to Mayfair Mall.

Because of COVID-19 and civil distrubance deployments, 3 full team training dates and several specialty training dates had to be cancelled. The team focused on their physical fitness programs for its members.

On June 2, SCIT took possession of the new Rescue Vehicle.





Prescription Drop Box / Drug Take Back Events

The medication disposal unit installed in the lobby in 2014 was again put to good use throughout 2020. **In 2020 we accepted approximately 386 pounds of medications in the drop box!** The red drop box can be accessed in the lobby 24-hours-per-day.

We also participated in Drug Take Back event at Walgreens and took in 80 pounds of prescription pills. Because of COVID-19, Pro Health decided not to do the program. Between the drop box and the event, we collected approximately 466 pounds of prescription pills to be properly disposed of.



Neighborhood Watch Program

The Neighborhood Watch program is one of the department's oldest community programs. The program helps join police officers with the residents they serve. The goal is to work together to deter crime and help keep Mukwonago safe. We rely on members of the community to help notice strangers or activity that is out of place.

Talks / Tours / Events

The Mukwonago Police Department provides numerous educational talks and tours to the public. Several times a year Girl and Boy Scout troops meet at the department to earn a merit badge in crime prevention. The tour takes the children to our dispatch center where they can see where 911 calls go to and see how emergency vehicles are dispatched to calls. They also see the officer work areas, prisoner process area, armory, squad cars and the officer's equipment. We also educate them and provide handouts containing anti-drug messages, crime prevention, stranger danger and other general safety practices.

Due to the COVID-19 pandemic talks, tours and events were all placed on hold in 2020.





2020 NIBRS Data

National Incident Based Reporting System

In 2015, the Department began working to upgrade crime reporting from the Uniform Crime Report (UCR) to the National Incident Based Reporting System (NIBRS). We obtained a grant to fund updating the department's ProPhoenix Records Management System and developed tools to assist officers with NIBRS compliant data entry.

UCR and NIBRS are both regulated by the FBI and both use the same general concepts. NIBRS goes into greater detail than UCR and has 46 Group A offenses while UCR only has 8 Part I offenses. UCR does not differentiate between completed and attempted crimes while NIBRS does. Also, UCR tends to only report the most serious offense reported when multiple crimes are reported in the same period of time, location, and person/group of people. The great thing about NIBRS is the data can be submitted electronically in the form of ASCII text files, needing no manual input. UCR data is written documents that have to be hand entered into a computer system for analysis. Within a few years, the FBI will require all law enforcement agencies to report NIBRS data instead of UCR data.

NIBRS only reports the <u>highest</u> level arrest for any incident where UCR report all arrests. For example, if you look at our Drug Equipment number, we had 26 incidents but only 2 arrests. That is because in most of those incidents, we also arrested the person for Possession of a Controlled Substance so only that arrest is reported, not the Narcotic Equipment arrest.




