OBJECTOR'S PETITION

Objector, Ernest C. Knight, states that he resides at 24013 W. Commercial Street, in the Village of Plainfield, Zip Code 60544, Will County, State of Illinois, that he is a duly qualified and registered legal voter of the Village of Plainfield, Will County, State of Illinois, the district in which the candidate is to be voted upon, and that his interest in filing the following objections is that of a citizen desirous of seeing that the election laws governing the filing of nomination papers for the office of Village President of the Village of Plainfield, Will County, State of Illinois, are properly complied with, and that only qualified candidates appear on the ballot for said office as candidates for the Consolidated General Election to be held on April 6, 2021 ("Election").

Therefore, Objector makes the following objections to the Nomination Papers of John F. Argoudelis as a candidate for the office of Village President of the Village of Plainfield, Will County, State of Illinois, to be voted upon at the Election.

- 1. Pursuant to state law, Nomination Papers for the election to the office of Village President of the Village of Plainfield, Will County, State of Illinois, to be voted for at the Election, must contain the signatures of not fewer than 115 (and not more than 184) duly qualified, registered and legal voters of said District collected in the manner proscribed by law. In addition, said Nomination Papers must truthfully allege the qualifications of the candidate, be gathered and presented in the manner provided for in the Illinois Election Code, 10 ILCS 5/1-1, et seq. ("Illinois Election Code"), and otherwise executed in the form provided by law.
- 2. Section 10-4 of the Illinois Election Code requires that all headings of petitions sheets be uniform and sets forth the information that must be contained next to the qualified voter's signature. 10 ILCS 5/10-4. Sections 10-4 provided in relevant part as follows:

Such petitions shall consist of sheets of uniform size and each sheet shall contain, above the space for signature, an appropriate heading, giving the information as to

name of candidate or candidates in whose behalf such petition is signed; the office; the party; place of residence; and such other information or wording as required to make same valid, and the heading of each sheet shall be the same. Such petition shall be signed by the qualified voters in their own proper persons only, and opposite the signature of each signer his residence address shall be written or printed. The residence address required to be written or printed opposite each qualified primary elector's name shall include the street address or rural route number of the signer, as the case may be, as well as the signer's county, and city, village or town, and state.

10 ILCS 5/10-4.

- 3. When Candidate presented his Petition Sheets to purported qualified voters to sign, on information and belief, the headings on the Petition Sheets were not complete and the Office of Village President for the Village of Plainfield was missing from at least Petition Sheets 2, 3, 4, 5, 8, 10, 12, 16 and 17.
- 4. Subsequently, upon information and belief, Candidate, after purported qualified voters placed their signatures and addresses on the Candidate's petition sheets, using his hand and pen, altered said Petition Sheets by adding the words "President/Mayor" under Village of Plainfield in the Office box in the heading on at least Petition Sheets 2, 3, 4, 5, 8, 10, 12, 16 and 17.
- On information and belief, Candidate made the alterations identified above after the Candidate had signed the Circulator's Affidavit as the circulator and/or after the Notary Public signed and notarized the Petition Sheets.
- 6. Candidate's actions and alterations violates the mandatory requirements of the Illinois Election Code and calls into question the integrity of Candidate's Nomination Papers, including all Petition Sheets and Statement of Candidacy signed by Candidate, as the circulator in the Circulator's Affidavit with a Notary Public attestation constitute false swearings and total disregard of the mandatory provisions of the Illinois Election Code by the Candidate, in that Candidate, altered said Nomination Papers in the manner described above and that the information contained in the Circulator's Affidavit is false as the purported qualified voters and the notarization of the Candidate's signatures on the Petition Sheets 1 through 17 and the Candidate's Statement of Candidacy are false requiring this Electoral Board to strike all of Candidate's Petition Sheets and Statement of Candidacy.
- 7. The Electoral Board, as an administrative agency, can take judicial notice that the Candidate has previously been found, by *clear and convincing evidence*, to have violated Rule 1.2(g) of the Illinois Rules of Professional Conduct by failing to advise a Court of facts the Candidate knew were not true, after learning those facts were not true; violated Rule 3.3(a)(6) of the Illinois Rules of Professional Conduct, which provides a lawyer shall not counsel or assist a client in conduct the lawyer knows t be illegal or fraudulent; violated Rule 3.3(a)(1) of the Illinois Rules of Professional Conduct in making statements of material fact to a Court when Candidate knew or reasonably should have known were false; and violated Rule 1.2(d) of the Illinois Rules

of Professional Conduct in counseling a client to engage or assisting a client in conduct that the lawyer knows is criminal or fraudulent. See *In re: John F. Argoudelis, 2012 PR 1060*.

- 8. Further, the Candidate voted at the November 3, 2020 Presidential election from his former address of 15214 Hamlin, Plainfield, Illinois, an address he did not reside in and was not his residence on November 3, 2020, and on information and belief, not his residence for many months prior to November 3, 2020.
- 9. That the Candidate's registration was changed from the Hamlin address to his current address sometime after the November 3, 2020 election when he voted from an address that was not his residence.
- 10. That the Candidate, upon information and belief, was not a resident in the Village of Plainfield, nor a legal registered voter for one (1) year prior to the election and the signing and filing of the Statement of Candidacy.
- 11. The Nomination Papers contain less than 115 validly collected signatures of qualified and duly registered voters of the Village of Plainfield, State of Illinois, signed by such voters in their own proper person with proper addresses, far below the number required under Illinois law, as set forth by the objections recorded in the Appendix-Recapitulation attached hereto and incorporated herein and the objections made therein are part of this Objector's Petition. Because of the above-listed irregularities and insufficiencies, Candidate's Nomination Papers are invalid in their entirety.

WHEREFORE, Objector, Ernest C. Knight, prays that the nomination papers of John F. Argoudelis, as candidate for election to the office of Village President of the Village of Plainfield, Will County, State of Illinois, to be voted for at the Consolidated Election to be held on April 6, 2021, be declared to be insufficient and not in compliance with the laws of the State of Illinois, and that his name be stricken and that this Electoral Board enter its decision declaring that the name of John F. Argoudelis as candidate for election to the office of Village President of the Village of Plainfield, Will County, State of Illinois, not be printed upon the official ballot for the Consolidated Election to be held on April 6, 2021.

CODE OF FAIR CAMPAIGN PRACTICES

There are basic principles of decency, honesty, and fair play that every candidate for public office in the State of Illinois has a moral obligation to observe and uphold, in order that, after vigorously contested but fairly conducted campaigns, our citizens may exercise their constitutional right to a free and untrammeled choice and the will of the people may be fully and clearly expressed on the issues.

THEREFORE:

- I will conduct my campaign openly and publicly, and limit attacks on my opponent to legitimate challenges to his record.
- (2) I will not use or permit the use of character defamation, whispering campaigns, libel, slander, or scurrilous attacks on any candidate or his personal or family life.
- (3) I will not use or permit any appeal to negative prejudice based on race, sex, sexual orientation, religion or national origin.
- (4) I will not use campaign material of any sort that misrepresents, distorts, or otherwise falsifies the facts, nor will I use malicious or unfounded accusations that aim at creating or exploiting doubts, without justification, as to the personal integrity or patriotism of my opposition.
- (5) I will not undertake or condone any dishonest or unethical practice that tends to corrupt or undermine our American system of free elections or that hampers or prevents the full and free expression of the will of the voters.
- (6) I will defend and uphold the right of every qualified American voter to full and equal participation in the electoral process.
- (7) I will immediately and publicly repudiate methods and tactics that may come from others that I have pledged not to use or condone. I shall take firm action against any subordinate who violates any provision of this Code or the laws governing elections.
