- (4) Discussion or consultation with the city's attorneys regarding the city's position regarding contracts that are the subject of negotiations, in pending or contemplated litigation, or in settlement discussions conducted in order to avoid litigation (A.R.S. § 38-431.03(A)(4));
- (5) Discussion or consultation with designated representatives of the city to consider its position and instruct its representatives regarding negotiations with employee organizations (A.R.S. §38-431.03(A)(5));
- (6) Discussion, consultation or consideration for negotiations by the city or its designated representatives with members of a tribal council, or its designated representatives, of an Indian reservation located within or adjacent to the city (A.R.S. §38-431.03(A)(6);
- (7) Discussion or consultation with designated representatives of the city to consider its position and instruct its representatives regarding negotiations for the purchase, sale or lease of real property (A.R.S. §38-431.03(A) (7)).

Confidentiality

Arizona statute precludes any person receiving executive session information from disclosing that information except as allowed by law. A.R.S. §38-431.03(F). Each violation of this statute is subject to a civil penalty not to exceed \$500, plus court costs and attorneys' fees. This penalty is assessed against the person who violates this statute or who knowingly aids, agrees to aid or attempts to aid another person in violating this article. The city is precluded from expending any public monies to employ or retain legal counsel to provide legal services or representation to the public body or any of its officers in any legal action commenced for violation of the statute unless City Council takes a legal action at a properly noticed open meeting to approve of such expenditures prior to incurring any such obligation or indebtedness. A.R.S. §38-431.07(A)(B).

ADOPT RESOLUTION NO. 26 OF THE DISTRICT BOARD OF HASSAYAMPA COMMUNITY FACILITIES DISTRICT #2, YAVAPAI COUNTY, ARIZONA, FINALLY DETERMINING AND ADOPTING ESTIMATES OF PROPOSED EXPENDITURES FOR THE FISCAL YEAR 2022, AND DECLARING THAT THE SAME SHALL CONSTITUTE THE BUDGET FOR THE HASSAYAMPA COMMUNITY FACILITIES DISTRICT #2 FOR SAID FISCAL YEAR.

Recommended Action (separate motions): (1) MOVE to close the public hearing; and (2) MOVE to adopt Resolution No. 24 setting the FY20 Budget for Hassayampa Community Facilities District #2.

District Treasurer Mark Woodfill presented the final budget for the FY 2022 for the Hassayampa Community Facilities District #2. Mr. Woodfill commented that this district has about nine (9) assessments left and will continue until 2024 paying off the debt service on that bond and proceeded to present budget.

Councilman Goode asked who will be responsible to maintain the infrastructure once the bond has been paid off, what the necessity and creation was for this district, how it is retiring its bonds and how its infrastructure will be maintained once paid.

Mr. Woodfill explained that this the Hassayampa Facilities District was part of the Hassayampa development and was created to build the capital of the district to include the waster water reclamation facility. HFD District # 2 was created for the infrastructure within a separate subdivision of that district using special assessment bonds; each property pays interest and principle twice per year. The infrastructure that is being paid off is already part of city's water, wastewater and streets fund. A twenty-five (25) year bond was issued in 2000.

ITEM SUMMARY

The Fiscal Year 2023 budget consists of debt service on the special assessment bonds used to fund the district, and other miscellaneous expenditures.

Notice of this public hearing and consideration of the Fiscal Year 2023 Hassayampa Community Facilities District # 2 budget was published in the newspaper on June 26, 2022. After the public hearing is closed, it is recommended that the Hassayampa Community Facilities District Board adopt the resolution approving the District's budget for Fiscal Year 2023.

BACKGROUND

Hassayampa Community Facilities District #2 was created in 2000 to provide a source of funding for the development of water, wastewater and streets infrastructure at Forest Ridge Subdivision located within Hassayampa Village.

FINANCIAL IMPACT

This is the FY23 budget for the district.
