Purcellville Zoning Ordinance Rewrite

July 25, 2024

Why Update the Zoning Ordinance?

- Our Zoning Ordinance exists “to promote, in accordance with present and future needs, the health, safety, morals, order, convenience, prosperity, and general welfare¹” of our citizens
- Update the existing Zoning Ordinance to bring it into agreement with the approved 2030 Comprehensive Plan to better reflect the desired character of the Town
- Update the existing Zoning Ordinance to be in compliance with recent changes in the State Code

¹ A Standard State Zoning Enabling Act (SZEA), U.S. Department of Commerce, 1926

Who reviewed this draft zoning ordinance?

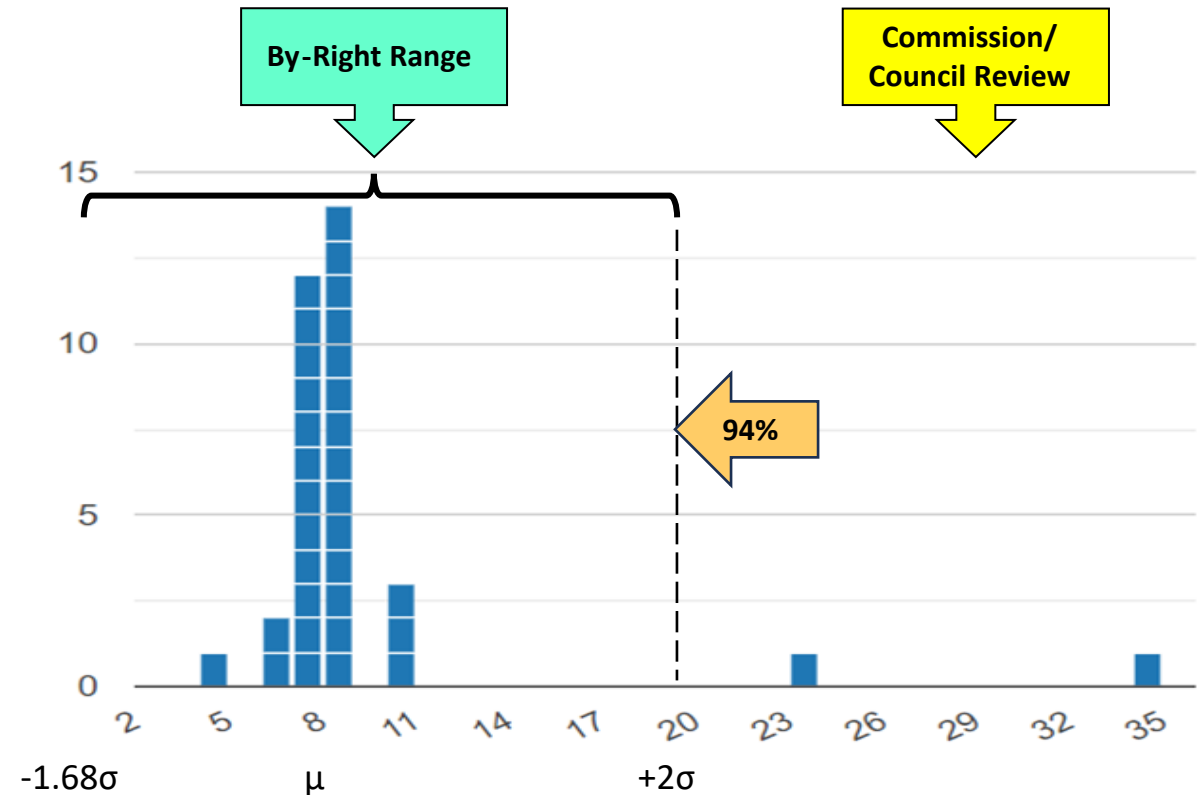

Major Changes

- By-right limits – Added data-informed maximums and minimums consistent with 90-95% of what actually exists in Town
- Overlay Districts – Added to address Comprehensive Plan focus areas
- Historic District – Added to sustain the Single-Family Detached Traditional areas of the Town
- Uses – Reduced types of use to Permitted and Special Use Permit, combined two similar commercial districts and made revisions to a few residential uses

By-right Limits

- Data analysis: Using County data for all Purcellville properties, we measured lot sizes, floor area ratios¹, impervious surface ratios², open space ratios³ and building heights.
- For each district, we established by-right “soft data envelopes” based on these characteristics that contained about 95% of all of the values.



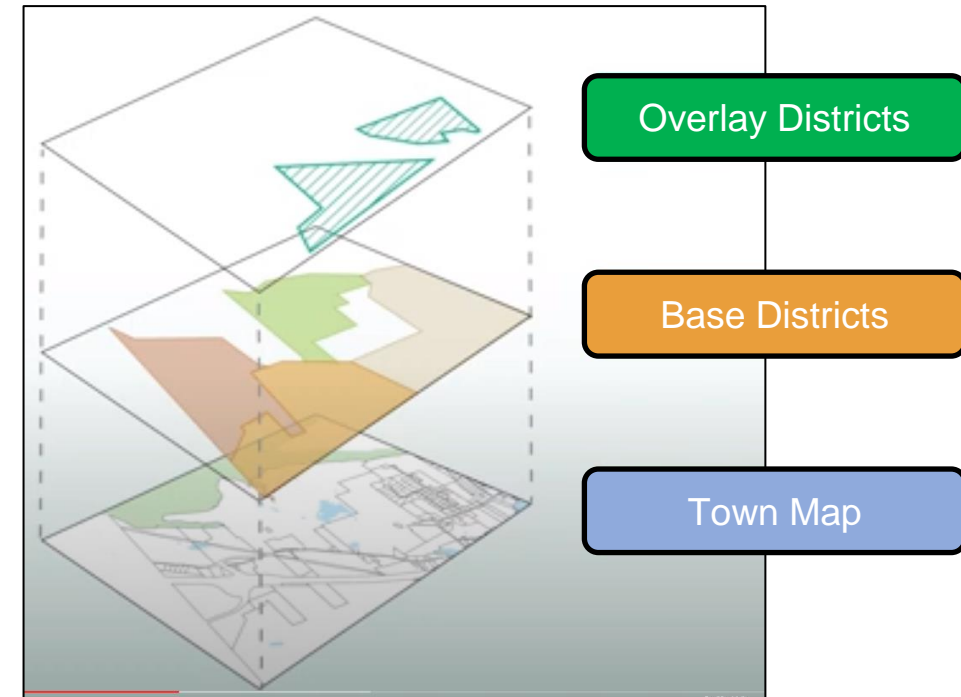
¹ Floor area ratio (FAR) is the ratio of a building's total (gross) floor area to the total area of a property.

² Impervious surface ratio (ISR) is the ratio of the total impervious surface area to the total area of a property, where impervious surfaces are mainly artificial structures such as roads, sidewalks, driveways and parking lots.

³ Open space ratio (OSR) is the ratio of the total undeveloped area to the total area of a property.

Overlay Districts

- Overlay districts are applied over one or more base zoning districts, establishing additional standards and criteria in addition to those of the underlying zoning districts.
- They promote the scale, mass, forms, architecture and design character that protect and shape land uses in existing development, new development, infill development and redevelopment.
- Existing overlays are the Floodplain Overlay District, the Architectural Control Overlay District and the Historic Corridor Overlay District

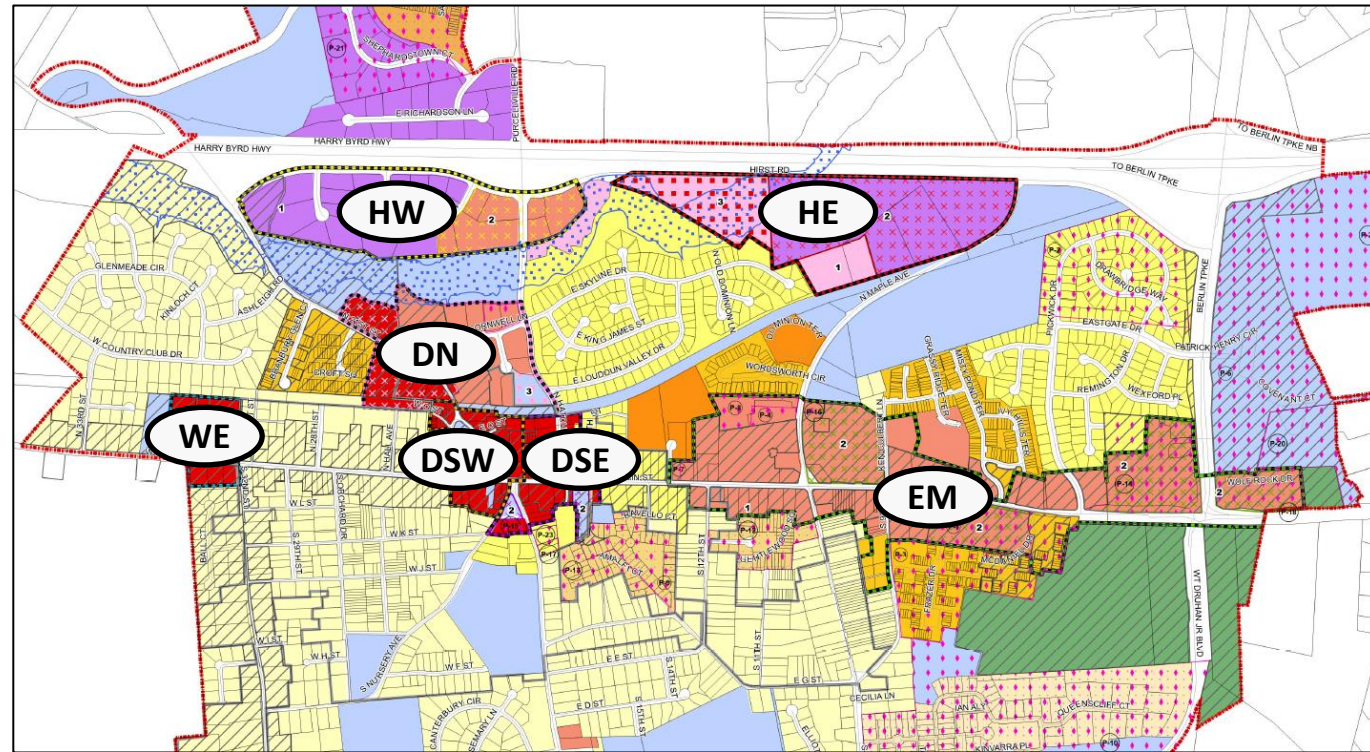


Overlay Districts Sample Figure

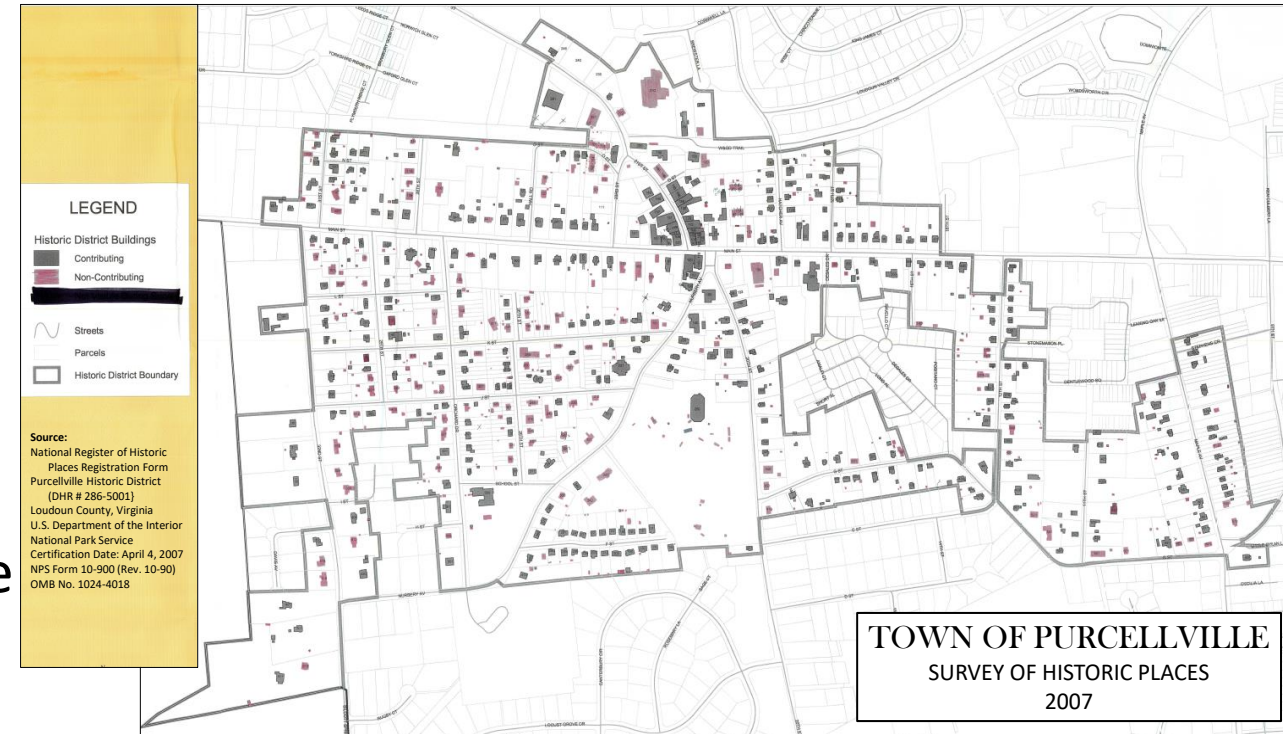
New overlay districts are based on the Focus Areas described in the Comprehensive Plan.

HPO - Historic Properties Overlay District

- Purcellville Historic District (DHR: 286-5001) was listed on the National Register of Historic Places in 2007. At that time it comprised 490 contributing buildings and eight contributing structures in the central business district and surrounding residential areas.
 - The HPO district fulfills the Comprehensive Plan's direction to sustain the Town's historic traditional residential core.
 - The goal of the HPO district is to reduce the risk of losing the Town's historic core by requiring that the proposed demolition of any principal historic structures[†] in the district go through a public review process.
- [†] Principal structure means the main building or other structure on a lot that is utilized for the property's principal use.



Uses Updated

- **Use Types** (i.e., permissibility of uses in districts) has been simplified to:
 - Permitted Uses (P)
 - Uses allowed by Special Use Permit (SUP)
 - Removed Special Exceptions (SE)
- **Uses** that have been modified:
 - Modified R3 by removing “duplex” designation; only 3 of 426 properties are listed as duplex in R3
 - Removed R3A; there are only three properties zoned R3A
 - Combined CM1-Local Service Industrial and M1-Limited Industrial into IB-Industrial Business
 - Removed PDH as a future land use but retained as a current use

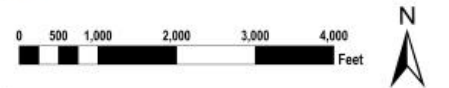
Proposed Official Zoning Map

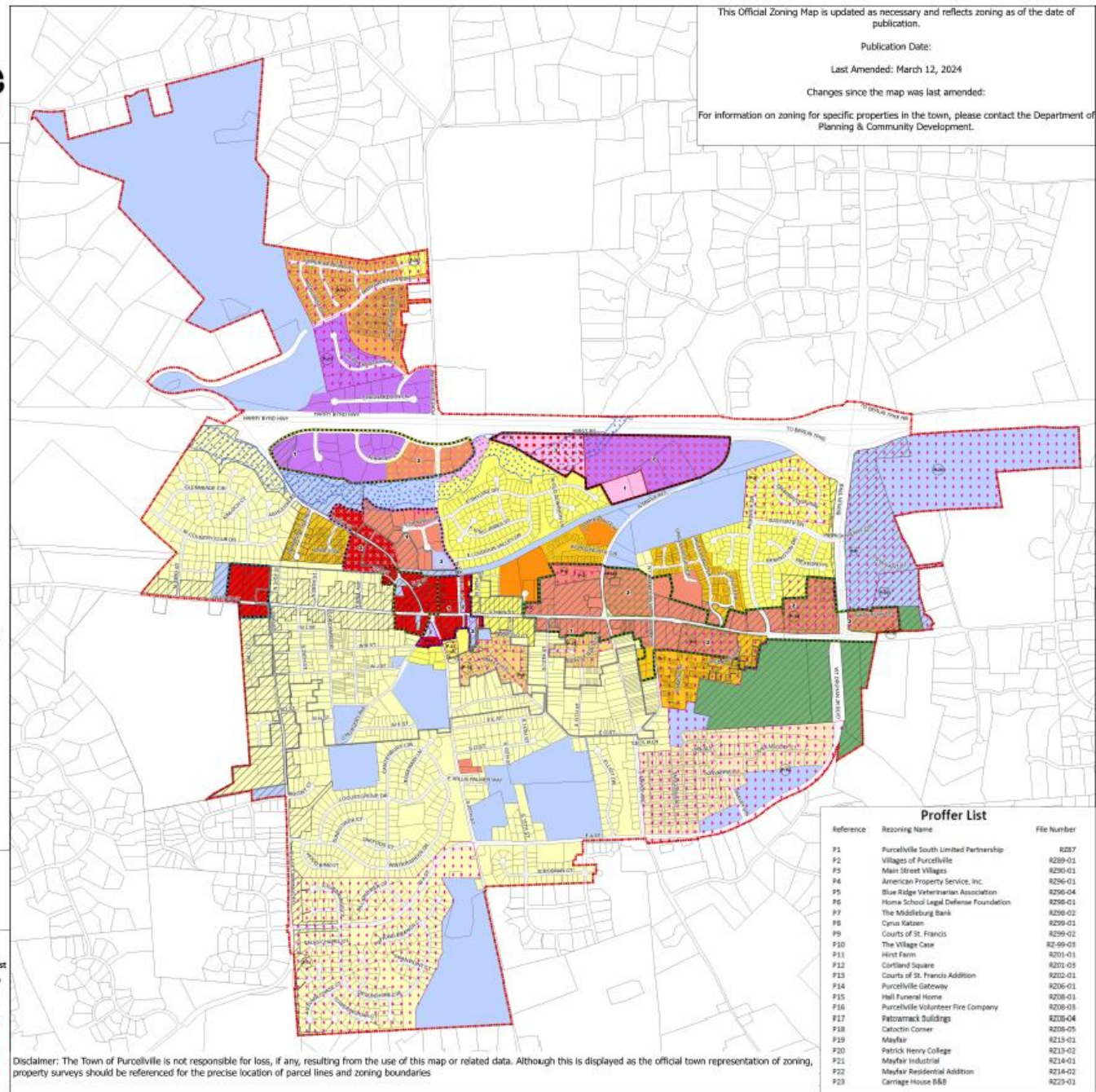

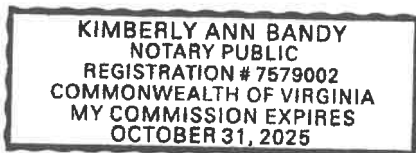

Dear Property Owner(s):

You are listed in the current real estate tax records of Loudoun County as the owner of a parcel or parcels of land within the Town of Purcellville subject to proposed amendments of the Town's Zoning Ordinance and Zoning Map. Pursuant to Code of Virginia 15.2-2204(B), this letter serves as official written notice on behalf of the Planning Commission of the scheduled **July 25th, 2024 6:30pm Public Hearing**. The hearing will be held at Town Hall, 221 S. Nursery Ave., Purcellville, VA 20132, in **Council Chambers**.

At this public hearing, all persons desiring to present their views concerning this matter will be heard. Persons requiring special accommodations should contact Kendall Wisniewski, Planning Operations Coordinator, at kwisniewski@purcellvilleva.gov, three days in advance of the meeting. In consideration of time and the number of citizens who may wish to be heard, your comments will be limited to three minutes. Please prepare accordingly.

The Planning Commission's proposed updates to the Zoning Ordinance seek to enact the vision of the 2030 Comprehensive Plan. The changes include updates to various standards and regulations that apply to residentially and commercially zoned properties. While some changes are minor in nature, the areas described below include significant changes or additions to the Zoning Ordinance:

- **Addition and Modification of Overlay Districts-** *See Zoning Map and Article 4*
 - A. Addition of Overlays pertaining to commercial areas including standards for building bulk and lot standards and regulations including:
 - Downtown North
 - Downtown Southeast
 - Downtown Southwest
 - East Main
 - Hirst East
 - Hirst West
 - West End
 - B. Addition of **Historic Properties Overlay** affecting processes for approval of demolition of residential structures
 - C. Modification of **Floodplain Overlay District** to include stricter standards and regulations

- **Removal of “dwelling, duplex” as a permitted use in the R-3 “Single-Family Detached Residential Medium-Density” base district, formerly “Duplex Residential” district.** *See Zoning Map and Articles 2 and 3*
- **Limited Base District rezonings affecting building and bulk standards in addition to use standards.** *See Zoning Map and Article 2*
- **Consolidation of CM-1 and M-1 industrial districts to IB, Industrial Business.** *See Zoning Map and Article 2*
- **Classification of all PDH districts as “Legacy” districts to prohibit the expansion of PDH districts.** *See Zoning Map and Article 2, Appendix A*



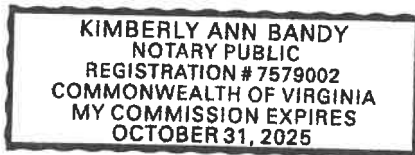

 - Downtown Southwest
 - East Main

 - Hirst West
 - West End
 - B. Addition of **Historic Properties Overlay** affecting processes for approval of demolition of residential structures
 - C. Modification of **Floodplain Overlay District** to include stricter standards and regulations

- **Removal of “dwelling, duplex” as a permitted use in the R-3 “Single-Family Detached Residential Medium-Density” base district, formerly “Duplex Residential” district.** *See Zoning Map and Articles 2 and 3*
- **Limited Base District rezonings affecting building and bulk standards in addition to use standards.** *See Zoning Map and Article 2*
- **Consolidation of CM-1 and M-1 industrial districts to IB, Industrial Business.** *See Zoning Map and Article 2*
- **Classification of all PDH districts as “Legacy” districts to prohibit the expansion of PDH districts.** *See Zoning Map and Article 2, Appendix A*
