With Chief Meienschein's approval The Salisbury Police Department is requesting to surplus patrol vehicle #1603, a 2016, Chevrolet Caprice (VIN: 6G3NS5U27GL224242) with 54,000 miles. The vehicle was involved in a single vehicle at fault departmental accident on 04/16/21, causing substantial front-end damage resulting in the vehicle being declared totaled by Local Government Insurance Trust.

The Salisbury Police Department retained Unit #1603 to be utilized for parts as Chevrolet Caprice replacements were becoming more and more difficult to obtain. We were able to reuse the engine and many other parts from the vehicle to maintain an aging fleet of other Caprices and realized a substantial savings in doing so. At this point the vehicle has been scavenged of all parts that we would need and is no longer of any use to the Salisbury Police Department. We are requesting to surplus the vehicle and dispose of it though approved City of Salisbury procurement processes.

SUBJECT: Surplus Vehicle- Unit #20


The below listed Salisbury Police Department vehicle have been identified as meeting the minimum requirements criteria used to determine if a vehicle should be removed from the fleet and be scheduled for surplus.

- 1. Age of vehicle
- 2. Mileage of vehicle
- 3. Condition of interior and or exterior of vehicle
- 4. Recent repair shop costs other than routine maintenance
- 5. Quoted needed repairs that are higher than the value of the vehicle making the vehicle no longer mechanically sound and unable to put back into service.

Vehicle # 20 is a 2006 Ford F250 with 130,659 miles and has been in our fleet for 19 years. The vehicle has several severe rust spots on the vehicle and the starter solenoid is making a whining noise at times. The transmission went out on the truck in June and we were given a quote of \$4,711.00 to rebuild the transmission from Reynolds Repair shop. We have replaced instrument panel cluster, battery and alternator during the past year and it has been determined that no more funds will be spent on this vehicle.







With the chief's approval, and the condition of the above listed vehicle, I request that this vehicle be considered by the City Council for surplus.


The City has accumulated several decommissioned vehicles and equipment due to scheduled replacements and uneconomical repairs.

To maintain our proactive approach and optimize cash flow for future replacements, we propose declaring these items as surplus. A list of the surplus assets is attached for your review. Items are deemed surplus due to age, condition, or lack of need.

Per the City Charter (Article XVI/SC16-8), with a favorable recommendation from the Director of Procurement, these assets may be sold or disposed of with Council approval.

Charter/Code language provided for convenience:

Surplus, obsolete or unused city property listed on the city's capital assets inventory shall be sold or otherwise disposed of only upon recommendation of the Director of Procurement and after approval of the Council. If saleable, such property shall be sold for the city's account by the Department of Procurement, subject to the applicable provisions of this Article as to competitive bidding; but if not saleable may be abandoned, destroyed or otherwise disposed of.

Subject: Budget Amendment for Union Negotiations - 2nd Reading

As you are aware, the City Council approved Resolution 3414 on June 16, 2025 which included three union side letters. As a result of the wage reopener negotiations with all three Collective Bargaining Agreements, there is an increase to wages that was not appropriated in the FY26 Budget.

The fiscal impact of these collective bargaining agreements for current year 2026 has affected the City per below:

- Initial FY 26 Budget provided for a 1 step salary increase in July 2025 and January 2026.
- Union negotiations resulted in an additional step in July 2025 as well as a pay scale change to the Fire Department scale. This change increased the step increments from 2% to 2.25%.
- Cost of additional step and pay scale change to the General Fund of \$1,187,953; Water/Sewer Fund of \$143,566; Storm Water Fund \$2,949; Parking Fund \$2,316.

Attached you will find an ordinance requesting the approval of a budget amendment for FY26 for the general fund, water/sewer fund, parking fund, and storm water fund in the amount of \$1,336,784.39 for additional salaries and the related fringe benefits.

Subject: Budget Amendment for Lawsuit Funds - 2nd Reading

In preparing the FY2026 Budget, \$2,000,000 was forecasted from lawsuit proceeds from the PFAS settlement. This revenue was included in the Water Sewer Fund. It has been determined that this revenue would be better accounted for in the Water Sewer Capital Project Fund.

There is an ordinance requesting to move the budgeted revenue of \$2,000,000 from the Water Sewer Fund into the Water Sewer Capital Project Fund. The PayGo projects of \$1,530,100 initially approved in the budget will also be moved to be paid for with Lawsuit Proceeds. With the movement of these lawsuit proceeds there will be a use of surplus to the water sewer fund of the difference of \$469,900 which will be used to balance the water sewer capital project fund and be assigned to the PFAS Filter Project.

AN ORDINANCE OF THE CITY OF SALISBURY AUTHORIZING A AMENDMENT TO TRANSFER PFAS **SETTLEMENT** PROCEEDS FROM THE WATER SEWER FUND TO THE WATER SEWER CAPITAL PROJECT FUND.

WHEREAS, the City of Salisbury has forecasted that Two Million Dollars (\$2,000,000) from the settlement of the PFAS lawsuit will be received by the City in its fiscal year 2026; and

WHEREAS, the City of Salisbury included this forecasted revenue in its FY2026 Water Sewer Budget; and

WHEREAS, the City of Salisbury included in the FY2026 Water Sewer Budget a total of \$1,530,100 for project expenditures necessary to fund Water Sewer Capital Projects; and

WHEREAS, the City of Salisbury has determined the forecasted revenue and project expenditures would be best accounted for in the Water Sewer Capital Project Fund; and

WHEREAS, this budget amendment will move the above referenced revenue and expenditures for capital projects from the FY2026 Water Sewer Fund into the Water Sewer Capital Projects Fund; and

WHEREAS, the appropriations necessary to execute this budget amendment as provided hereinabove must be made upon the recommendation of the Mayor and the approval of four-fifths of the Council of the City of Salisbury.

This memorandum informs you of the proposed amendments to Title 15 of the Salisbury City Code regarding the adoption and integration of the 2021 International Property Maintenance Code (IPMC).

The IPMC is designed to establish minimum standards for maintaining existing buildings and properties within the City. Its goal is to ensure that all properties are kept in a manner that guarantees our residents' safety, livability, and overall quality.

The IPMC serves as a vital tool for our municipal authorities, providing Code Enforcement with a clear and concise reference to regulations that align with existing standards already adopted by the City. By incorporating the 2021 edition of the IPMC, which is fully compatible with the I-Codes approved by the City on December 16, 2021 (Ordinance 2906), we will strengthen our ability to address property maintenance issues effectively.

These updates will enhance the health, safety, and welfare of our citizens by ensuring that the City's regulations remain current and comprehensive. Furthermore, the IPMC will support our Code Enforcement officers in efficiently addressing issues that may not be explicitly covered in the municipal code but fall within the standards set by the IPMC.

We recommend adopting these amendments to incorporate the 2021 IPMC into Title 15 of the Salisbury City Code. I appreciate your consideration of this matter.
