April 21, 2023, Meeting Minutes

Chair Jose Rodriguez (South County) called the Public Safety Committee (PSC) meeting to order at 1 p.m.

1. Approval of Meeting Minutes

7. Public Safety Allocations and Staffing Challenges for Law Enforcement Agencies in the Region¹

Criminal Justice Research Principal Research Analyst Dr. Octavio Rodriguez Ferreira presented an overview of present findings from the most recent Criminal Justice Publications about public safety expenditures and staffing in FY 2021-2022, and Chief Kaye, Coronado Police Department, led a panel discussion regarding law enforcement agencies' staffing challenges.

The panelist was asked specific questions regarding recruitment efforts in their perspective agencies, their major concerns in decreasing retention rates, and various other law enforcement concerns. The panelist for this discussion included Chief Ray Sweeney (La Mesa Police Department), Chief Mike Moulton (El Cajon Police Department), Assistant Chief Phil Collum (Chula Vista Police Department), and Assistant Sheriff Brian Nevins (San Diego County Sheriff's Department)

Timothy Bilash, a member of the public, asked how the recruitment process in jails is conducted and reviewed and various other law enforcement concerns.

4. Report From Chief's/Sheriff's Management Committee

Chief Kaye reported on the recent Chiefs'/Sheriff's Management Committee meetings.

On April 19, the CSMC held a special meeting to review presentations of the Fiscal Year 2023-2024 draft budget and Fiscal Year 2024 ARJIS Workplan. After further review and discussion on the work plan, the CSMC recommended being included in these rankings and selecting the top five prior projects. Over the next few weeks, the ARJIS staff will ask the CSMC for their rankings, which will then be calculated and up for voting at the next CSMC meeting on June 7, 2023. Moving forward, the CSMC recommended that the ARJIS staff solicit input for the work plan from the Seconds in Command, Business Working Group, and Technical/User Task Force before presenting it to the Chiefs'/Sheriff's Management Committee for final review and approval.

Proposed Changes to Clarify Public Safety Committee Membership

Overview

[Board Policy 002](#) outlines the membership for SANDAG Policy Committees, including the Public Safety Committee (PSC). Proposed changes to Board Policies are brought to the Board of Directors annually. Prior to making recommendations to the Board regarding changes Board Policy 002, the PSC is asked to discuss the following proposed updates.

Action: **Discussion**

Staff will share proposed changes to clarify Public Safety Committee Membership as described in Board Policy 002.

Fiscal Impact: None

Schedule/Scope Impact: None

Key Considerations

In addition to the 12 voting members of the PSC (six Board members or alternates representing each subregion, as well as two members from the Chiefs'/Sheriff's Management Committee, a member selected by the County Sheriff, a member representing the San Diego County District Attorney's Office, a member from regional Fire/Emergency Medical Services, and a member representing the City of San Diego Police Chief), there are eight nonvoting Advisory Members.

While the description for one of these seats is consistent with policy and practice (representative for the Southern California Tribal Association), seven are not. Staff would like to recommend the following changes to Board Policy 002 for Board of Director consideration.

- Two persons selected by the Federal Justice Agency Association: Six federal agencies have historically rotated two seats, serving as primary, first alternate, and second alternate. Seat A has rotated between the U.S. Attorney's Office, Transportation Security Administration, and Immigrations and Custom's Enforcement and Seat B has rotated between the Federal Bureau of Investigation, Drug Enforcement Administration, and the U.S. Marshal. The recommendation is being made to more clearly describe this representation since there is no Federal Justice Agency Association.
- One person selected from San Diego County Criminal Justice Association: The County of San Diego Probation Department has historically filled this seat, but the recommendation is being made to update this description to reflect that this seat is to be filled by the County of San Diego's Chief Administrator Office or designee.
- A member of the Regional Homeland Security Committee: This seat has alternated between the City of San Diego's Office of Emergency Services and County of San Diego's Office of Emergency Services serving as primary and alternate. The recommendation is being made to more accurately reflect this representation.
- A member selected by the State Public Safety Agency Association: This seat has been historically filled by the California Highway Patrol and the recommendation is being made to update the policy to reflect this seat is held by the California Highway Patrol.
- One person selected by the Department of Defense: Historically, this seat has been filled by a representative from the Navy Region Southwest and the U.S. Marine Corps, alternating the primary and alternate seats. The recommendation is being made to reflect this representation more accurately.

- There is no mention in the bylaws of regional transit as an advisory member in the bylaws, but the Metropolitan Transit System and North County Transit District have alternated this Regional Transit seat. The recommendation is being made to correct this error and reflect this in the updated policies.

Next Steps

With the feedback from the PSC, SANDAG staff will work with SANDAG legal counsel to reflect these proposed changes to Board Policy 002 and bring them to the Executive Committee and Board of Directors for approval in Fall 2023.

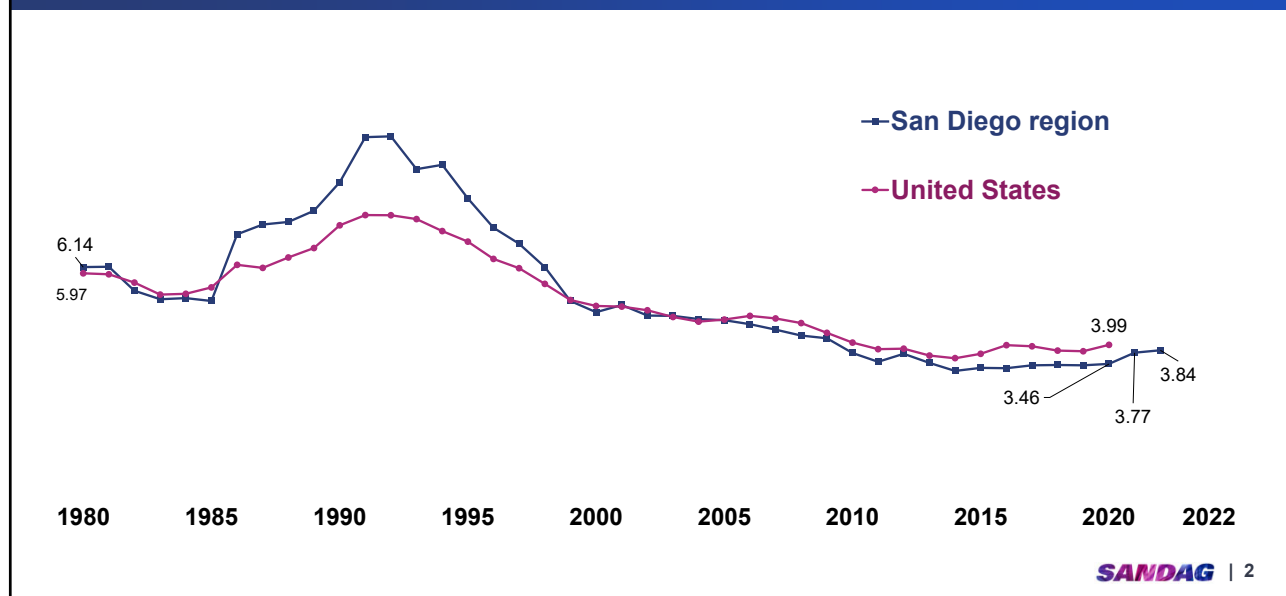


43 Years of Crime in the San Diego Region: 1980 Through 2022

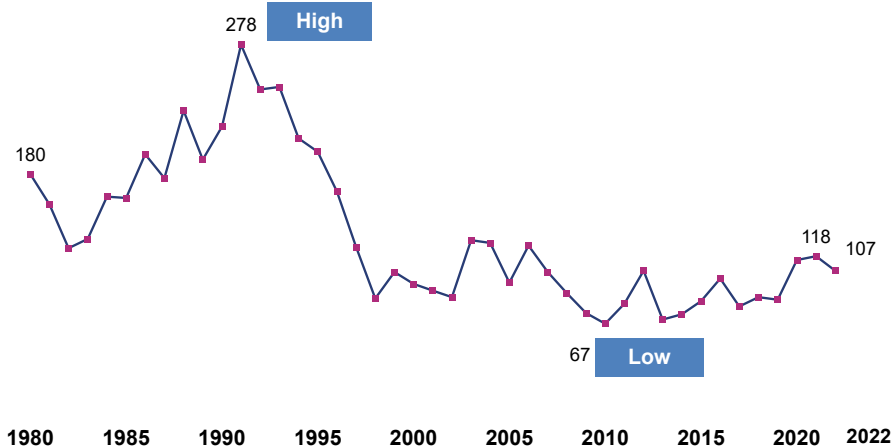

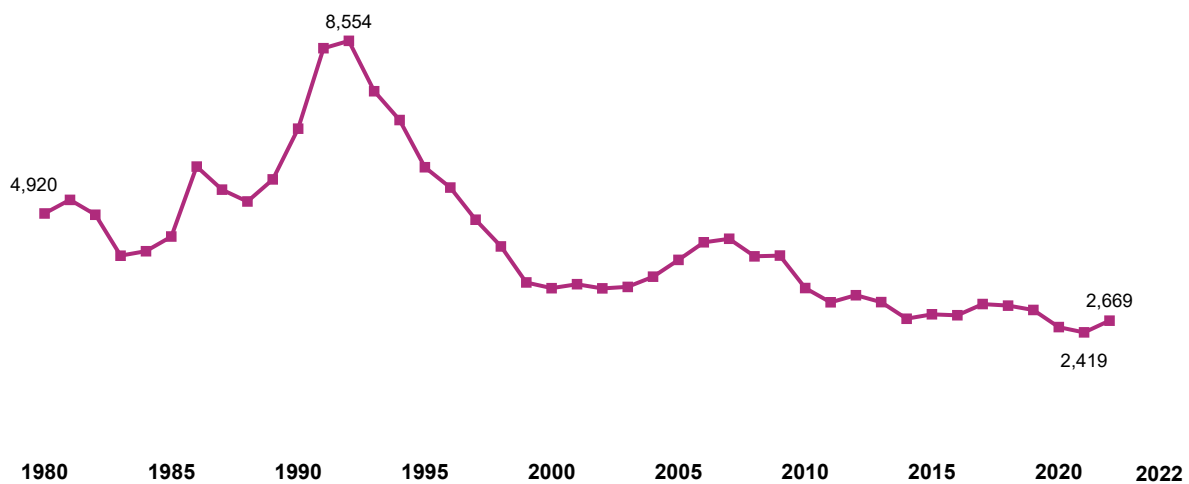

Robberies had greatest increase among violent crimes

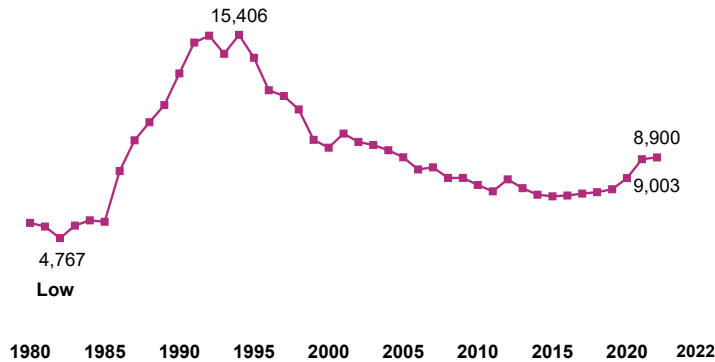

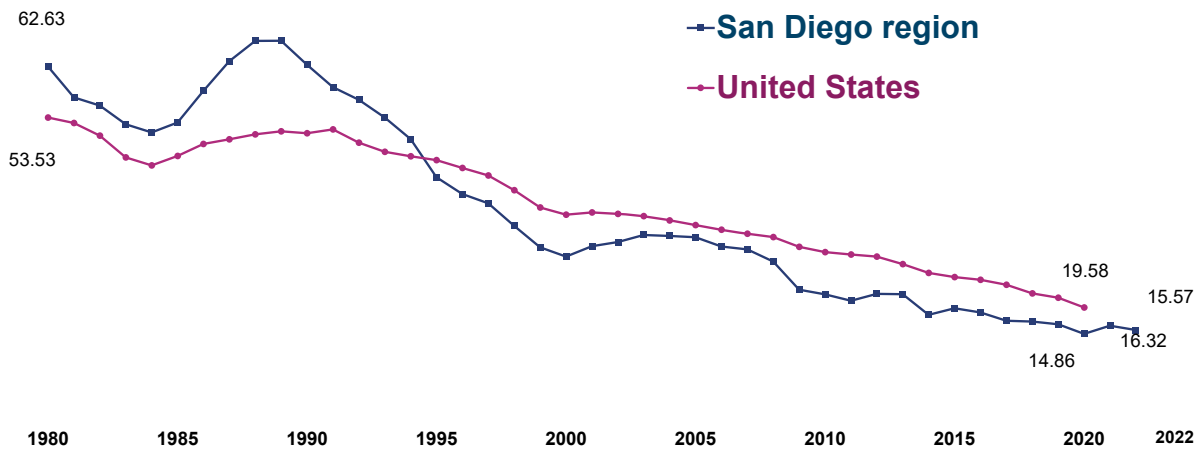

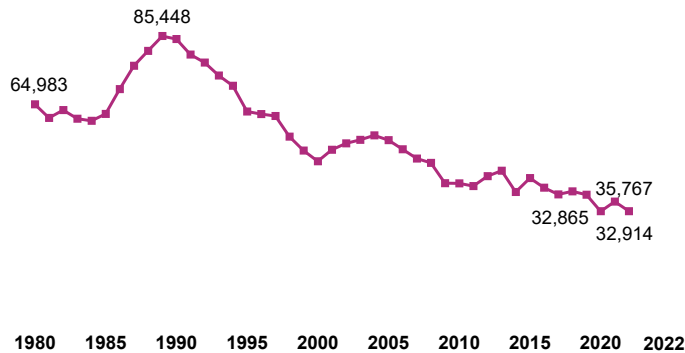

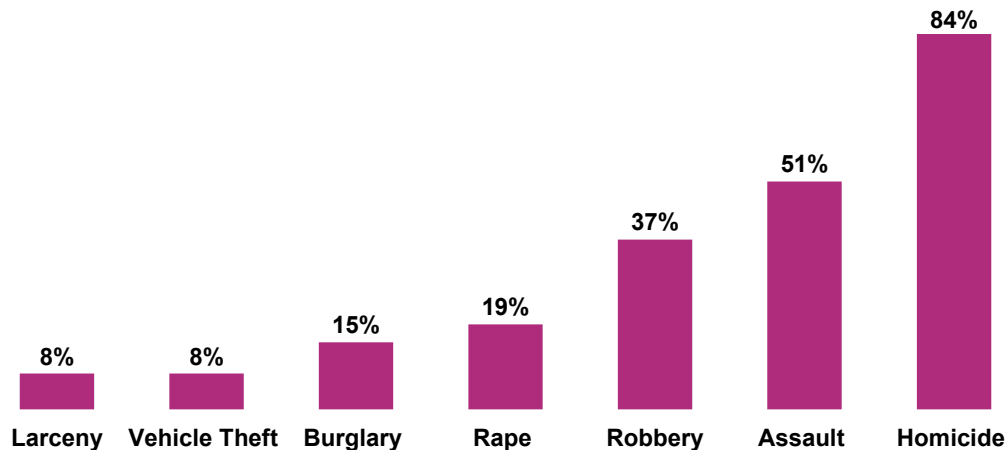

- There were 64,354 Part I crimes, 19.41 crimes per 1,000 residents
- Violent crime rate up 2%
- Homicides and rapes decreased, but robberies and assaults increased
- Property crime rate decreased 5% and is the second lowest in 43 years
- Increases in burglaries and motor vehicle thefts but decrease in larcenies
- Hate crimes and violent crimes against senior citizens were up

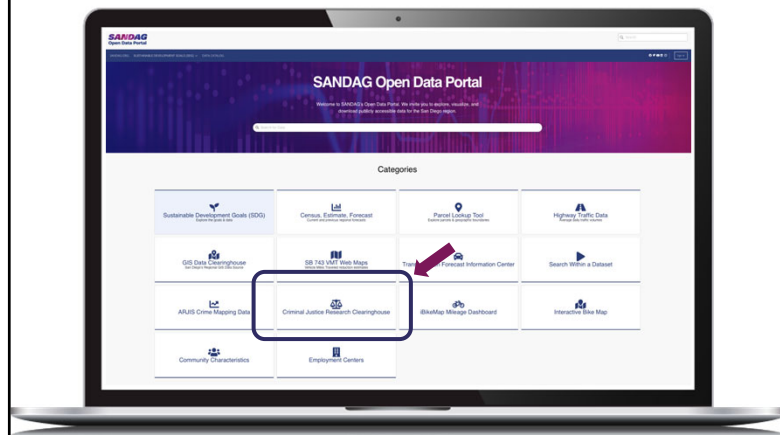

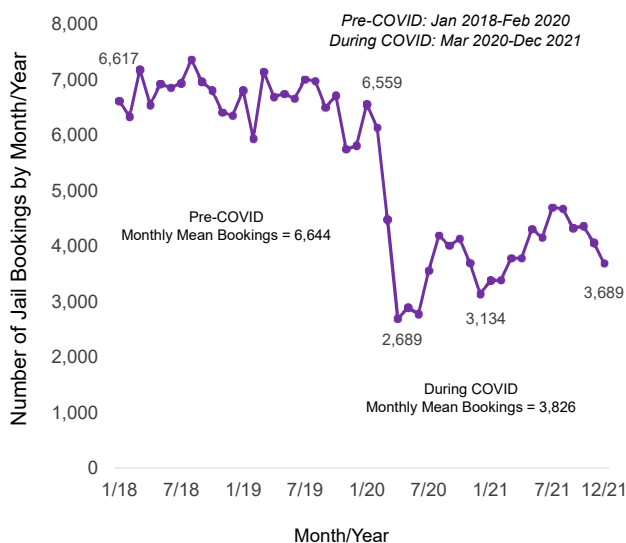

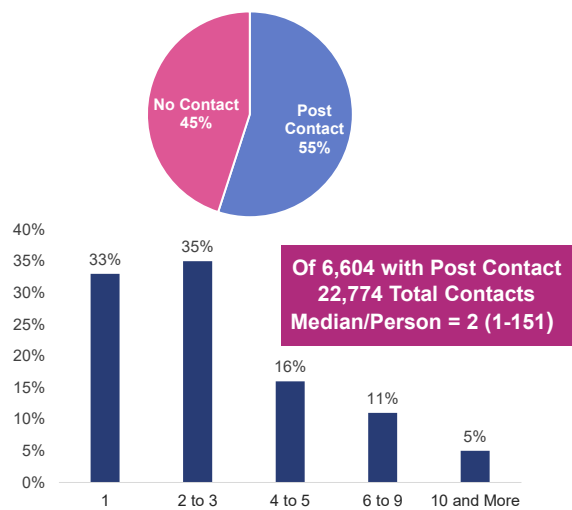

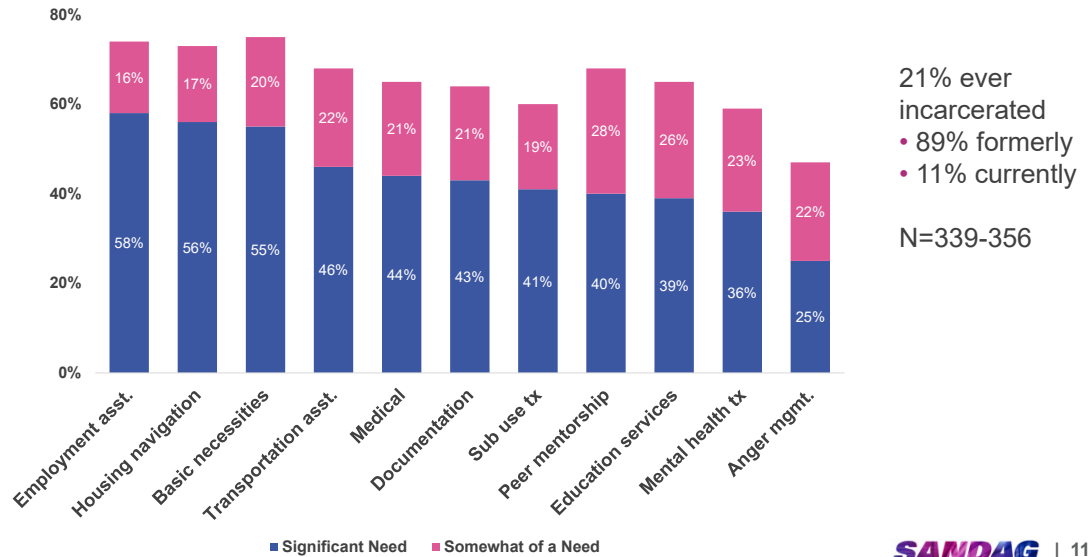

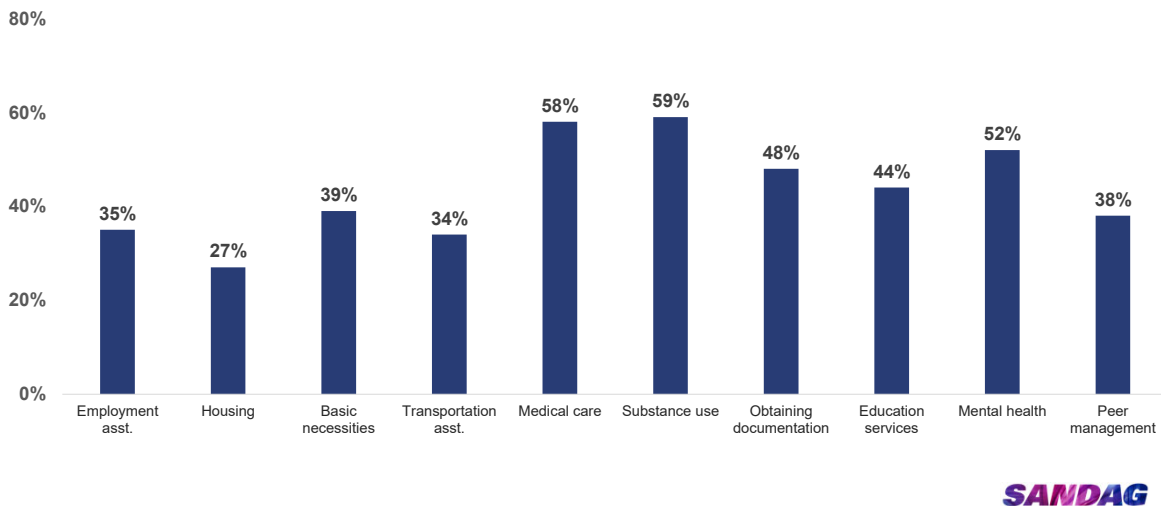

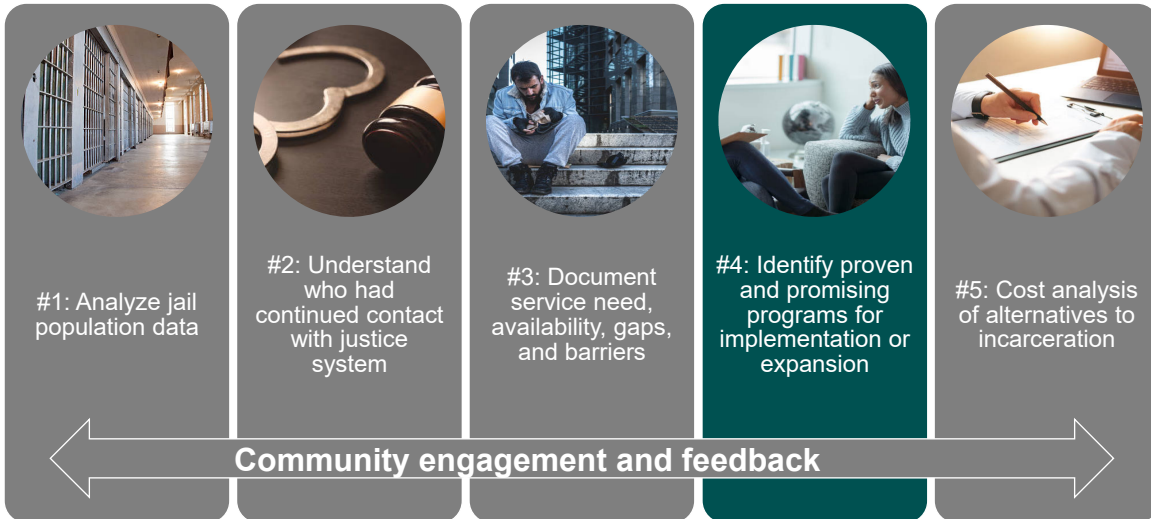

What Works, Why Does it Work, Who Does it Work For?

- Academic literature, think tanks, National Institute of Justice, Advisory and Working Group feedback
- Best practice and policy
- Address multiple needs: substance use, antisocial cognition, antisocial associates, family and marital relations, employment, and leisure and recreational activity
- Reduce system involvement, advance equity for vulnerable populations, and improve public safety
- Organized along the Sequential Intercept Model (SIM)
- Process evaluations, fidelity assessments, and impact evaluations

Guiding Principles for ATI Recommendations

- Emphasize prevention, early intervention, and rehabilitation to minimize justice system contact
- Consider HOW services are provided, not just IF they are offered
- Build upon cross-sectoral and multi-disciplinary collaboration
- Utilize coordinated care and peer mentorship
- Consistently collect, share, and evaluate data across programs and sectors
- Ensure basic needs are met
- Support families and communities disproportionately affected, while ensuring accountability to victims
- Regionalize successful local programs where possible

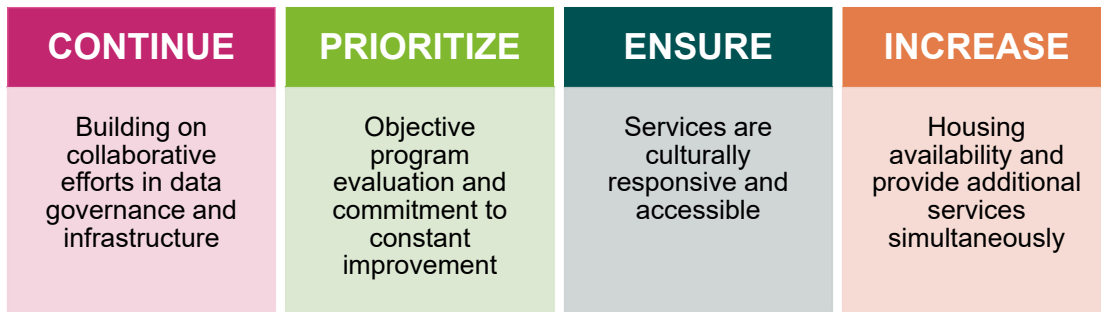

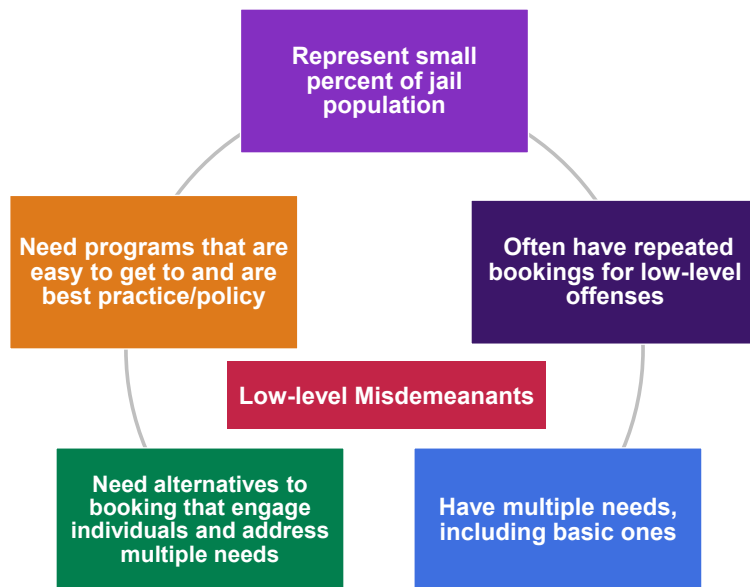

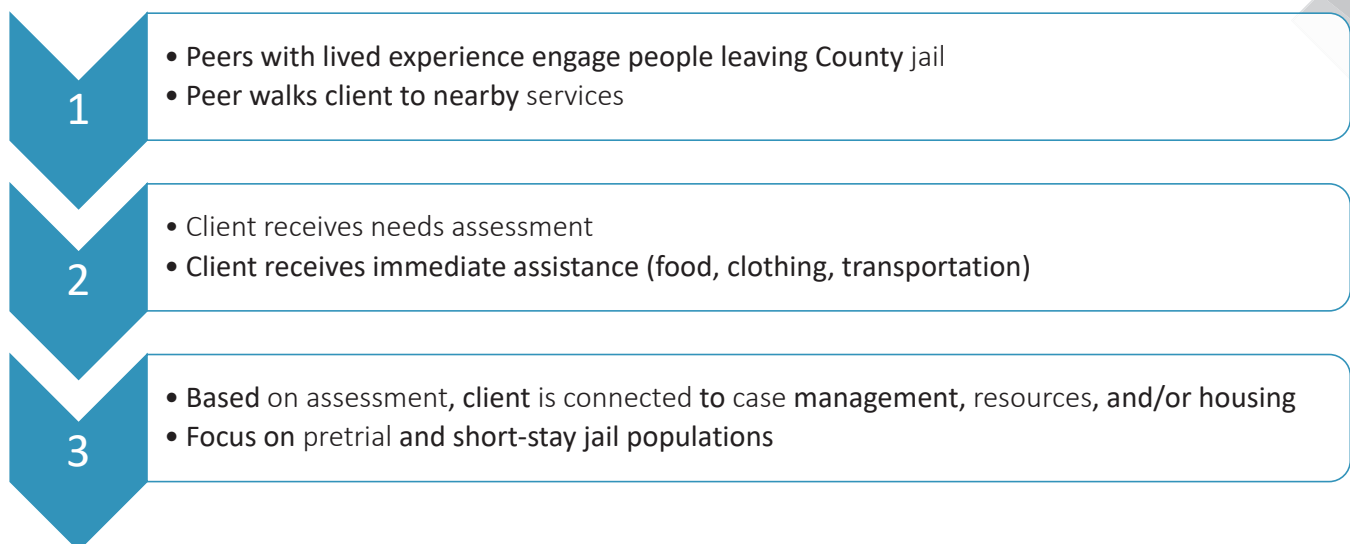
