Grant Extensions for Specialized Transportation Grant Program

Overview

The Specialized Transportation Grant Program (STGP) is a competitive grant program that seeks to improve mobility for older adults and individuals with disabilities whose needs are not met by conventional transit or Americans with Disabilities Act (ADA) paratransit services. The STGP supports several types of projects, including purchasing accessible vehicles on behalf of grantees who use them to provide specialized transportation services. Through the STGP. SANDAG has awarded Federal Transit Administration Section 5310 funding for purchasing 178 vehicles and currently oversees an active fleet of 124 vehicles that fourteen grantees around the region operate. Like other public transportation services, STGP ridership is still below pre-pandemic levels, and several grantees have requested time extensions to allow for the continued use of these vehicles.

The Transportation Committee is asked to approve time extensions greater than 12 months for Specialized Transportation Grant Program grantees that need such extensions due to vehicle appraisal values over \$5,000.

Schedule/Scope Impact:

Pending approval, the Chief Executive Officer will execute grant amendments for STGP vehicle grantees.

Key Considerations

Board Policy No. 035 applies to all competitive grant programs administered by SANDAG and outlines competitive grant program procedures. Section 4.4 (previously Section 3.2) of the Policy requires approval from a Policy Advisory Committee for grant extensions of more than twelve months. Section 3.1.4 of the policy states that funds for the "use of the… vehicles for the benefit of the public must commence within three months following acceptance…." Due to ongoing challenges stemming from the COVID-19 pandemic, the Board of Directors granted waivers of Policy No. 035 for STGP grantees, as summarized below.

Date	Approval Granted, Reason, and Duration
January 22, 2021	Waiver of Section 3.1.4 (previously Section 1.1.4) to allow vehicles to be put in non-use status for up to 12 months if needed due to public health concerns for riders.
November 19, 2021	Retroactive approval for various STGP vehicles to continue to be in non-use status until February 1, 2022.
February 25, 2022	Retroactive waiver in effect from January 1, 2022, to June 30, 2022, to allow the Chief Executive Officer to authorize grantees to continue the non-use status of vehicles, grant scope change amendments, and extensions of up to 12 months.

Under these waivers, various STGP grantees were allowed to place their STGP vehicles out of service for long periods. Reasons grantees removed one or more vehicles from service include reduced demand, concern over the health and safety of older adults and individuals with disabilities, and physical distancing requirements. Additionally, some grantees removed vehicles from service initially due to maintenance or other repairs needed, and global supply chain disruptions caused significant delays for parts or supplies, rendering vehicles out of service for an extended period. While most vehicles are no longer out of service, these waivers allowed them to reduce service, resulting in low mileage rates across numerous vehicles in the STGP.

All STGP vehicles are procured using Federal Transit Administration (FTA) Section 5310 funding, which requires vehicles to comply with useful life requirements outlined in FTA Circular 5010.1E (Circular).

The Circular requires vehicles to remain in service for a minimum number of years or miles, whichever comes first, and varies depending on the type of vehicle. Consequently, on September 16, 2022, the Transportation Committee approved a request to provide time extensions over six months to grantees who placed vehicles out of service for extended periods so they could meet the FTA useful life requirements. Additionally, the FTA retains a financial interest in a vehicle, even if useful life has been met, until the vehicle has an appraised value of less than \$5,000. Grantees that reduced service over the past three years have vehicles with low odometer readings and the appraised value remains above \$5,000. Several grantees have requested time extensions for their vehicle projects to continue providing specialized transportation service and achieve higher odometer readings and vehicle appraisal values under \$5,000 to avoid federal interest.

The Transportation Committee is asked to approve time extensions over twelve months for the STGP grantees listed in the table below that placed one or more vehicles out of service due to prior waivers, supply chain delays, or reduced demand. All of these vehicles are back in service. The length of extension time needed is estimated based on current mileage rates and amount of time needed to increase vehicle odometer readings and lower appraisal values.

Overview

The 2021 Regional Plan assumes growth in electric bike (e-bike) adoption rates through an investment of \$35 million in e-bike incentives over the life of the plan to help reduce vehicle miles traveled (VMT) and greenhouse gas (GHG) emissions.

During the COVID-19 pandemic, U.S. bike sales were up 65% between 2019 and 2020, and e-bike sales grew by 145% in the same period. E-bikes expand the number of people who can ride bikes as a viable

option for getting around, because of their speed and ease of travel, which is crucial for traveling across our region's hills. Recent studies have found that people who purchase e-bikes more than double their use of bikes for travel. Not only are they biking more, but studies point to the fact that people are replacing car trips.

SANDAG is partnering with Pedal Ahead, a 501(c)(3) program, to implement an e-bike incentive pilot that will expand sustainable mobility options for underserved communities. The pilot will help fulfill a near-term commitment in the 2021 Regional Plan of funding local e-bike incentives while strongly aligning with SANDAG priorities to reduce congestion, advance equity, and combat climate change. SANDAG anticipates using the data gathered from this program to inform future pilots and programs.

The pilot program launched in November 2022, and will run for 24 months. In the first week, 1,500 applications were received to fill 125 spots. Applications are screened using evaluation criteria that prioritizes low-income residents living in disadvantaged communities and within 15 minutes of transit. Selected program participants receive an e-bike along with training that maximizes their knowledge of how to use and maintain the bike. Program participants will track their miles traveled through Strava and quarterly surveys. Participants are offered quarterly trainings and group rides led by the San Diego County Bicycle Coalition. After two years, participants can keep their e-bike if they accomplish the program requirements.

Next Steps

Over the next two months, Pedal Ahead will continue distribution of e-bikes and participants will begin tracking their usage and reporting back to the program. SANDAG will collect and analyze data and report back on progress over the life of the pilot program.






San Diego and Imperial Counties Sustainable Freight Implementation Strategy

Overview

SANDAG, in partnership with the Imperial County Transportation Commission (ICTC), was awarded a Caltrans Sustainable Transportation Planning Grant to conduct the San Diego and Imperial Counties Sustainable Freight Implementation Strategy (Sustainable Freight Strategy).This study will develop freight related strategies, projects, policies and programs that leverage innovative and multimodal technologies to meet climate, air quality, and public health goals.

Action: Information

Staff will present an update on the San Diego and Imperial Counties Sustainable Freight Implementation Strategy.

Fiscal Impact:

The project is funded by a \$500,000 Caltrans Sustainable Transportation Planning Grant.

Schedule/Scope Impact:

The project is expected to be completed by February 2024.

Key Considerations

San Diego and Imperial Counties (collectively the

Gateway Region) play a critical role in global supply chains by facilitating international trade. The freight industry transports billions of dollars' worth of goods annually through the Gateway Region's ports, highways, railroads, airports and land ports of entry. The demand for goods moving through the region is driven primarily by cross-border trade, industrial warehouses in the Inland Empire, the Ports of Los Angeles and Long Beach, and major intermodal rail yards in Los Angeles and San Bernadino Counties. With significant goods moving through the region, communities near major freight hubs are subject to public health, air quality, noise, congestion, and safety impacts. California's ambitious climate, air quality, and public health goals will require the freight sector to transition towards more sustainable technologies, operations, and infrastructure.

The Sustainable Freight Strategy kicked off by developing the project goal to guide the development of the strategy, to create a more sustainable supply chain network through regional freight projects and policies that reduce emissions while fostering trade. As part of the research and evaluation of sustainable freight best practices around the world, the project development team (made up of representatives from SANDAG, Caltrans, ICTC, and consulting team), reviewed projects, programs, and policies for San Diego and Imperial Counties that were included in adopted regional transportation plans and leveraged the best practice research to develop new, innovative ideas.

The development of the Sustainable Freight Strategy employed numerous forms of outreach to engage stakeholders throughout the region with a focus on communities near major freight hubs. Stakeholder engagement efforts included one-on-one interviews, focus groups, public surveys, working group discussions and outreach events. The list of sustainable freight strategies developed for this study are being evaluated using environmental, equity, and economic criteria and considering feedback from the stakeholder engagement efforts.

Next Steps

The evaluation process that is underway will result in the prioritization of strategies for implementation. Two additional deliverables will be prepared for this study: an implementation plan and a workforce development toolkit. The implementation plan will identify pilot opportunities, develop their high-level cost estimates and project schedules, and identify potential funding opportunities. The workforce development toolkit will identify occupational needs and opportunities along with available training programs. The final report is expected to be completed in early 2024.







Independent Taxpayer Oversight Committee Report on Initial Findings and Recommendations of the FY 2022 TransNet Fiscal and Compliance Audits

Overview

In accordance with the TransNet Extension Ordinance, the TransNet Independent Taxpayer Oversight Committee (ITOC) has the responsibility to conduct the annual fiscal and compliance audits of agencies that receive TransNet funds. The TransNet Extension Ordinance requires the ITOC to share the initial audit findings and its recommendations with the Transportation Committee 60 days prior to its release to resolve any inconsistencies and technical issues.

Key Considerations

Davis Farr, LLP, performed the audit of the FY 2022 TransNet sales tax revenue recipient agencies using the agreed-upon procedures (AUP) approved by the ITOC at its September 14, 2022, meeting. These AUP include requirements specific to the TransNet Extension Ordinance and SANDAG Board Policy No. 031. Attachment 1 includes both the independent auditor's summary of results of the draft AUP and recipient agency FY 2022 TransNet draft AUP reports.

Action: **Discussion**

The Transportation Committee is asked to review the Independent Taxpayers Oversight Committee's draft independent fiscal auditor's report for any inconsistencies and technical issues.

Fiscal Impact:

The annual TransNet fiscal and compliance audits are conducted by the ITOC and its independent fiscal auditor and funded throughOverall Work Program Element No. 1500200 in the FY 2022 Program Budget.

Schedule/Scope Impact:

The FY 2022 TransNet Fiscal and Compliance Audit is an annual review of all agencies that receive TransNet funding.

Next Steps

In accordance with the fiscal and compliance audit procedures outlined in Board Policy No. 031, proposed dates for upcoming audit activities are discussed below:

- **April 2023**: The Auditors issued a report of compliance audit results and presented it to the ITOC at its April 12, 2023, meeting.
- July 4, 2023: This is the earliest date the ITOC could accept and issue the final compliance audit results (60 days following the report of the initial draft audit findings to the Transportation Committee on May 5).
- July 2023: Acceptance of the final summary of results of the AUP for issuance is scheduled for ITOC consideration at its July 12, meeting. The ITOC Annual Report, which includes results of the annual compliance audit, is scheduled for the July 28, 2023, Board of Directors meeting.

FY 2022 *TransNet* Extension Ordinance Funding Eligibility Request

Overview

The TransNet Extension Ordinance (Ordinance) includes annual eligibility requirements for the transit operators and local jurisdictions to continue receiving their annually apportioned TransNet revenues. If a requirement is not met, the Ordinance provides guidance on additional steps.

For FY 2022, the cities of San Marcos and Poway had requirements that were not met and are requesting to cure the eligibility requirements.

Key Considerations

Responsibility for making the final decision on these eligibility requests rests with the Board of Directors.

Approval of these requests enables compliance and requesting agencies would be eligible to receive all apportioned FY 2023 TransNet revenues consistent with TransNet Ordinance provisions.

Without Board approval of San Marcos' request letter, the city of San Marcos would remain noncompliant and receive FY 2023 revenues less the shortfall of the Maintenance of Effort (MOE) requirement.

Without Board approval of Poway's request letter, the city would remain noncompliant with the Ordinance and would transfer the unexpended portions of the RTCIP funds to SANDAG to be spent on qualified projects within the same subregion.

Action: Recommend

The Transportation Committee is asked to:

- Consider the TransNet funding eligibility requests of the cities of Poway and San Marcos.
- 2. Recommend the Board of Directors, acting as the San Diego County Regional Transportation Commission, approve the requests.

Fiscal Impact:

Approval of the requests will allow the requesting agencies to receive their full FY 2023 TransNet revenue apportionments.

Schedule/Scope Impact:

Upon approval of the requests by the Board of Directors, the findings will be removed and noted as corrected in the FY 2022 TransNet fiscal and compliance audits for final adoption by the Independent Taxpayer Oversight Committee at its July 12, 2023, meeting.

Next Steps

Discussion Memo

TransNet Extension Ordinance Eligibility Requirements

Section 8 states:

Each local agency receiving revenues pursuant to Section 4(D) shall annually maintain as a minimum the same level of local discretionary funds expended for street and road purposes on average over the last three fiscal years completed prior to the operative date of this Ordinance (Fiscal Years 2000-01, 2001-02, 2002-03), as was reported in the State Controller's Annual Report of Financial Transactions for Streets and Roads and as verified by an independent auditor. This is referred to as the Maintenance of Effort requirement (MOE).

Section 8 of the Ordinance also includes the following language:

Any local agency which does not meet its maintenance of effort requirement in any given year shall have its funding under Section 4(D)(1) reduced in the following year by the amount by which the agency did not meet its required maintenance of effort level.

In the event that special circumstances prevent a local agency from meeting its maintenance of effort requirement, the local agency may request up to three additional fiscal years to fulfill its requirement.

Section G(4) of the Transnet Extension Ordinance states that cities must have RTCIP funds committed or expended on Regional Arterial Systems projects within 7 years before requiring an eligibility request by ITOC.

City of San Marcos

The draft FY 2022 *TransNet* fiscal and compliance audit report for the City of San Marcos includes the following finding:

City Request

Section 8 of the Ordinance states, in part:

"Each local agency receiving revenues pursuant to Section 4(D) shall annually maintain as a minimum the same level of local discretionary funds expended for street and road purposes on average over the last three fiscal years completed prior to the operative date of this Ordinance..."

In accordance with Section 8 of the Ordinance, the City of San Marcos (Attachment 2) is requesting until June 30, 2025, to make up the deficits due to special circumstances.

Next Steps

Approval of this request by the Board of Directors would enable compliance with Section 8 of the Ordinance, and the City of San Marcos would be eligible to receive all apportioned FY 2023 TransNet revenues.

Should the Board of Directors choose to not approve the request, then the City of San Marcos would remain in noncompliance for FY 2022 and would be eligible to receive FY 2023 TransNet revenues less the shortfall of \$39,988.

City of Poway

City Request

Section G(4) of the Transnet Extension Ordinance states, in part regarding the 7 year requirement:

"Unless a planned need for such fees can be demonstrated and a justification for the delay can be provided that is acceptable to the Independent Taxpayer Oversight Committee, the unexpended or uncommitted portion of the Funding Program revenues shall be transferred to the Regional Transportation Commission (SANDAG) to be expended within three years on qualified projects within the same subregion."

In accordance with Section G(4) of the Transnet Extension Ordinance, the City of Poway is requesting until June 2023 to remedy the unexpended revenues.

Next Steps

Approval of this request by the Board of Directors would enable the City of Poway to keep their RTCIP funding per Section G(4) of the Transnet Extension Ordinance.

Should the Board of Directors choose to not approve the request, then the City of Poway would remain in non-compliance for FY 2022 and would have to transfer those uncommitted or unexpended portions of the RTCIP funds to SANDAG to be spent on qualified projects within the same subregion.

The *TransNet* Audit Report (agreed- upon procedures) for fiscal year ended June 30, 2022 indicates that the City did not meet the Maintenance of Effort (MOE) requirement, as required by Section 8 of the *TransNet* Extension Ordinance.

The deficit occurred due to unexpected delays to the project start date. The City budgeted sufficient discretionary funds to meet its MOE requirements for FY2021-22, but a large sum of discretionary funds were not expended before the end of the fiscal year as a result of this delay. The City is committed to completing this project and other street maintenance related projects within the required timeframe to meet the MOE requirement moving forward.

In accordance with Section 8 of the *TransNet* extension Ordinance, the City of San Marcos requests that the commission review and approve our request to allow the City an additional three years, until June 30, 2025, to expend aforementioned amount over and above our regular MOE threshold to make up the shortfall, due to special circumstances. The additional time requested to fulfill the FY2021-22 MOE shortfall provides the City with the opportunity to use its finite amount discretionary funds to meet the requirements of the TransNet extension ordinance.

Our expense plan to fulfill the extension requirements is provided in the table below:



Dear Ms. Huntington,

The draft City of Poway TransNet Audit Report (agreed- upon procedures) for fiscal year ended June 30, 2022, indicates that the City did not expend or commit its RTCIP funding within the seven-year requirement. The primary reason for being in non-compliance is due to RTCIP eligible project expenditures incurred that had been charged to the incorrect funding source. Documentation in support of these expenditures totaling \$258,203.00 has been provided to the TransNet auditor and is currently being reviewed. A journal entry to charge these expenditures against the RTCIP funding source has since been recorded in the current fiscal year. We are confident that, once the auditor's review is complete, the City will be comfortably back in compliance with the seven-year expenditure requirement. In addition, project POW48 was completed in early FY23 causing a large uncommitting of RTCIP funding previously committed on past audits.

In accordance with Section G (4) of the TransNet extension Ordinance, the City of Poway requests that the commission review and approve our request to allow the City until June 30, 2023, to expend the necessary amount to make up the shortfall. The additional time requested to fulfill the requirement will provide enough time for the auditor's review of the additional RTCIP expenditures provided and the reimbursement to the General Fund for RTCIP eligible project expenditures that were incurred but charged to the General Fund in error, which will then bring the City into compliance with the seven-year spend down requirement.
