

News Center - is there a lack of Flu vaccines due to increased demand - There are periodic limit stock outs of higher dose vaccines - but not aware of any systematic shortages or disruptions

Holiday Plans for family visits - there is a risk regardless of size if there is infection amongst the participants

Trump tested positive - When is someone no longer shedding or infectious - US CDC determinations Recovered can resume without risk of transmission Must be symptom free for a series of days absent medications, for a period of days

Regeneron - use? Not all data is yet in - Early data should be called by the US DA

Maine Beacon - Voter intimidation, are you aware of any planned disruptions? Not at this time

Online Voter Registration - Is Maine working to put in place soon - thinks will be addressed in the next election

Patti White Maine Public - Charter School outbreak - mostly Staff - How Transmitted? Key focus of the investigation (9 Staff) persons - was face covering being used in School? Other outbreaks - were using face coverings - but when employees remove with each other during breaks/break rooms - transmission then occurs.

Indications that Staff followed protocols - took off masks to answer questions? Small lapses can transmit - close proximity in workplace settings are being reviewed due to close

Indications that Staff followed protocols - took off masks to answer questions? Small lapses can transmit - close proximity in workplace settings are being reviewed due to close proximity and prolonged contact

**BDN** - Halloween - Risk in Trick or Treaters or Homeowners passing out the candy - In general, concerns are more about adults than children - especially higher risk adults - Door to Door contact even under the 15 minute contact time - could experience cumulative dose through multiple contacts

**PPH** - Hockey - was it youth games - potential exposures? - do not yet have the counts of potential exposures - potentially early estimate of 400 persons Community Sports Guidelines - indoor hockey still not allowed - would this be a violation? Focused on making contact - do not yet determine a violation afterwards. Is a violation of Community Sports guidelines a violation of Gov EO's? - Did not answer - talked about a Regional Approach - Nov 2nd target date for bars



Drop Box use seems to be working well

Anticipate 500,000 - 600,000

Secretary does not believe you can constitutionally be turned away at the polls without a mask - BUT can be turned away at City Hall as you have time to use alternative means - Encouraged to Wear a mask as part of your civic obligation

WABI - Skowhegan has major outbreaks and schools have gone red - concerned about larger spread across ALL of Maine - What happened in York can or will happen elsewhere in Maine - especially in rural areas having not had before





Over time, some states have reached the minimum testing target, and a few have exceeded it.



### NOTICE OF VIOLATION, ORDER TO CORRECT

INSPECTION: 277 BLANCHARD RD, SANFORD, ME (TAX MAP R4-12A)

Dear JOSEPH T DUNICAN & ASHLEY CARRUTHERS,

On 06/19/2020, the City of Sanford inspected this property and found VIOLATIONS listed on this notice pursuant to City Code §90-13 et seq., City Code §149-5.1 et seq., City Code §149-6.1 et seq., City Code §220 et seq. and City Code §280 which you are hereby ORDERED TO CORRECT by the DATE FOR COMPLIANCE listed. You must sign and return the CERTIFICATION to the Code Enforcement Office no later than 10 business days from the receipt of this Notice. If you require additional time to correct the violations due to a substantial hardship, you must contact the Code Enforcement Office to request additional time, within 10 business days. If you have not remedied the violations by the date for compliance listed or have not been approved for a compliance time extension, the City of Sanford will take actions as deemed necessary to remedy the violations and recover the City's direct, legal and administrative cost from you.

FAILURE TO SIGN AND RETURN THIS NOTICE ON TIME OR CORRECT ALL VIOLATIONS WITHIN THE APPLICABLE TIMEFRAME WILL RESULT IN LEGALACTION AGAINST YOU, THE IMPOSITION OF CIVIL PENALTIES, AND THE PURSUIT OF OTHER LEGAL REMEDIES.

Any person who violates a provision of City Code and who fails to comply therewith, or with any of the requirements thereof, shall be penalized in the amount of \$500 for unlicensed activity and penalized not less than \$100 and not more than \$2,500 for each specific violation, and other remedies, injunctive relief, and costs as set forth in accordance with 30-A M.R.S.A. § 4452. Each day during which a violation of said code continues, 10 days after notification by the Code Official, shall constitute a separate offense. In lieu of or in addition to the issuance of a citation for the violations listed in this notice, a land use complaint may be initiated pursuant to Rule 80-K of the Maine Rules of Civil Procedure and 30-A M.R.S.A. § 4452 and § 3758-A. A judgement from such a lawsuit in the City's favor will result in a court order that a license be obtained for the rental housing and any other violations be abated; the imposition of a penalty of not less than \$100 per day for each specific violation; and the payment of court costs and the City's legal fees.

The above referenced City Codes are available for review at the Code Enforcement Office or at <a href="https://www.sanfordmaine.org/citycode">www.sanfordmaine.org/citycode</a>. Contact the Code Enforcement Officer with any questions.

You may appeal this Order and request a hearing before the City of Sanford Board of Appeals by filing a written petition at the Code Enforcement Office within 30 days of the receipt of this notice. This petition shall be submitted on a form provided by the Code Enforcement Office along with the appeal fee. Should you fail to appeal, you will be barred from any opportunity to contest or challenge the terms of this Order in any further legal proceedings.



Dear Mr. Dunican and Ms. Carruthers:

I am writing to advise you that certain activities that have and will be taking place on your property located at 277 Blanchard Road, Springvale Maine, may be illegal and that the Police Department is intent on preventing these activities and placing criminal and civil charges should any violations occur. You should know that several residents and neighbors on Blanchard Road have been complaining about:

- Parties that go late into the evening, with very loud music
- Guests from your parties who appeared to be intoxicated, trespassing on private property
- That you are apparently charging admission for your parties. Requiring a donation to enter/stay is not a donation. You are not licensed to have such a party and charge admission
- Apparent advertisement and sale of cannabis products from your residence you
  are not licensed to be a medical marijuana dispensary, and
- Several violations of the Governor's Executive Orders regarding COVID-19
  restrictions, specifically that you are hosting parties with more than 100 people
  present, and those present are not social distancing and not wearing face
  coverings as required

I realize that you and your neighbors have what could be described as an adversarial relationship; I know that some of your neighbors have been harassing you, and that you have obtained a protection from harassment order against at least one neighbor. That being said, I also believe that many of the complaints made regarding your "parties" are probably accurate. I have been following your advertisements on

line, and I am aware that there could hundreds of people attending your event scheduled for September 18-20. I have also read that you may use a shuttle bus to bring people to and from your property.

Your neighbors have complained long and often to the City of Sanford Codes Department, the City Manager, and the City Council. The powers that be have reached the limit of their patience, and this matter has been delivered to me for some type of resolution.

So, here is what I would like to see happen:

- That you will cease advertising for and hosting large parties that attract hundreds
  of people. You are not licensed for special events. Additionally, under the
  Governor's Emergency Orders, you are not allowed any more than 100 people at
  any outdoor event; if the 100 people at any event cannot or do not social
  distance, then participants must wear a face covering
- 2. That you ensure that you comply with Sanford Ordinance 178, Noise, especially (4) (1) and (2). In essence, you may not make any noise or play any music that can be heard more than 75 feet from your property line after 10:00 PM on Friday and Saturday nights; 9:00 PM on Sunday nights
- 3. That you cease any activities that are related to the use of your property as a Medical Marijuana Dispensary. It is my understanding that neither you nor Ms. Carruthers is allowed to be a caregiver in Sanford, as the City did not opt-in for LD 1539, which expanded the operations of caregivers. Your Baked Boxer website is very nice. Unfortunately, you may not operate as a dispensary or provide services as a caregiver

I would hope that you would understand that I obtain no pleasure in taking action against these non-violent issues; however, your refusal to listen to your neighbors, and abide by the directives of our Codes Department, has now placed this matter at my feet. Here is what I am prepared to do:

1. I am directing my officers to conduct frequent patrols at your property, especially from 09-18-20 through 09-20-20. Any and all qualifying violations of the noise ordinance will result in a summons for the City ordinance violation, 178-4. The penalty is \$50, and each subsequent violation doubles the fine; \$50, \$100, \$200. If we do not get compliance, I will elevate this to a Class E (misdemeanor)

Disorderly Conduct, §17-A, 501 (A), and obtain a warrant for your arrest. You could be fined up to \$1,000 and jailed (doubtful)

- 2. If you do not stop advertising and hosting large parties, especially parties that violate the Governor's Executive Orders on the maximum number of people and the requirements to wear a face covering, then I will document the event and the violations, and I will either personally issue you a summons or obtain a warrant for your arrest. I hope you understand that with all of the COVID angst present in the community, that the Attorney General's office would be more than pleased to authorize your arrest. For your information, I have asked the MDEA to insert an undercover agent into one of your parties we'll pay the "voluntary" admission fee. That agent will take photographs to document any violations
- 3. You must remove the signs from your property advertising the sale of Cannabis products, and you must stop engaging in any marijuana caregiver or dispensary business. While these are mainly code and licensing regulations, I promise you that I will burn-up the phone lines between Sanford and The Office of Marijuana Policy until someone from that office files the appropriate court injunction against you. This is in addition to working with my Codes Department to prosecute any and all code violation in civil court. I understand that the fines for such civil violations can run into the thousands of dollars, plus legal fees on your part

The ball is now "in your court." You can disregard everything in this letter; should you do that, I promise you that I will take each and every action I mentioned. I would be pleased to meet with you at your convenience, and discuss how we can avoid any and all future confrontations.

### §441. Code enforcement officers

### (REALLOCATED FROM TITLE 12, SECTION 4812-C)

1. Appointment. In every municipality, the municipal officers shall annually by July 1st appoint or reappoint a code enforcement officer, whose job may include being a local plumbing inspector or a building official and who may or may not be a resident of the municipality for which that person is appointed. The municipal officers may appoint the planning board to act as the code enforcement officer. The municipal officers may remove a code enforcement officer for cause, after notice and hearing. This removal provision only applies to code enforcement officers who have completed a reasonable period of probation as established by the municipality pursuant to Title 30-A, section 2601. If not reappointed by a municipality, a code enforcement officer may continue to serve until a successor has been appointed and sworn.

**2.** Certification; authorization by municipal officers. No person may serve as a code enforcement officer who is authorized by the municipal officers to represent the municipality in District Court unless that person is currently certified under Title 30-A, section 4453, as being familiar with court procedures.

Upon written authorization by the municipal officers, a certified code enforcement officer may serve civil process on persons whom that officer determines to be in violation of ordinances adopted pursuant to this chapter and, if authorized by the municipal officers, may represent the municipality in District Court in the prosecution of violations of ordinances adopted pursuant to this chapter. - 3. Powers and duties. The duties of the code enforcement officer shall include the following:
- A. Enforce the local shoreland zoning ordinance in accordance with the procedures contained therein; [PL 1985, c. 481, Pt. A, §29 (RAL).]
- B. Collect a fee, if authorized by a municipality, for every shoreland permit issued by the code enforcement officer. The amount of any such fee shall be set by the municipality. The fee shall be remitted to the municipality; [PL 1985, c. 481, Pt. A, §29 (RAL).]
- C. Keep a complete record of all essential transactions of the office, including applications submitted, permits granted or denied, variances granted or denied, revocation actions, revocation of permits, appeals, court actions, violations investigated, violations found and fees collected; and [PL 2013, c. 320, §14 (AMD).]
- D. Investigate complaints of alleged violations of local land use laws. [PL 1985, c. 481, Pt. A, §29 (RAL).]
