Members present were M. Michelle Dearing, Thomas J. Kent, and Jeffrey W. Love. Benjamin T. Carson was absent. Clerk Sana G. Booker presided.

- 1. APPROVAL OF MINUTES
 - <u>July 1, 2025, Meeting</u>
 Mr. Love moved to accept the minutes of the July 1, 2025, Board of Works meeting.
 Mr. Kent seconded the motion.

The motion was adopted.

2. NEW BUSINESS

a. <u>Street and Sidewalk Closure: West Leslie Avenue – Browning Tree Service Corp.</u> <u>– Parks</u>

Greenspace Administrator Brandon Hall requested approval of a street and sidewalk closure on behalf of Browning Tree Service Corp. On July 9, 2025, Browning will remove a large Sycamore tree and clean up an overgrown corner adjacent to the West Lafayette Junior/Senior High School. Crews will utilize both lanes of West Leslie Avenue, from Hayes Street to the intersection with Ravinia Drive. Sidewalk traffic along Ravinia Drive will be routed around the closure and the sidewalk along West Leslie Avenue will remain open.

Mr. Love moved that the street and sidewalk closure be approved. Mr. Kent seconded the motion.

Mr. Kent asked if the Parks Department was pleased with the quality of work from Browning Tree Service. Administrator Hall said they are.

Clerk Booker asked if there would be signs on the street to route people. Administrator Hall said there will be. Browning does a great job of bringing the correct signs, routing traffic, and having people posted to direct traffic if needed.

b. <u>Retroactive Elevation: Probationary Police Officer to Officer First Class – Ryan</u> <u>McDonald – Police</u>

Police Chief Adam Ferguson requested approval to elevate Ryan McDonald from Probationary Police Officer to Officer First Class, effective retroactively to June 21, 2025. His new bi-weekly salary will be \$2,852.17 and will include a \$0.50 night shift differential.

c. <u>Retroactive Elevation: Probationary Police Officer to Officer First Class – Jonathan</u> <u>Wealing – Police</u>

Chief Ferguson requested approval to elevate Jonathan Wealing from Probationary Police Officer to Officer First Class, effective retroactively to June 21, 2025. His new bi-weekly salary will be \$2,852.17 and will include a \$0.50 night shift differential.

Mr. Love moved that the retroactive elevation be approved. Mr. Kent seconded the motion.

Mr. Kent asked if the Department is at full complement. Chief Ferguson said there is one spot currently open with two potential officers undergoing background investigation.

d. <u>Retroactive Elevation: Social Service & Crisis Response Specialist to Social</u> <u>Service & Crisis Response Manager – Devon Moore – Police</u>

Chief Ferguson requested approval to elevate Devon Moore from Social Service & Crisis Response Specialist to Social Service & Crisis Response Manager, effective retroactively to May 24, 2025. Manager Moore has demonstrated the competence and commitment necessary for this advancement. She has also been working to help train our new Social Service And Crisis Response Specialist Patience Smith. Her new bi-weekly salary will be \$3,177.82.

Mr. Love moved that the retroactive elevation be approved. Mr. Kent seconded the motion.

The motion was adopted.

e. <u>Lane Closure: Northwestern Avenue (Between Bexley Road and Northridge Drive)</u> <u>– Street Department – Engineering</u>

Project Manager Benjamin Neild stated he was recently informed of a date change for this request and would update the memo accordingly. He requested approval of a lane closure on June 16, 2025, on behalf of the West Lafayette Street Department. The outside northbound lane of Northwestern Avenue, between Bexley Road and Northridge Drive, will be closed to facilitate sewer repair work at 1120 Northwestern Avenue.

Mr. Love moved that the lane closure be approved. Mr. Kent seconded the motion.

f. <u>Partial Lane and Sidewalk Closure: Northwestern Avenue and Vine Street – Ervin</u> <u>Cable Construction – Engineering</u>

Manager Neild requested approval of a partial lane and sidewalk closure on behalf of Ervin Cable Construction. From June 8 to 15, 2025, Ervin Cable will utilize the manhole path starting at 224 Northwestern Avenue and run north along Vine Street to install fiber optic cable for Frontier Communications. Each work zone location will restrict traffic for one hour as work moves along the manhole system.

Mr. Love moved that the partial lane and sidewalk closure be approved. Mr. Kent seconded the motion.

The motion was adopted.

g. <u>Interconnection Agreement: Solar IRA Initiative Fire Station No. 3 – Duke Energy</u> <u>– Development</u>

Director of Development Jenifer Van Schuyver requested approval of an interconnection agreement with Duke Energy to energize the solar panels on Fire Station No. 3. The panels were installed by Solar Energy Systems as part of the City's Solar IRA Initiative in an ongoing effort to reduce its carbon footprint. The Redevelopment Commission approved an agreement with Solar Energy Systems on October 16, 2024, to install solar panels on the roof of five public buildings, including Fire Station No. 3. The Board is authorized to approve ongoing management of City facilities and this agreement.

Mr. Love moved that the interconnection agreement be approved. Mr. Kent seconded the motion.

The motion was adopted.

We are requesting the Board of Public Works and Safety permission to approve the following Addendum to the contract. The original service agreement between the City and Lafayette Transitional Housing Center was entered on October 15, 2024. The contract was amended on April 29, 2025.

This Addendum allows eligible reimbursable expenses accrued within the program year to be reimbursed outside of the quarterly program year caps. Eligible reimbursements shall not exceed the contractual amount for the Supportive Housing Program.

This funding was allocated in 2024 by the Mayor's CDBG Advisory Board, and the budget was approved at the June 2024 City Council meeting. The funding is provided by the Community Development Block Grant through the U.S. Department of Housing and Urban Development.

ADDENDUM TO THE SOCIAL SERVICES AGREEMENT (2024-2025) BETWEEN

THE CITY OF WEST LAFAYETTE

AND

THE LAFAYETTE TRANSITIONAL HOUSING CENTER

This Addendum is entered into this _____ day of _____, 2025, by and between the City of West Lafayette (the "CITY") and the Lafayette Transitional Housing Center (LTHC), collectively referred to as the "Parties," and modifies the contract executed on the 29th day of April 2025.

RECITALS

WHEREAS, the CITY and the LTHC entered into an amended contract to allow eligible reimbursable expenses accrued within each quarter be expensed at three payments of \$3,402.48 and a final payment of \$3,402.46 for costs accrued in the corresponding quarter.

WHERAS, the CITY has reimbursed \$6,804.94 out of the \$13,606.90 eligible amount for reimbursement for Quarter 2 (October, November, December) and Quarter 3 (January, February, March).

WHEREAS, the Parties wish to allow costs accrued throughout the 2024-2025 program year be eligible for reimbursement for an amount not to exceed \$13,606.90.

NOW, THEREFORE, the Parties agree as follows:

1. REIMBURSEMENT OF ELIGIBLE COSTS

Eligible expenses that occurred within the 2024-2025 program year (July 1, 2024, through June 30, 2025) be reimbursed by amounts that exceed the quarter reimbursement caps to an amount not to exceed \$13,606.90 for the Supportive Housing Program.

2. EFFECT OF ADDENDUM

Except as modified herein, all terms and conditions of the contract entered on April 29, 2025, shall remain in full force and effect. In the event of conflict between this Addendum and the Contract, the terms of the Addendum shall prevail.

SOCIAL SERVICES AGREEMENT (2024-2025) AMENDMENT Lafayette Transitional Housing Center

THIS AGREEMENT, entered into this <u>29</u> day of <u>April</u>, 2025, by and between the City of West Lafayette, Indiana, a municipal corporation, by and through its Board of Works and Safety, hereinafter referred to as "City" and Lafayette Transitional Housing Center, a not-forprofit agency, organized pursuant to the laws of the State of Indiana, hereinafter referred to as "Agency",

WITNESSETH:

WHEREAS, pursuant to the Federal Housing and Community Development Act of 1974 and amendments and additions thereto, (Public Law 96-399), a program for Community Development Block Grants (CFDA Number 14.218) was initiated; and

WHEREAS, the Department of Development of the City of West Lafayette, by and through its duly authorized director, has prepared and initiated an application for participation and utilization of the above mentioned funds, which has been approved by the Common Council of the City of West Lafayette, Indiana, and thereafter approved by the United States Department of Housing and Urban Development; and

WHEREAS, it has been determined by federal and local officials that the City's activity is an eligible activity pursuant to the said Acts for allocation of a portion of the Community Development Funds for purchasing of social services which are supportive of and in addition to other Community Development activities; and

WHEREAS, the Common Council of the City of West Lafayette, Indiana, pursuant to RESOLUTION #13-2024 adopted on the 1st day of June 2024, did appropriate certain specific sums of money for the purchase of social services in the City of West Lafayette, Indiana, provided that said social service was a qualified and recognized social service agency to the citizens of the City of West Lafayette in connection with the Community Development Programs;

WHEREAS, the Agency hereunto is a duly authorized and qualified agency participating in said Community Development Program for the benefit of the citizens of the City of West Lafayette, Indiana; and

WHEREAS, the Mayor and Common Council of the City of West Lafayette have determined that the sum of Thirty-Two Thousand Five Hundred Eight-Four Dollars and Eighty-One Cents (\$32,584.81) shall and is to be expended for the purchase of social services from the Agency referenced herein; and

WHEREAS, it is the purpose of the Agreement to expressly document the Agreement by the parties hereto for the benefit of the persons serviced by the said Agency;

NOW, THEREFORE, in consideration of the mutual covenants and agreements by and between the parties hereto and for other good and valuable consideration exchanged between the parties hereto, the parties do hereby agree as follows, to wit:

1. The City does hereby agree to utilize funds received from the United States Department of Housing and Urban Development under the Community Development Act, and more particularly, the Community Development Block Grant (CFDA Number 14.218), to purchase from the Agency services to West Lafayette residents, and primarily to residents of low and moderate income, elderly residents, or disabled residents, for the period of this Agreement.

2. It is agreed by and between the parties hereto that payments by the City for services rendered to said citizens of West Lafayette shall be for a period beginning the 1st day of July, 2024, and ending the 30th day of June, 2025, said services to be prorated over that period on a periodic basis. All claims for services rendered by the Agency shall be made to the Director of Development of the City of West Lafayette on the duly designated forms with proper verification thereof as required by the City's Clerk.

The said services and funds to be expended by the City to the Agency shall be for services provided to the City and/or its citizens. Said services and duties are described in Exhibit A which is attached hereto and made a part hereof. If Community Development Block Grant funds will be used for operations with funds of similar characteristics, then the Community Development Block Grant resource will be separately identified as a source of funds in accordance with the principles of accounting.

It is understood by the parties hereto that in the event that the Agency utilizes all funds allocated to this particular Agreement prior to the ending of the period covered herein, then in that event the City shall not be responsible for any further funding and this Agreement is of no further force and effect.

In addition, it is agreed that if, for whatever reasons, sufficient sums of money are not available from the federal government and/or are revoked or terminated by the federal government for any reason whatsoever, then in that event the City shall not be responsible to the Agency for any further funding per this Agreement whatsoever.

It is agreed by the parties that in the event the Agency does not, for the period herein, utilize or furnish services equaling the amount of this Agreement, then in that event said funds shall revert to the City and be placed in its Community Development General Fund or other fund as specified by the Controller of the City of West Lafayette, and the Agency shall have no claim thereto.

Any CDBG program income, as defined in 24 CFR 570.500 (a) and 570.504, shall be reported to the City and retained by the Agency to be used for social services described in Exhibit A.

Program income received before expiration of this agreement may be retained by the recipient if the income is treated as additional CDBG funds subject to all applicable requirements governing the use of CDBG funds. Program income in the form of repayments to, or interest earned on, a revolving fund as defined in 24 CFR 570.500(b) shall be substantially disbursed from the fund before additional cash withdrawals are made from the U.S. Treasury for the same activity. Substantially all other program income shall be disbursed for eligible activities as described in Exhibit A before additional cash withdrawals are made from the U.S. Treasury.

The Agency also agrees to complete quarterly and annual reports on the approved form and to send such reports to the City. Such reports will differentiate the number and types of clients served within the City and will include data on the direct benefit to be reported according to the appropriate categorical columns.

The Agency also agrees to submit an annual budget, an annual financial report and a copy of the Agency's audit, which should include an A-133 audit should the agency expend more than \$500,000 in federal funds annually, to the City and gives permission to the State Board of Accounts to examine the Agency's account if deemed necessary by the State Board of Accounts.

3. The terms and conditions of this Agreement are subject to release of the Community Development Block Grant Funds (CFDA Number 14.218) from the United States Department of Housing and Urban Development.

4. The Agency must follow federal procurement rules when purchasing services, supplies, materials, or equipment. The Agency shall establish written procurement procedures. All procurement transactions shall be conducted in a manner to provide, to the maximum extent practical, open and free competition. The recipient shall be alert to organizational conflicts of interest, as well as, noncompetitive practices among contractors that may restrict or eliminate competition or otherwise restrain trade. Good procurement should identify and clearly specify standards for the goods or services the Agency wants to obtain, seek competitive offers to obtain the best possible quality at the best possible price, use a written agreement that clearly states the responsibilities of each party, keep good records, and have a quality assurance system that helps the Agency get what it pays for.

Some form of cost or price analysis shall be made and documented in the procurement files in connection with every procurement action. Price analysis may be accomplished in various ways, including the comparison of price quotations submitted, market prices, and similar indicia, together with discounts. Cost analysis is the review and evaluation of each element of cost to determine reasonableness and allowability.

There are four methods of procurement that are identified in the federal regulations. They are small purchase procedure, sealed bid, competitive proposal, and non-competitive proposal.

a. Small purchases procedure allows the Agency to acquire goods and services totaling no more than \$100,000, without publishing a formal request for proposals or invitation

for bids. This method of procurement is typically used to purchase commodities such as equipment or other materials. In the event that a grantee is purchasing materials that will exceed \$100,000, they must use the sealed bid process. In general, the small purchases procedures also should not be used to acquire construction contractors. It is recommended that these acquisitions occur under the sealed bid approach outlined below. Under the small purchase's method, the Agency sends a request for quotes to potential vendors with a detailed description of the goods or services needed. In return, they receive competitive written quotations from an adequate number of qualified sources. Each quote should include pricing information that allows the grantee to compare costs across bidders and ensure cost reasonableness. Documentation of the quote's hall be maintained in the Agency's files. The award should be made to the lowest responsive and responsible source.

b. Sealed bid (Formal Advertising) should be used for all construction contracts or for goods costing more than \$100,000. Competitive sealed bidding requires publicly solicited sealed bids and a firm-fixed-price lump sum or unit price contract is awarded to the responsible bidder whose bid, conforming to all the material terms and conditions of the invitation for bids, is lowest in price. In order for formal advertising to be feasible, the following minimum conditions must be present: A complete, adequate and realistic specification or purchase description is available, two or more responsible suppliers are willing and able to compete effectively for the Agency's business, the procurement lends itself to a firm fixed-price contract, and the selection of the successful bidder can appropriately be made principally on the basis of price.

When the competitive sealed bid (formal advertising) process is used, the following requirements apply:

Publication Period: The invitation for bids must be publicly advertised and bids solicited from an adequate number of suppliers. The publication should be published at least once in a newspaper of general circulation, providing sufficient time prior to bid opening. If the publication period is not of sufficient time to attract adequate competition, the bid may have to be re-advertised.

Clear Definition: The invitation for bids, including specifications and pertinent attachments, must clearly define the items or services needed in order for bidders to properly respond to the invitation.

Public Opening: All bids must be opened publicly at the time and place stated in the invitation for bids. The public is allowed at that time to review the bids.

Selection and Contracting: A firm-fixed-price-contract award must be made by written notice to the responsible bidder whose bid, conforming to the invitation for bids, is lowest. Where specified in the bidding documents, factors such as discounts, transportation costs and life cycle costs must be considered in determining which bid is lowest.

Rejection of all Bids: All bids may be rejected when sound documented reasons exist. Such documentation shall be made a part of the files.

c. Competitive proposals are used to purchase professional services where the total cost

will exceed \$100,000. Under this procurement method, the Agency must publish a written request for submissions and then review these submissions based on established selection criteria. The Agency must solicit proposals from an adequate number of qualified sources.

Under this approach, there are two possible methods of soliciting proposals. A request for proposals asks that offerors submit both qualifications and cost information. A request for qualifications can be used for purchasing architecture and engineering services. It only asks for information on the offeror's expertise/experience and not on cost, subject to a negotiation of fair and reasonable compensation. When acquiring any service that is not architecture or engineering, the full RFP process must be used. When acquiring architectural or engineering services, either an RFP or a RFQ may be used. When Competitive Proposals are utilized, the following requirements apply:

Publication Period: Proposals must be solicited from an adequate number of qualified sources and an advertisement must be published. RFPs/RFQs should be published in a sufficient timeframe before the proposals/qualifications are due.

Clear Definition: The RFP/RFQ must identify the general scope of work and all significant factors of evaluation, including price where appropriate, and their relative importance.

Technical Evaluation: The grantee must provide a mechanism for technical evaluation of the proposals received, determinations of responsible offeror and the selection for contract award.

Award: Award may be made to the responsible offeror whose proposal will be most advantageous to the procuring party, price and other factors considered. Unsuccessful offerors should be notified promptly. The contract can be either a fixed price or a cost reimbursement type.

d. Non-competitive procurement may be used only when the award of a contract is infeasible under small purchase procedures, sealed bids, or competitive proposals and one of the following circumstances applies:

Where the item is available only from a single source.

Where a public emergency or urgent situation is such that the urgency will not permit a delay beyond the time needed to employ one or the other procurement methods.

Where after solicitation of a number of sources, competition is determined inadequate.

5. The Agency agrees that, upon expiration of this Agreement, it will transfer to the City

any Community Development Block Grant funds on hand at the time of expiration and any accounts receivable attributable to the use of Community Development Block Grant funds. In addition, any real property under the Agency's control that was acquired or improved in whole or in part with Community Development Block Grant funds in excess of \$25,000, will be disposed of in one of two ways to be determined in writing by the City at the time of expiration.

- a. Real property will be used to meet one of the national objectives (Low/Mod, Slum/Blight, Urgent Need), as defined in paragraph 570.208 of the same Community Development Block Grant Handbook referenced above. The meeting of national objectives will continue for five years after expiration of the Agreement, or such longer period of time as determined appropriate by the recipient; or
- b. Real property will be disposed of in a manner which results in the recipient being reimbursed in the amount of the current fair market value of the property less any portion thereof attributable to expenditure of non-Community Development Block Grant funds for acquisition of, or improvement to, the property. Such reimbursement is not required after the period of time specified in accordance with paragraph (a) above.

6. The Agency agrees that no person on the ground of race, color, national origin, sex, gender, age, religion, familial status, or disability will be excluded from participation in, be denied the benefits of, or be subjected to discrimination under CDBG-assisted programs.

The Agency agrees to comply with City and State civil rights ordinances and with Title VI of the Civil Rights Act of 1964 as amended, Title VII of the Civil Rights Act of 1968 as amended, Section 109 of Title I of the Housing and Community Development Act of 1974, Section 504 of the Rehabilitation Act of 1973, the Americans with Disabilities Act of 1990, the Age Discrimination Act of 1975, Executive Order 11063, and with Executive Order 11246 as amended by Executive Orders 11375 and 12086.

The Agency will not discriminate against any employee or applicant for employment because of race, color, creed, religion, ancestry, national origin, sex, gender, disability, age, marital status or status with regard to public assistance.

7. No employee, agent, consultant, officer, or elected official or appointed official of the City or Agency which is receiving CDBG funds, who exercise or have exercised any functions or responsibilities with respect to CDBG activities, or who are in a position to participate in a decision-making process or gain inside information with regard to such activities, may obtain a personal or financial interest or benefit from such activities, or have an interest in any contract, subcontract, or agreement with respect thereto, or the proceeds thereunder, either for themselves or those with whom they have family or business ties, during their tenure or for one year thereafter, except for approved eligible administrative or personnel costs or when an exception is granted in accordance with 24 CFR 570.611.

8. The Agency certifies that no Federal appropriated funds have been paid or will be paid, by or on behalf of the undersigned, to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

The Agency further certifies that if any funds other than Federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with this Federal contract, grant, loan, or cooperative agreement, the undersigned shall complete an submit Standard Form-LL, "Disclosure Form to Report Lobbying", in accordance with its instructions.

9. The City agrees to make available for inspection copies of CDBG regulations. The Agency agrees to abide by all applicable CDBG regulations (24 CFR 570) and local laws and ordinances.

10. The Agency shall maintain client data demonstrating client eligibility for services provided. Such data shall include, but not be limited to, client name, address, income level or other basis for determining eligibility, and description of service provided. Such information shall be made available to City monitors or their designees for review upon request.

11. The Agency shall in all printed brochures and other materials which provide information related to funding sources acknowledge the financial support of the City of West Lafayette's CDBG program where appropriate.

12. The City will monitor the performance of the Agency against goals and performance standards required herein. Once a monitoring visit has been completed, the City will provide the Agency with a report of conclusions and/or findings. If findings are made, suggestions and/or resolutions will also be provided. Substandard performance as determined by the City will constitute non-compliance with this Agreement. If action to correct substandard performance is not taken by the Agency within a reasonable period of time after being notified by the City, contract suspension or termination procedures will be initiated.

Under the uniform administrative requirements of the CDBG regulations, the Agency is required to retain and make available all records and documents related to CDBG activities for a period of not less than four years.

14. The City reserves the right to require repayment of part or all of any payment under this Agreement if required by HUD in the exercise of corrective or remedial actions regarding the use of the funds by the Agency, as authorized under the regulations governing the CDBG program 17

or by the City for noncompliance with the terms of this contract.

15. The Agency shall hold harmless, defend and indemnify the City from all claims, actions, suits, charges and judgements whatsoever that arise out of the Agency's performance or non-performance of the services or subject matter called for in this Agreement.

16. The City or Agency may amend this Agreement at any time provided that such amendments make specific reference to this Agreement, and are executed in writing, signed by a duly authorized representative of both organizations, and approved by the City's governing body. Such amendments shall not invalidate this Agreement, nor relieve or release the City or Agency from its obligations under this Agreement.

The City, at its discretion, may amend this Agreement to conform with federal, state, or local governmental guidelines, policies, and available funding amounts, or for other reasons. If such amendments result in a charge in the funding, the scope of the services, or schedule of the activities to be undertaken as part of this Agreement, such modifications will be incorporated only by written amendment signed by both City and Agency.

17. Either party may terminate this Agreement at any time by giving written notice to the other party at least thirty (30) days before the effective date of termination. The City may also suspend or terminate this Agreement, in whole or in part, if the Agency materially fails to comply with any term of this Agreement, or with any of the rules, regulations or provisions referred to herein, and the City may declare the Agency ineligible for any further participation in City contracts, in addition to other remedies as provided by law. In the even there is probable cause to believe the Agency is in non-compliance with any applicable rules or regulations, the City may withhold all unpaid contract funds until such time as the Agency is found to be in compliance by the City or is otherwise decreed to be in compliance.

Exhibit A

Lafayette Transitional Housing Center (LTHC) provides 24/7 support for people who are experiencing homelessness. Their programs are centered around helping individuals find appropriate housing and connecting them with additional resources that are often needed to sustain housing for the long term.

The Homeless Services Program is for anyone in Tippecanoe County who is homeless or at-risk of becoming homeless. This program is open 7 days per week. The Day Services are open from 7:30am-8:30pm and the Night Shelter is open 8:30pm-7:00am. We offer a variety of supportive services on-site, including: client intake services, showers, laundry, mail, computer, lockers, meals, and more. Each client utilizing our services works with a Client Service Manager on developing their Housing Stability Plan to overcome their homelessness.

The LTHC Supportive Housing Program provide supportive housing for formerly homeless individuals and families through the Family Program, Eighth Street Commons and the Lincoln Center to. These housing projects provide not only housing, but also the client management support needed to keep people housed. Each tenant works with a Client Service Manager to increase income, obtain any benefits for which they could be eligible, and other necessary services in order to maintain housing.

This exhibit pertains to the contract agreement for the CDBG program year 2024-2025, which started July 1, 2024, and ends June 30, 2025. The contract amount for this program year is \$18,977.91 for the Homeless Service Program dispersed in quarterly reimbursement of \$3,629.33 for the first three disbursements and a final disbursement to the amount of \$8,089.92. The contract amount for this program year is \$13,606.90 for the Supportive Housing Program dispersed in quarterly reimbursement of \$3,402.48 for the first three disbursements and a final disbursement to the amount of \$3,402.46. Each drawdown request must be accompanied by a beneficiary report with supporting receipts from the quarter that the draw takes place. Following a delayed release of grant funds from the federal government – prior quarters will be reimbursed up to the current applicable quarter.

SERVICE AGREEMENT

THE CITY OF WEST LAFAYETTE, IN (the "City") agrees to retain **MERCHANT MCINTYRE & ASSOCIATES, LLC**, a Delaware limited liability company with a principal place of business in Washington, D.C. ("MM") (together, the "Parties"), for government relations services commencing on <u>August 1, 2025</u> and terminating on <u>July 31, 2026</u> (the "Term").

Fee. During the Term of this Agreement, the City agrees to pay MM a total professional fee of <u>\$8,000 per month</u>, billed monthly in advance. Payment shall be made to MM at the address listed on the MM invoice(s). Federal funds may not be used to pay MM professional fees.

Deliverables. MM agrees to provide the following deliverables during the Term of this Agreement:

- 1. Continue identifying federal grant opportunities for which the City is eligible and competitive.
- 2. Support the City in all facets of the federal funding process, including planning, partnership development, writing, budget development, proposal submission, administrative requirements, and compliance.
- 3. Continue engaging federal agency personnel with jurisdiction over funding on behalf of the City and building support for the City's priorities and grant applications among its Members of Congress.
- 4. Build, strengthen, and help leverage relationships with the City's Congressional delegation, the Administration, and other key decision-makers to support the City's position on federal legislation.

Assurances. In its capacity as a consultant, MM shall make its best effort to assist the City in pursuing its federal funding and government relations objectives. The nature of these objectives shall be determined by the City with the advice and assistance of MM. In this role, MM shall plan and implement all government relations strategies designed to accomplish the City's federal funding objectives; assist in the preparation of grant applications and supporting materials for the initiatives; develop meetings with Members of Congress, congressional staff, and federal agency decision-makers to advance the funding initiatives; and serve as liaison to federal agencies relevant to the City's funding initiatives. The City agrees to frequent communication with MM and to provide MM the necessary information in real time to help MM plan and implement strategies.

Indemnification. The City agrees to indemnify and hold MM harmless from and against all liability, including all actions, claims, damages, costs, and attorneys' fees, which MM may incur (or to which MM may be a party), arising out of actions taken or statements made by MM at the City's direction or based upon information provided by the City, except in the event of wrongful acts or omissions on MM's part.

Assignment. No other party shall assign any of its rights or delegate any of its duties or obligations under this Agreement without the express written consent of the other party.

The team at Merchant McIntyre appreciates and values the continued opportunity to serve the City of West Lafayette. We are greatly encouraged by our partnership over the last year and look forward to even greater success in future funding cycles.

As of June 2025, West Lafayette's partnership with Merchant McIntyre has resulted in **\$2,892,600** in federal funding, with a return-on-investment (ROI) of 13:1. Most notably, the City's EDA award to expand the North Side Regional Lift Station has enabled SK Hynix Inc. to establish an advanced semiconductor manufacturing facility and create over 800 high-skilled, well-paying jobs in West Lafayette. In addition to our funding wins, the City currently has over **\$2 million in pending proposals**.

Throughout our partnership thus far, MM has also significantly bolstered the relationship between West Lafayette and the City's Congressional Delegation and federal program staff. This has resulted in increased awareness of West Lafayette on the federal level, Congressional letters of support for West Lafayette's projects, and positions the City as a priority for Congressionally Directed Spending if Senator Young, Senator Banks, or Representative Baird choose to participate in the earmarking process in future appropriations cycles.

RECENT WINS AND SUBMISSIONS

- EDA Public Works and Economic Adjustment Assistance Program (PWEAA)
 - \$2,000,000 to expand the North Side Regional Lift Station, which will enable SK Hynix, Inc. to leverage federal CHIPS and Science Act funding to establish an advanced semiconductor manufacturing facility and create over 800 high-skilled, well-paying jobs in West Lafayette. This project has been a major priority for both

the Dennis and Easter Administrations, Purdue University, the Purdue Research Foundation, Greater Lafayette Commerce, and West Lafayette's Congressional Delegation.

- Indiana Dept. of Natural Resources (DNR) Land and Water Conservation Fund (LWCF) Grant Program
 - **\$492,600** to implement Phase 1 of the Happy Hollow Park Master Plan, which includes an updated children's garden, light-chasing sensory game, adventure trail, and overlook boardwalk.

• DOT Safe Streets and Roads for All Grant Program (SS4A)

- **\$280,000** to develop a Comprehensive Roadway Safety Action Plan for the City.
- Once the Action Plan is completed, MM will work with the City to apply for up to \$25 million in SS4A Implementation funding in the spring of 2025 or 2026.

This funding will also allow the department to effectively respond to the expanded service area, which includes the newly constructed housing developments on the northern side of West Lafayette.

Police and Fire departments have been notified, and appropriate pedestrian and vehicular detour signage will be in place during the closure.

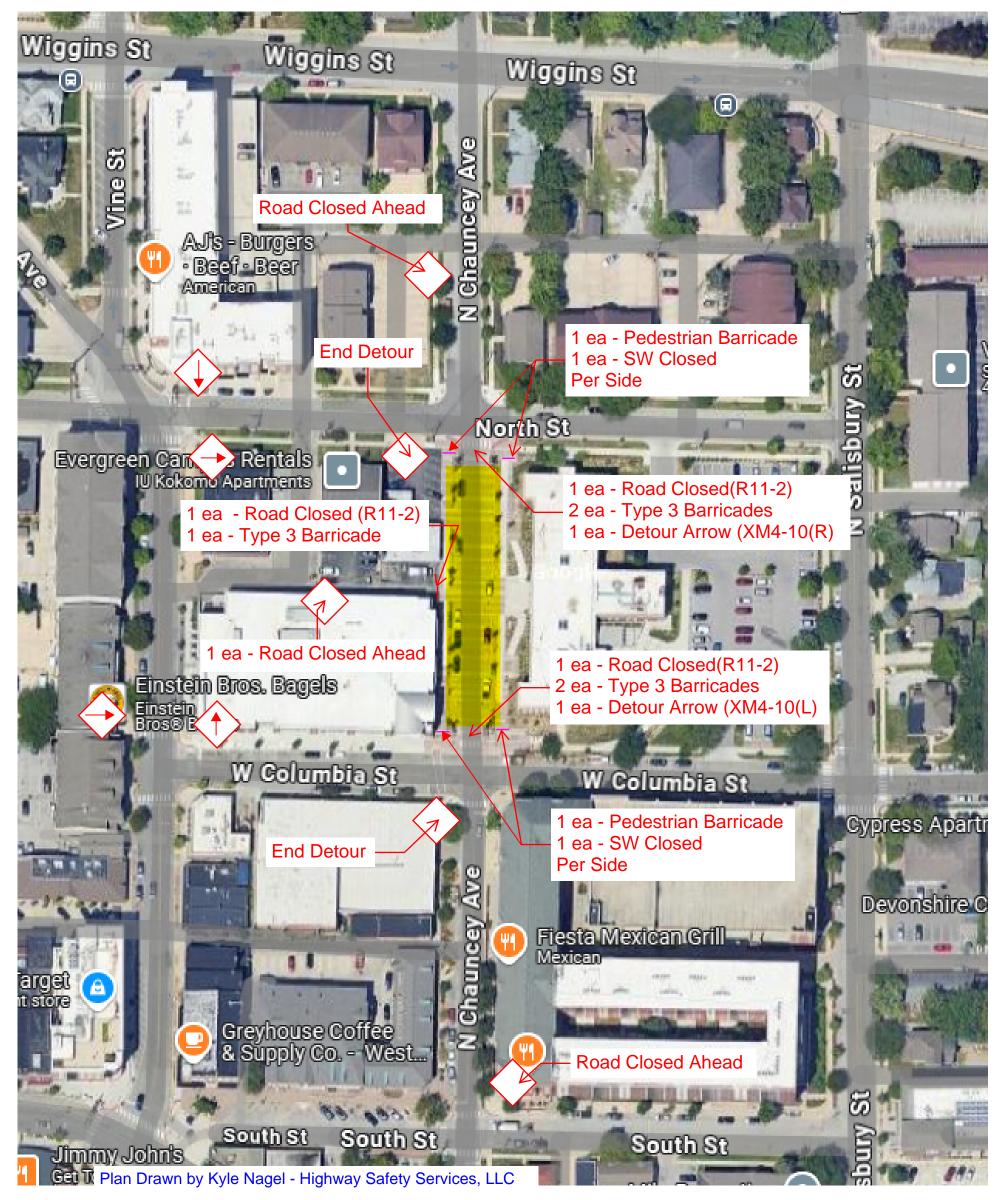

West Lafayette WRP Capacity Optimization Study AGREEMENT FORM

This agreement, made this 15th day of July, 2025, at West Lafayette, Indiana, by and between the Board of Public Works and Safety for the City of West Lafayette, Indiana (hereinafter referred to as the "City") and **DHI Water & Environment, Inc.** (hereinafter referred to as the "Contractor").

WITNESSETH:

That in consideration of the mutual covenants hereinafter set forth, the City and the Contractor agree as follows:

Article 1: SCOPE OF WORK

The Contractor shall furnish all labor and tools and equipment and do all things required for complete installation, construction, and resurfacing in accordance with the plans and specifications. The plans and specifications shall be on file in the Water Resource Recovery office.

Article 2: PAYMENT

The City shall pay to the Contractor, in full and complete payment for all performance of the Contract not to exceed the sum of **\$68,400.00** (sixty-eight thousand and four hundred dollars).

Article 3: CONTRACT DOCUMENTS

The contract documents include this agreement, executive summary, approach and scope, deliverables cost and schedule, example data request, example influent characterization sampling regime, IAW's "Good modeling practices", and terms and conditions.

Said documents are hereby incorporated into and made a part of this agreement the same as if herein fully set forth.

Article 4: SEVERANCE

The intent of the parties is that this agreement be deemed entire in the sense that its purpose is to establish one price for the doing of the whole work, and that it be deemed severable in the sense that the voidance of any part or portion shall not void the remainder.

It is understood and agreed that partial payments may be made for the mutual convenience of the City and Contractor but shall not be construed as the City's acceptance of a part or portion of the work. Acceptance is to only in the manner prescribed in the General Conditions.

Article 5: RECORDS

The Contractor will maintain proper records for review by the City.

Article 6: DATE OF COMPLETION

The Contractor agrees that he will have the work contained in this contract completed by six months from the project kickoff and fulfillment of initial data request.

Article 7: PREVAILING PARTY – ATTORNEY FEES

Notwithstanding any term or condition in this Contract to the contrary, in the event litigation is commenced to enforce any term or condition of this Contract, the prevailing party shall be entitled to costs and expenses of litigation including a reasonable attorney fee.

Article 8: NO INVESTMENT IN IRAN

As required by Ind. Code § 5-22-16.5, the Contractor certifies that the Contractor is not engaged in investment activities in Iran. Providing false certification may result in the consequences listed in Ind. Code § 5-22-16.5-14, including termination of this Contract and denial of future contracts, as well as an imposition of a civil penalty.

Article 9: NON-COLLUSION

The undersigned offeror or agent, being duly sworn on oath, says that he or she has not, nor has any other member, representative, or agent of the firm, company, corporation or partnership represented by him or her, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor to prevent any person from making an offer nor to induce anyone to refrain from making an offer and that this offer is made without reference to any other offer.

Article 10: E-VERIFY – USCIS Form I-9

Contractor shall comply with E-Verify Program as follows:

a. Pursuant to IC 22-5-1.7, Contractor shall enroll in and verify the work eligibility status of all newly hired employees of Contractor through the E-Verify Program ("Program"). Contractor is not required to verify the work eligibility status of all newly hired employees through the Program if the Program no longer exists.

b. Contractor and its subcontractors shall not knowingly employ or contract with an unauthorized alien or retain an employee or contract with a person that Contractor or its subcontractors subsequently learns is an unauthorized alien. If Contractor violates this Section 7(b), the City shall require Contractor to remedy the violation not later than thirty (30) days after the City notifies Contractor. If Contractor fails to remedy the violation within the thirty (30) day period, the City shall terminate the contract for breach of contract. If the City terminates the contract, Contractor shall, in addition to any other contractual remedies, be liable to the City for actual damages. There is a rebuttable presumption that Contractor did not knowingly employ an unauthorized alien if Contractor verified the work eligibility status of the employee through the Program.

c. If Contractor employs or contracts with an unauthorized alien but the City determines that terminating the contract would be detrimental to the public interest or public property, the City may allow the contract to remain in effect until the City procures a new contractor.

d. Contractor shall, prior to performing any work, require each subcontractor to certify to Contractor that the subcontractor does not knowingly employ or contract with an unauthorized alien and has enrolled in the Program. Contractor shall maintain on file a certification from each subcontractor throughout the duration of the Project. If Contractor determines that a subcontractor is in violation of this Section 7(d), Contractor may terminate its contract with the subcontractor for such violation. Such termination may not be considered a breach of contract by Contractor or the subcontractor.

e. By its signature below, Contractor swears or affirms that it i) has enrolled and is participating in the E-Verify program, ii) has provided documentation to the City that it has enrolled and is participating in the E-Verify program, and iii) does not knowingly employ an unauthorized alien.

Article 11: NON-DISCRIMINATION

Pursuant to Ind. Code § 22-9-1-10 and the City of West Lafayette's Municipal Code, the Contractor represents that it and its subcontractors shall not discriminate against any employee or applicant for employment to be employed in the performance of this Agreement, with respect to the employee's or applicant's hiring, tenure, terms, conditions or privileges of employment or any matter directly or indirectly relating to employment because of the employee's or applicant's race, religion, color, sex, disability, national origin, ancestry, veteran status, sexual orientation, or gender identity.

Article 12: COMPLIANCE WITH ACCESSIBILITY

It is the intent and goal of the city to ensure that all new construction within the City of West Lafayette shall comply with all ADA and PROWAG guidelines.

Pursuant to Title II regulations at 28CFR 35.151; and the 2004 ADAAG CFR part 1191, appendices B and D, the City of West Lafayette adopted the 2010 ADA SAD standards for new construction and alterations for facilities, and also adopted the Proposed Accessibility Guidelines for Pedestrian Facilities in the Public Right of Way (PROWAG) as published July 26, 2011.

Facilities located within the City of West Lafayette, the 2010 ADA SAD standards shall be met for new construction and alterations for projects within the City.

Facilities located within the right of way, PROWAG standards shall be met for new construction and alterations for project elements.

Fair Housing Act (FHA) and Section 504 of the Rehabilitation Act, and The Architectural Barriers Act (ABA) standards and guidelines shall be followed.

Accessibility guidelines shall be met on all projects requiring compliance with the FHA, Section 504, or the ABA.

Projects found to not be in compliance with these standards and guidelines will be accessed fines, as follows:

- Non-compliant fee (\$250 per day), and a "Stop Work" order will be issued.
- If after (3) violations and (10) business days to correct non-compliance issues, your contract will be revoked.

Article 13: COMPLIANCE WITH TITLE VI

It is the intent and goal of the City to ensure that all new construction within the City of West Lafayette shall comply with all TITLE VI guidelines.

Executive Summary

Objective

DHI Water & Environment, Inc. (DHI) will partner with the City of West Lafayette (WL) to collaboratively evaluate the maximum treatment capacity and loading of the water reclamation plant (WRP). This capacity optimization objective is to support ongoing and imminent expansion in the WL sewershed. By maximizing the capacity of existing treatment plant infrastructure, the project findings will assist in evaluation of future additional treatment requirements for WL to support local economic development.

Process Evaluation

DHI and WL will work together to build a deep understanding of the **existing treatment capabilities** through historical data evaluation, special sampling for influent characterization, activated sludge system nutrient profile sampling, a site visit, and virtual process meetings. DHI will develop and **calibrate a WEST process model** to further validate process understanding and evaluate the maximum load that the plant could handle under the current configuration and operations. Note that these activities are expected to be streamlined through DHI's existing understanding and WEST model of the WRP from 2018, however, should be thorough enough to reevaluate the current processes and underlying model assumptions.

Capacity Optimization

Design loads for WRPs are generally conservative. Recent adoptions of process optimization and automation strategies have allowed municipal WRPs to expand treatment capacity, reduce energy utilization, and meet new permit requirements with existing assets and infrastructure. Ultimately, this project team will **identify**, **assess**, **and virtually test optimization solutions** best fit for the WLWRP while loosely planning for long-term nutrient removal requirements and nitrification-denitrification (N/dN) capacity.

Relevant solutions for evaluation may include **total nitrogen (TN) control** for the aeration and activated sludge systems (including, e.g., mixed liquor return control, step-feed options, and swing zone automation), load equalization methods, carbon balancing, and flux-based return sludge control.

Special considerations will be made for the high-strength nutrient loads from sludge dewatering **return streams** as it pertains to future lagoon utilization. Considerations for side-stream treatment or equalization may be assessed.

Preferred scenarios will be further evaluated as high-level business cases to understand **requirements** and relative costs for implementation, **impact on treatment capacity**, and additional impacts on operations such as maintenance requirements, operational costs and/or savings, carbon footprint, and operability or robustness for permit compliance.

Deliverables, Schedule, & Cost

DHI will deliver a report summarizing the results and findings from the study. This report will balance **recommendations** to maximize existing process capacity with a conservative evaluation of the **true capacity** of the existing facilities. Recommendations will also include methods for WL to **validate** results through follow-up field testing and discussion of next steps for implementation of high-priority opportunities identified. The report will serve as backup for **WL planning decisions for expansion**.

DHI will strive to complete this work in close collaboration with WL within **6-months** of project kick-off and receipt of relevant initial data requests. The project will be executed for a total, lump-sum cost of **\$68,400**. This cost includes time, expenses for site visit(s), and any support DHI may seek from partners in the wastewater treatment industry such as Aarhus Vand or US-based municipal clients with similar issues.



Approach & Scope

The project is divided into the following work packages (WPs). While the scope items are described below for planning and cost estimation, each WP is designed to be flexible, allowing the project team to focus on relevant opportunities and aspects of the process as they are discovered.

Plant Process Evaluation

The main purpose of the plant process evaluation is to develop a deep understanding of the plant configuration, operation, capabilities, and bottlenecks, while providing a platform and common understanding from which DHI and WL project staff can collaborate. Individual scope items may include:

- Data Request
 - o DHI will plan a kickoff meeting to discuss current plant configuration, and,
 - Collaborate with WL project staff to develop an initial data request based on data availability and initial evaluation of project data requirements. An example data request is attached in APPENDIX A for reference and planning.
- Data Analysis
 - DHI will independently review the provided data and relevant studies to develop an unbiased analysis of current process operations.
 - This step will include data processing, statistical analyses, mass balancing, unit process efficiency and other process calculations.
- Process Team Workshops
 - DHI will present the results of the data analysis and prepare questions based on initial findings, patterns in the data, and process calculations.
 - DHI and WL project staff will collaborate via approximately biweekly process calls to discuss process-related opportunities and ideas based on the outcome of the above.
 - DHI will visit the WL plant for a field walk and in-person process workshop; note that this site visit is depending on DHI and WL travel availability and may be scheduled earlier or later in the project to accommodate.
 - Additional data requests will be submitted to WL as needed based on gaps in understanding and data identified through the data analysis and process team workshops.

WEST Model Calibration

DHI will develop and calibrate a dynamic WEST process model to emulate the WLWRP biological processes. This model will allow DHI and WL to confirm understanding of the plant developed in WP1 while preparing a model for use in scenario analyses in WP3. This is done through collaborative calibration steps, building trust in the model's predictive capabilities to enable the project team to extrapolate from baseline operation in the simulation environment.

General WEST model calibration steps are described below:

- Influent Fractionation
 - Estimating COD loading and fractionating influent COD loads into selected model components (e.g., soluble COD, VFA, slowly degradable particulate COD, etc.) is the most important and challenging step in process modeling.



- DHI will use available historical data, previous sampling campaigns or modeling efforts, and a primary clarifier mass balance to characterize the influent and build an initial fractionation model for the WL loads.
- However, to develop a sufficiently accurate model for predicting maximum plant capacity with a high-level of confidence, DHI recommends WL execute a special sampling campaign to further evaluate the influent. An **example** influent characterization sampling campaign is attached in APPENDIX B for reference.
- Additional considerations for fractionating the content of the food waste streams may be incorporated as a separate input to the model (e.g., lipids, carbohydrate, and protein content with relative nutrient load impacts to the sidestream)
- Overall Model Setup
 - o DHI will build a representative process layout focused on activated sludge unit operations.
 - Relevant model parameters (e.g., tank volumes, process temperatures, DO setpoints, etc.) will be incorporated.
 - DHI will present the initial model layout to WL for review.
- Model Calibration
 - DHI setup plots in WEST for comparing model results to measured data and evaluate these results together with WL.
 - Based on the above, the model may require updates to inputs or configuration of controls, and kinetic parameters may be tuned to enhance the calibration.
 - Last, WEST provides the unique ability for users to develop custom models which are often developed by DHI to better represent WRP operations and designs. Custom models may be developed for WL depending on the perceived need and complexity to implement.
- Model Validation
 - Depending on the project findings to this point, the calibrated WEST model will be validated by one of more of the following methods:
 - Test known scenarios and evaluated results compared to expected outputs (i.e., apply a change to the model such as stopping mixed liquor return and confirm that this impacts N/dN as one would expect, limiting denitrification)
 - Evaluate the extend of nitrification and denitrification in the individual anoxic and aerated zones. The example influent characterization sampling campaign attached in APPENDIX B also includes a recommendation for nitrogen profile sampling.
 - Use a test dataset from a period of sufficiently different operation and evaluate calibration for this new period (e.g., test a period where an aeration reactor was out of service).
 - Iterate- model calibration is an iterative process throughout which DHI with revisit assumptions, the fractionation model, inputs, and model parameters.

The resulting, calibrated baseline model will be documented and presented to WL throughout the calibration effort. The IWA's Task Group publication *"Good Modeling Practices"* includes stop criteria and an approach shown in APPENDIX C that will be generally followed by DHI for WL model calibration.

Scenario Analyses

DHI and WL will identify optimization opportunities and relevant increased load scenarios throughout the project. These opportunities will be catalogued and ultimately evaluated to understand their benefits and impacts to the plant from a holistic perspective. Scenarios will be identified and evaluated using the calibrated WEST process model where relevant. Other scenarios may be evaluated through engineering and operations workshops and



discussions with WL, DHI global WRP experts, and DHI partners in municipal utilities. Relevant scenarios will be specific to the findings of the previous WPs, however, are expected to include:

- Capacity Testing
 - The influent load in the model will be incrementally increased to identify breakpoints present in the process model.
 - Note that this evaluation will exclude hydraulic limitations, recommending additional studies if necessary and relevant.
 - Nutrient loads from food waste streams for anaerobic digestion will also be increased to evaluate impacts from elevated nutrient contributions from the sidestream.
- Activated Sludge Optimization
 - Aeration control methods may be feasible for intensifying N/dN processes in existing tanks.
 - Total-nitrogen control will likely be incorporated into the model to evaluate how to best utilize internal operating handles such as swing zones and mixed-liquor return.
 - The carbon balance will be evaluated to understand the impact of carbon removed from primary sludge vs. carbon limitations for denitrification.
 - Automated SRT control is a critical component of any activated sludge optimization strategy and may be considered with the above.
- Sidestream Handling
 - Sidestream treatment and dosing will be evaluated and may make use a rigorous liquid-gas phase transport and stripping model available in WEST.
 - Alternative sidestream treatment methods (e.g., anamox, bioaugmentation, etc.) may be considered if applicable.
- Miscellaneous Opportunities, e.g.:
 - Hydrocyclones for enhanced settling and potential to further intensify biological N/dN processes through sludge granulation.
 - Flux-based or automated sludge-blanket level control may be evaluated for return-activated sludge and secondary settling optimization.
 - Sensitivity and/or uncertainty analyses may be executed to quantify or qualify confidence in findings from preferred scenarios.

Reporting & Recommendations

DHI will document the methods, inputs, results, findings, and recommendations from the study. Additionally, highlevel costs to implement preferred solutions will be incorporated as recommendations are prioritized for WL consideration. The report will be developed to provide benefit analyses for capacity optimization and ultimately DHI's evaluation of the true process capacity of the existing facilities. Last, recommended solutions will be documented with recommended follow-up studies or validation testing to be performed to support WL capacity expansion decisions.



Deliverables, Cost, & Schedule

Deliverable

DHI will deliver a full report documenting methods, results, and recommendations for WL review. WEST model files will be made available to WL upon request; WL may request WEST licensure if internal modeling training and handover is required.

Cost Estimate

The estimated project cost, to be invoiced based on 50% and 100% completion of each WP as lump sum amounts, is \$68,400. DHI's standard project terms and conditions are attached in APPENDIX D.

APPENDIX A

Example Data Request

To support the plant process review and evaluations, DHI requests the following data. For all timeseries data, DHI requests three (3) years of daily average values. Items listed in **bold** are considered more critical. Note that this is an indicative list; data may not all be available, and DHI may request additional data throughout the project.

- Process flow diagram
- Current and anticipated discharge requirements (both outfall and reuse limits)
- Influent Flowrate
 - $\circ~$ Daily max and daily average flow
 - o Effluent flows (how much reuse, how much waste sludge/ brine, how much discharged to port)
 - \circ 3 days of diurnal flow detail (minute by minute) data for each season
- Raw Influent Concentrations (BOD, COD, TKN, NH₄, TP, TSS, alkalinity, pH)
 - $\circ~$ 10 or more soluble COD (sCOD) samples (coupled with total COD data)
 - $\circ~$ Any other influent data or influent streams.
- Activated Sludge System (first and second stage)
 - \circ Flowrates
 - Step-feed, mixed-liquor return, etc.

 - DO concentrations
 - MLSS concentration and/or SRT
 - Temperature
 - Physical data
 - # of tanks
 - Tank geometry (volume, depth)

 - Recorded air flowrate

Influent Characterization

Influent fractionation in wastewater treatment involves analyzing the composition of incoming wastewater to identify and quantify various organic and inorganic components. An example sampling campaign is described below to support this process.

One week of the following daily flow-proportional composite samples:

- Locations
 - Raw Influent
 - Primary Clarifier Effluent
 - Filtrate Return
 - Secondary Clarifier Effluent
- Tests
 - TSS, VSS
 - BOD5, filtered BOD5
 - □ Total COD, filtered COD, flocculated-filtered COD, acetate
 - \Box TKN, NH₄, NO₃

Aeration Tank Nutrient Profiles

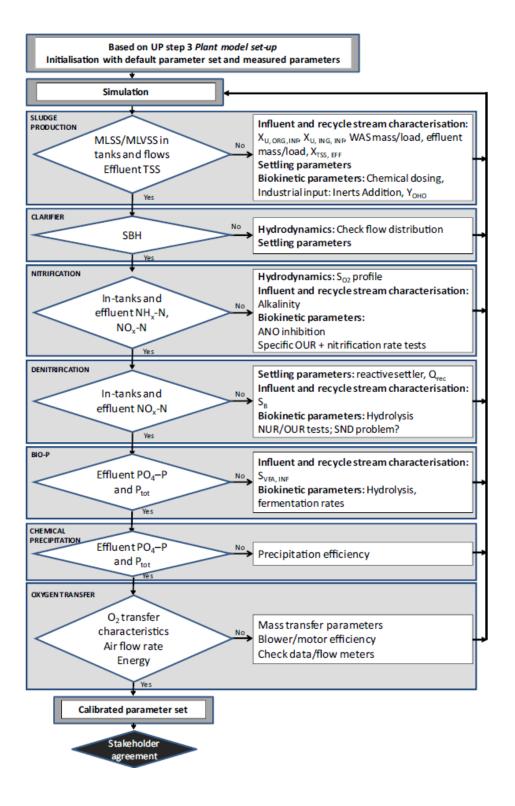
Understanding nutrient concentrations in each activated sludge zone assists in evaluating the true capacity of each zone. DHI recommends a set of grab samples from peak load and a set during off-peak operation:

- Locations- depending on the geometry and configuration of the activated sludge units, e.g.:
 - anaerobic zone influent
 - anoxic zone 1, anoxic zone 2
 - aeration zone 1, aeration zone 2
 - secondary clarifier effluent
- Tests
 - Soluble (filtered) COD
 - \square NH₄
 - □ NO₂, NO₃
 - □ Orthophosphate

DHI Standard Terms and Conditions



Terms and Conditions

1 GENERAL PROVISIONS

- 1.1 DHI: DHI Water & Environment, Inc., the party providing the Services to Client.
- 1.2 Client: The party ordering Services from DHI.
- 1.3 Scope of Services. The services to be performed by DHI (hereinafter called "the Services") are described in the "Purchase Order" and "Proposal" and are governed by these Terms and Conditions (hereinafter called "the Terms").
- 1.4 Purchase Order. Issued to DHI for the purchase of Services.
- 1.5 Proposal: Document that is presented to Client offering to perform the Services.
- 1.6 Integration. Any Purchase Order and attached documents (e.g. the Proposal) entered into pursuant to these Terms and those others incorporated herein constitute the entire agreement between the parties (the "Agreement") and cannot be changed except by a written instrument signed by both parties.
- 1.7 Relationship between the parties. Nothing contained herein shall be construed as establishing or creating a partnership between the entities.
- 1.8 Headings. The headings in these Terms and Conditions shall not be deemed to be part thereof or be taken into consideration in the interpretation or construction thereof.
- 1.9 Priority over Form Agreement/Purchase Orders. The parties agree that the provisions of these terms and conditions shall control over and govern as to any form writings signed by the parties, such as Client Purchase Orders, Work Orders, or other agreement forms, and that such forms may be issued by Client to DHI as a matter of convenience of the parties without altering any of the terms or provisions hereof.
- 1.10 Severability. In the event that any provision of this Agreement is found to be unenforceable under law, the remaining provisions shall continue in full force and effect.
- 1.11 Governing Law and Venue. This Agreement shall be governed in all respects by the laws of the State of Colorado. Any legal action brought under or in connection with the subject matter of this Agreement shall be brought only in the Federal or State courts sitting in Denver, Colorado. Each party submits to the exclusive jurisdiction of these courts and agrees not to commence any legal action under or in connection with the subject matter of this Agreement in any other court or forum.

2 COMMENCEMENT, COMPLETION AND ALTERATIONS

- 2.1 Commencement Date. The services shall be commenced as noted in the Proposal.
- 2.2 Completion Date. The services shall be completed according to the time schedule stipulated in the Proposal. In the event of delays due to circumstances beyond the control of DHI, the time schedule shall be revised in agreement with the Client.
- 2.3 Alterations. Should circumstances arise which call for modifications of the Purchase Order these may be made by mutual consent given in writing. Proposals in this respect from one party shall be given due consideration by the other party.

3 REMUNERATION

- 3.1 The Client shall remunerate DHI in respect of the Services in accordance with the conditions set forth in the Proposal, and in any event, within 30 days of receiving an invoice from DHI. In the event that Client fails to pay any undisputed fees within 30 days of the invoice date shall bear interest at a rate of two percent (2%) per month that the fees are not paid. In the event that Client fails to pay any undisputed fees within 60 days of their due date, DHI shall have the right to suspend its Services until such time as Client pays its fees in full.
- 3.2 In the event that any services are required supplementary to those detailed in the Proposal due to circumstances arising beyond the control of DHI, the parties will agree on necessary alterations or modifications to the Proposal and/or Purchase Order based on the Client's specific requests. DHI, upon additional scope and fee approval by the Client, shall receive additional remuneration which shall be computed on a time basis together with all reimbursable costs incurred, unless otherwise agreed to in writing.
- 3.3 Client may request additional services or modifications to the requested Services by delivering a written change order request to DHI. In the event that DHI receives a change order request, DHI will determine the cost and/or schedule impact, if any, of the requested change, and provide to Client a proposal for a change order ("Change Order"). Each Change Order will be effective when signed by both parties. DHI will not be obligated to perform the requested changes unless (i) the parties agree on the terms of a Change Order and (ii) the applicable Change Order has been executed by the parties.
- 3.4 In the case of delay on the part of the Client in performing its obligations under this Agreement, DHI, to the extent that such delay results in extra cost, shall be entitled to additional remuneration. Such additional remuneration shall be computed on an hourly basis using DHI's standard rates together with all reimbursable costs incurred, unless otherwise agreed to in writing.

4 ASSIGNMENT AND SUBCONTRACTS

- 4.1 Assignment. DHI shall not, without the written consent of the Client, assign the benefits, other than the assignment of any monies due or to become due under this Agreement.
 - 4.1.1 Unless otherwise specified in this Agreement, DHI shall not, without the written consent of the Client, in any way assign or transfer the obligations of this Agreement or any part thereof.
 - 4.1.2 The Client shall not, without the written consent of DHI, in any way assign or transfer the obligations of this Agreement or any part thereof.
 - 4.1.3 Notwithstanding any other limits in this Agreement, either party may assign its rights or obligations under this Agreement in connection with (i) the sale of all or substantially all of the party's assets or a line of business sale; (ii) the sale of a majority of the capital stock of the party; or (iii) the merger of the party with another entity. In each such instance, the party may transfer the Agreement to the acquirer or surviving company (in the case of a merger).
- 4.2 Sub-Contracts. Unless otherwise specified in this Agreement, the use of any sub-contract (excepting any and all DHI subsidiaries) or modification or termination thereof relating to the performance of the Services by DHI shall be made only with the advance written agreement of the Client. Written agreement shall not be unreasonably withheld.



5 COMPLETION, POSTPONEMENT, TERMINATION

- 5.1 By Notice of the Client. The Client may terminate this Agreement at any time by providing DHI with sixty (60) days' written notice. Upon receipt of such notice DHI shall take immediate steps to bring the Services to a close and to reduce expenditures to a minimum.
- 5.2 Force Majeure. DHI shall promptly notify the Client, in writing, of any situation or event arising from circumstances beyond DHI's control and which DHI could not reasonably foresee which makes it impossible for DHI to carry out in whole or in part his obligations under this Agreement (Force Majeure). Upon the occurrence of such a situation or event, the Services shall be deemed to be postponed for a period of time equal to that caused by the Force Majeure and reasonable period to remobilize for the continuation of the Services. DHI may by written notice to the Client terminate this Agreement if the Services have been postponed as provided for in this Clause 5.2 and the period of postponement has exceeded six (6) months.
- 5.3 Default by Either Party. Either party may terminate this Agreement for a material breach which remains uncured for thirty (30) days after the breaching party receives notice of such breach from the non-breaching party. The failure of Client to make full payment of any and all fees as enumerated in Clause 3 constitutes a material breach of this Agreement.
- 5.4 Entitlement of DHI upon postponement or termination. Upon postponement of the Services or termination of this Agreement under Clause 5.1, 5.2 or 5.3, DHI shall be entitled to receive the remuneration due and for Services performed up to the effective date of postponement or termination and reimbursement in full for such of the costs as shall have been incurred prior to the effective date of such postponement or termination and for all costs incidental to the orderly termination of the Services, including return travel of DHI's personnel, their dependents and effects.
- 5.5 Rights and Liabilities of Parties. Termination of this Agreement, for whatever reason, shall not prejudice or affect the accrued rights or claims and liabilities of either party to this Agreement.
- 5.6 Survival. All provisions of this Agreement for indemnity or allocation of responsibility or liability between Client and DHI shall survive the completion of services and/or the termination of this Agreement.

6 THE RIGHTS AND DUTIES OF DHI

- 6.1 DHI shall exercise all reasonable skill, care and diligence in the performance of the Services under the Agreement and shall carry out all responsibilities in accordance with recognized professional standards. DHI shall in all professional matters act as a faithful adviser to the Client. No other warranty, expressed or implied, is made or intended by this proposal, by oral statements made by DHI's representatives, by the performance of services, or by written reports or documents.
- 6.2 The remuneration of DHI charged to the Client according to the Proposal shall constitute DHI's only remuneration in connection with the Agreement and neither DHI nor DHI personnel shall accept any trade commission, discount, allowance or indirect payment or other consideration in connection with or in relation to the Agreement or to the discharge of his obligations thereunder.
- 6.3 DHI will provide the expert technical advice and skills which are normally required for the class of services for which DHI is engaged. Where specialist technical advice or assistance is required, beyond that committed under the Scope of Services as outlined in the Proposal, DHI may arrange for the provision of such services by a third party. The Client shall pay for all such services. However, DHI shall retain full and inseverable responsibility for all the Services which he is committed to render under this Agreement.
- 6.4 Equipment and materials furnished to DHI by the Client or purchased by DHI with funds wholly supplied or reimbursed by the Client shall be the property of the Client and shall be so marked. Upon completion or termination of the Services DHI shall furnish to the Client inventories of the equipment and materials referred to above as it then remains and dispose of same as directed by the Client.

7 LIABILITY OF DHI

- 7.1 LIMITATION OF LIABILITY CLIENT AND DHI HAVE DISCUSSED THE RISKS AND REWARDS ASSOCIATED WITH THIS AGREEMENT AS WELL AS DHI'S FEES FOR SERVICES. CLIENT AND DHI AGREE TO ALLOCATE CERTAIN OF THE RISKS SO THAT, TO THE FULLEST EXTENT PERMITTED BY LAW, THE TOTAL AGGREGATE LIABILITY AND/OR INDEMNIFICATION OBLIGATIONS OF DHI AND ITS PARTNERS, PRINCIPALS, DIRECTORS, EMPLOYEES, AFFILIATES, AND SUBSIDIARIES (THE "DHI PARTIES") TO CLIENT AND ALL THIRD PARTIES FOR ALL CLAIMS WHATSOEVER RELATED TO THE DELIVERABLES, THE SERVICES PROVIDED HEREUNDER, OR THIS AGREEMENT, INCLUDING ANY CAUSE OF ACTION SOUNDING IN CONTRACT, TORT, OR STRICT LIABILITY, WILL NOT EXCEED THE TOTAL AMOUNT OF THE FEES PAID TO DHI BY CLIENT DURING THE IMMEDIATELY PRECEDING TWELVE (12) MONTHS UNDER THE PROPOSAL OR PURCHASE ORDER THAT GAVE RISE TO SUCH LIABILITY. IN NO EVENT WILL ANY OR ALL OF THE DHI PARTIES BE LIABLE FOR ANY LOST PROFITS, INCIDENTAL, EXEMPLARY, INDIRECT, PUNITIVE, OR CONSEQUENTIAL DAMAGES, EVEN IF ANY OF THE DHI PARTIES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- 7.2 Insurance. DHI maintains insurance to statutory and professional standards for comparable Services of this type in this area at the time of service, and in accordance with any governing contractual requirements.

8 OBLIGATIONS OF THE CLIENT

- 8.1 The Client shall furnish without charge and within a reasonable time all pertinent data and information available to it and shall give such assistance as shall reasonably be required by DHI for the carrying out of its duties under this Agreement. The Client shall give its decision on all sketches, drawings, reports, recommendations and other matters properly referred to it for decision by DHI in such reasonable time as not to delay or disrupt the performance by DHI of his Services under this Agreement.
- 8.2 The Client shall facilitate the timely granting to DHI, and any DHI personnel, where the Services are at a site or sites outside DHI's control, of: (i) Necessary permits and licenses for right of entry; (ii) Unobstructed access to all sites and locations involved in carrying out the Services; (iii) Client will arrange right-of-entry to the property for the purposes of performing project management, studies, review of existing conditions and evaluations pursuant to the Services. Client represents that it posses sees or will possess necessary right-of-entry authority, permits, and licenses required for its activities at the site or sites.
- 8.3 The Client shall comply with its obligations under this Agreement in a manner consistent with all applicable laws and regulations.

9 PERSONNEL

- 9.1 The Services shall be carried out by personnel specified in the Proposal for the respective periods of time indicated therein, provided that DHI may make such reasonable adjustments in such periods as may be appropriate to ensure the efficient performance of the Services.
- 9.2 DHI shall designate a Project Manager to be in charge of the project and to be responsible for liaison between the Client and DHI.



9.3 Should it become necessary to replace any person specified by name in the Proposal, DHI shall, to the extent reasonably possible forthwith arrange for such replacement with a person of comparable experience. The party requesting the replacement shall be responsible for the financial consequences thereof, except in cases when DHI's personnel are replaced for reasons of proved misconduct, inability to perform or violation or laws. All such requests, for whatever reason, must be presented in writing with the particular reasons stated.

10 INTELLECTUAL PROPERTY RIGHTS

- 10.1 DHI warrants that it is not aware of any copyright, patent, trademark, trade secret or other proprietary right that it might infringe upon in providing the Services required under this Agreement. DHI shall indemnify and hold the Client harmless from any and all claims, suits, liability, expense or damages for any actual infringement of any copyright, patent, trademark, trade secret or other proprietary right arising in connection with the Services provided by DHI under this agreement.
- 10.2 With the exception of DHI Background Intellectual Property and any generic IP as described in Clause 10.4, all Intellectual Property created by DHI, sub-consultants or supplier during the course of the Services shall vest in the Client. DHI shall do all such things and sign and execute all such documents as may reasonably be required in order to perfect, protect or enforce any of the Intellectual Property assigned and granted to the Client at the Client's expense.
- 10.3 Background Intellectual Property shall mean all information (including without limitation, processes, methods, techniques, designs, structures, applications, software, and specifications) that is owned, controlled, licensed, developed, or acquired solely outside the performance of this Agreement by a party or on behalf of that party by an entity other than the other party. Nothing in this Agreement shall affect DHI's right to own or license its Background Intellectual Property.
- 10.4 The Client acknowledges that DHI possesses certain expertise, know-how, techniques, models, concepts, processes, software (including third party licensed software) and other intellectual property rights, which have been and will be developed by DHI, and which relate to DHI's business operations in general and not specifically to performance of the Services (the "DHI Property"). DHI Property is and remains the exclusive property of DHI and DHI shall not be restricted in using DHI Property. For the avoidance of doubt: Clause 10.2 does not apply to any generic tools, models, methods, techniques, software, algorithms, scripts, process, data, know-how generated, developed or obtained by DHI during the execution or performance of the Agreement and/or any Service as such is to be considered DHI Property. To the extent necessary for the Client to use the Services, DHI grants to the Client an irrevocable, royalty-free, world-wide and non-exclusive right to use DHI Property for the purpose of using the Services for the purpose of the Agreement for which the Services are created.
- 10.5 Notwithstanding any other provision in these terms or the Agreement, any use of DHI software (e.g. MIKE, NOCS or the like) will be subject to the terms and conditions set out in the applicable license agreement.

11 INDEMNIFICATION

- 11.1 Client and DHI shall each indemnify the other against claims for bodily injury or damage to tangible property resulting from:
 - 11.1.1 negligent error, omission, or act of the indemnitor or the indemnitor's agents, officers, servants, employees, or subconsultants in the performance of Services hereunder, or
 - 11.1.2 negligent failure of the indemnitor or the indemnitor's agents, officers, servants, employees, or subconsultants to comply with laws or regulations,
 - 11.1.3 negligent failure of the indemnitor to perform under any contract with either party's agents, officers, servants, employees, subconsultants, or clients, or
 - 11.1.4 claims of any type for violation of patent, trademark, or intellectual property rights claimed by Client, DHI or any third party resulting from the design or application of technology used on this Project.

This indemnity obligation shall survive performance of the services hereunder.

- 11.2 Client shall indemnify DHI against all costs, fees, expenses, damages, and liabilities (including legal defense costs) associated with any third-party claim, including any punitive damages, arising from or relating to:
 - 11.2.1 any claim or allegation that the Client Materials or DHI's licensed use of the Client Materials infringes or violates any third party rights, constitutes defamation or slander or unfair competition. or violates any law; or,
 - 11.2.2 any Services, deliverables, or other work product from DHI that Client uses or discloses to others in a manner other than that expressly permitted by this Agreement.
 - 11.2.3 The terms of this Clause 12.2 shall apply regardless of the nature of any claim asserted (including those arising from contract law, statutes, regulations, or any form of negligence whether of Client, DHI, or others whether arising out of tort, strict liability, or otherwise) and whether or not DHI was advised of the possibility of the damage or loss asserted. Such terms shall also continue to apply after any termination of this Agreement by either party and during any dispute between the parties.

12 DISCLAIMERS

12.1 EXCEPT AS EXPRESSLY STATED IN THIS AGREEMENT, THE SERVICES AND ANY DELIVERABLES ARE PROVIDED "AS IS" AND DHI DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, (i) IMPLIED WARRANTIES OF TITLE, NON-INFRINGEMENT, AND MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE; OR (ii) ANY WARRANTY THAT ANY SERVICE DELIVERABLE IS FREE FROM ERROR. NO WRITTEN OR ORAL INFORMATION OR ADVICE GIVEN BY DHI SHALL CREATE ANY WARRANTY.

13 CONFIDENTIALITY

13.1 The parties, from time to time, may disclose Confidential Information (as defined below) to one another. Accordingly, each party agrees as the recipient (the "Receiving Party") to keep strictly confidential all Confidential Information provided by the other party (the "Disclosing Party"). The Receiving Party further agrees to use the Confidential Information of the Disclosing Party solely for the purpose of exercising its rights and fulfilling its obligations under this Agreement. The Receiving Party may not use for its own benefit or otherwise disclose any of the Confidential Information of the Disclosing Party for any other purpose.



- 13.2 Confidential Information" means, subject to Clause 14.3 herein, information in any form, oral, graphic, written, electronic, machine-readable, or hard copy consisting of (i) any non-public information provided by the Disclosing Party, including but not limited to, all of its inventions, designs, data, source and object code, programs, program interfaces, know-how, trade secrets, techniques, ideas, discoveries, marketing and business plans, pricing, profit margins, and/or similar information; (ii) any information which the Disclosing Party identifies as confidential information or the Receiving Party should understand from the context of the disclosure, to be confidential information; or (iii) any information that the parties otherwise treat as confidential by their actions. Without limiting the generality of the foregoing, Client acknowledges and agrees that DHI's know-how constitutes Confidential Information.
- 13.3 The term "Confidential Information" will not include information that (i) is publicly available at the time of disclosure by the Disclosing Party; (ii) becomes publicly available by publication or otherwise after disclosure by the Disclosing Party, other than by breach of this Clause 14 by the Receiving Party; (iii) was lawfully in the Receiving Party's possession, without restriction as to confidentiality or use, at the time of disclosure by the Disclosing Party; (iv) is provided to the Receiving Party without restriction as to confidentiality or use by a third party without violation of any obligation to the Disclosing Party, or (v) is independently developed by employees or agents of the Receiving Party who did not access or use the Confidential Information.
- 13.4 The Receiving Party will inform those employees and consultants who have access to the Confidential Information of the Disclosing Party that such information is confidential and proprietary information of a third party. - 13.5 Notwithstanding the foregoing, the Receiving Party may disclose the Confidential Information of the Disclosing Party without violating the obligations in this Section 14 to the extent that such disclosure is required by a valid order of a court or other governmental body having jurisdiction, provided that the Receiving Party provides the Disclosing Party with reasonable prior written notice of such disclosure and makes a reasonable effort to obtain, or to assist the Disclosing Party in obtaining, a protective order preventing or limiting the disclosure and/or requiring that the Confidential Information so disclosed be used only for the purposes for which the law or regulation requires, or for which the order was issued.
- 13.6 Promptly upon the written request of the Disclosing Party or upon termination of this Agreement, the Receiving Party will return to the Disclosing Party or destroy all copies of the Disclosing Party's Confidential Information. DHI will, however, maintain a copy of any Confidential Information necessary to support its Services under this Agreement for reference and archive purposes and to protect its interests in relation to the Client or to comply with current legislation or public authority decisions, in accordance with applicable professional standards. The parties acknowledge that in the case of Confidential Information communicated through email or that has been scanned or otherwise stored electronically by the Receiving Party, the Receiving Party's deletion of (i) email messages from individual mailboxes, or (ii) documents from network or individual hard drives will not result in the removal of all copies of such information from the Receiving Party's back-up or archival systems.

- 14.5 The Client acknowledges that a violation of this Clause 14 shall be deemed a material breach of these Terms or the Agreement, and that the Client shall defend, indemnify, and hold DHI, its officers, directors, employees and shareholders harmless from any costs, expenses, fines, penalties or loss arising from its failure to comply with such applicable governmental laws and regulations.

14.6 The Client shall obtain and maintain at its own risk and expense from the appropriate authorities all permits and licenses necessary for the use of the Services.
