Members present were M. Michelle Dearing, Jason D. Huber, Thomas J. Kent, and Jeffrey W. Love. Clerk Sana G. Booker presided.

1. APPROVAL OF MINUTES

a. October 26, 2021, Meeting

Mr. Huber moved to accept the minutes of the October 26, 2021, Board of Works meeting.
Mr. Kent seconded the motion.

The motion was unanimously adopted.

2. NEW BUSINESS

a. Street Renaming: Challenger Avenue to Endeavour Drive – Purdue Research Foundation/Area Plan Commission

City Engineer Mitch Lankford requested approval of Purdue Research Foundation's petition to change the name of Challenger Avenue, just north of Kalberer Road off Yeager Road, to Endeavour Drive. The Area Plan Commission has checked and found no issues with making the change.

Mr. Huber moved that Street Renaming of Challenger Avenue to Endeavour Drive be approved. Mr. Kent seconded the motion.

Mr. Love asked if they said why they were making the change. Mr. Lankford stated that it is his understanding that with the building of a fuel facility out on Yeager Road and Challenger Avenue that there was some bad juju with the name Challenger being associated with rocket fuel. Endeavour was a better space shuttle choice to name it after than Challenger.

The motion was unanimously adopted.

b. Lane Closure: N. Salisbury Street – Salisbury Redevelopment Project – Engineering

City Engineer Mitch Lankford retroactively requested the approval of the southbound lane closure on Salisbury Street. This closure was for last week into today. Due to weather last week, the contractor had to extend the closure to today. After today they will need to do some temporary flagging operations to do some finishing touches on the curb work and the fill-in in the parkway. They will have the lane open this afternoon.

Mr. Huber moved that the lane closure on N. Salisbury Street be approved. Mr. Kent seconded the motion.

The motion was unanimously adopted.

c. Agreement: Snow Plowing Services – Pawnee Woods HOA – Street

Street Commissioner Ben Anderson requested to withdraw the Snow Plowing Services agreement with Pawnee Woods HOA. He asked that this agreement be tabled until a further date.

Mr. Huber moved that the Snow Plowing Services agreement be tabled until a time uncertain. Mr. Kent seconded the motion.

The motion was unanimously adopted.

► City Engineer Mitch Lankford stated that he recently spoke with our contractor that is doing curb, ramp, and pavement repairs in the Amberly Village subdivision. They are planning on finishing up the project this week and it will require a lane manipulation at Humboldt and Cinnabar. They will have signs up and direct traffic as needed. They will be using a high early-strength concrete mix, so once they pour one section it will be able to be open the next day and then switch to the other side.

► Commissioner Anderson gave a reminder that it is cold outside and to disconnect your garden hoses.

Signage and Barriers Required for Street Closure:

“Sidewalk Closed” signs – placed at southeast corner of State St / Marsteller St intersection to divert pedestrian traffic away from tree work. Sign at southwest corner of State St / Sheetz St to divert pedestrian traffic away from tree work.

Approximately 20 traffic cones or small barricades to mark lane closure of eastbound lane and lane shift of eastbound traffic into the westbound left turn lane.

SUBJECT: Task Order No. 15 – Tree Protection Standards

The Parks and Recreation Department requests the approval of Task Order No. 15 – Tree Protection Standards with Butler, Fairman and Seufert, Inc. for an amount **not-to-exceed \$5,850.00** to develop typical constructing guidelines for the protection of existing trees located within and adjacent to public works construction sites. These guidelines will be formatted to be included in the current West Lafayette Typical Construction Guidelines and Details.

This project is part of an overall update to the City's urban forestry inventory and standards update. West Lafayette has been awarded the Community and Urban Forestry Assistance grant, though the Indiana Department of Natural Resources Division of Community and Urban Forestry. This grant is a 50% reimbursement grant upon completion of the project. The grant also included acquiring TreePlotter PARKS inventory software, tree inventory update, and development of tree protection standards.

Project Description:

The Tree Protection Standards project consists of developing typical construction guidelines for the protection of existing trees located within and adjacent to public works construction sites. These guidelines will be formatted to be included in the current West Lafayette Typical Construction Guidelines and Details.

Project Scope:

Kick-off Meeting with Staff

- Meet with Engineering and Department of Development Staff to review and confirm project approach, scope, and gather initial formatting criteria and standards regarding the grant requirements and submittal milestone dates.

 - Construction specifications and guideline text for establishing tree protection requirements.
- Submit Draft Standards to the grant agency for preliminary approval.

Final Design

- Finalize details, drawings, specifications, and formatting.
- Submit Sheets to City to review final sheets before adopting into City Standards.
- Sheets submitted in digital format will be shared with Indiana Department of Natural Resources for possible adoption.

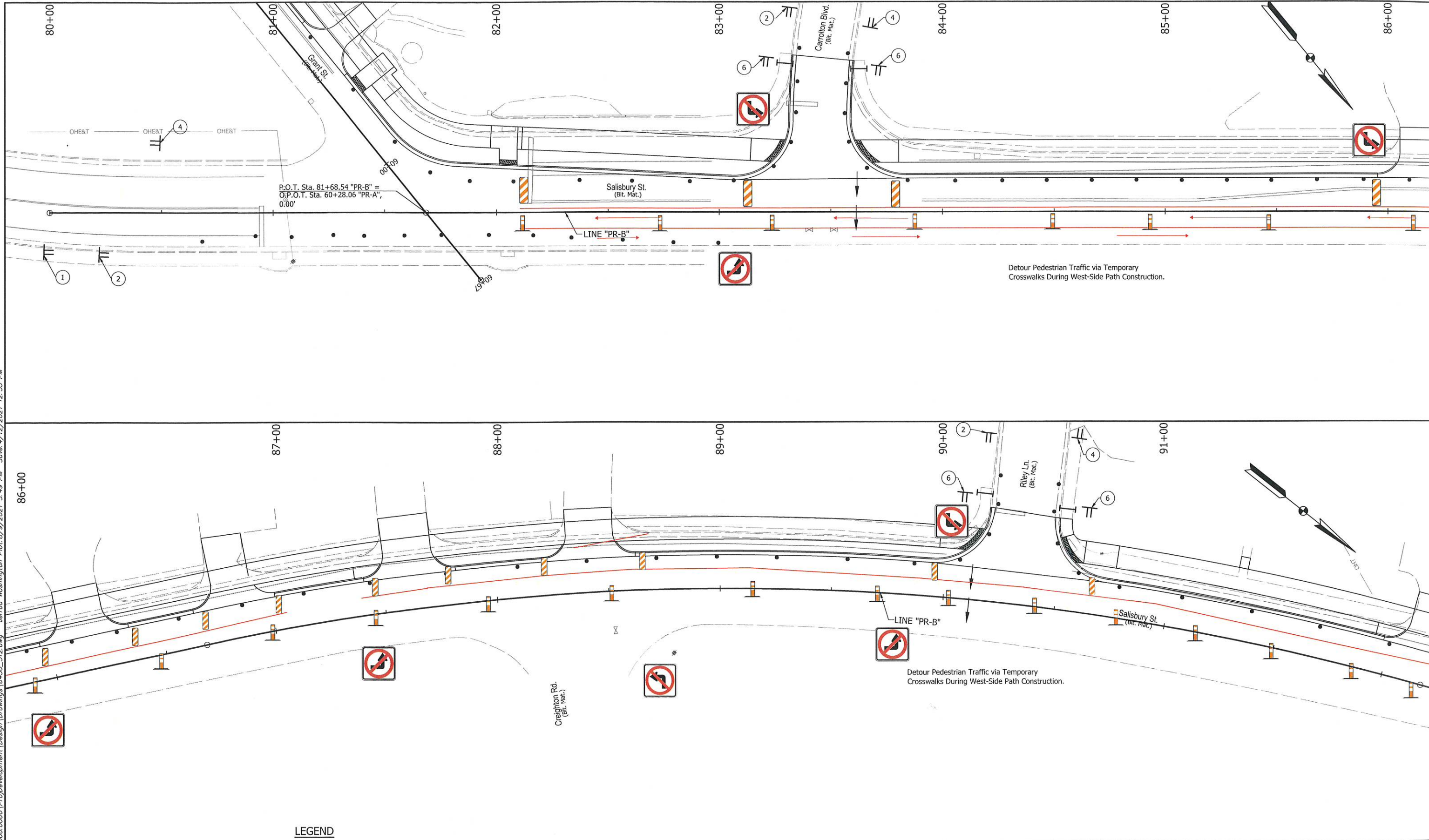

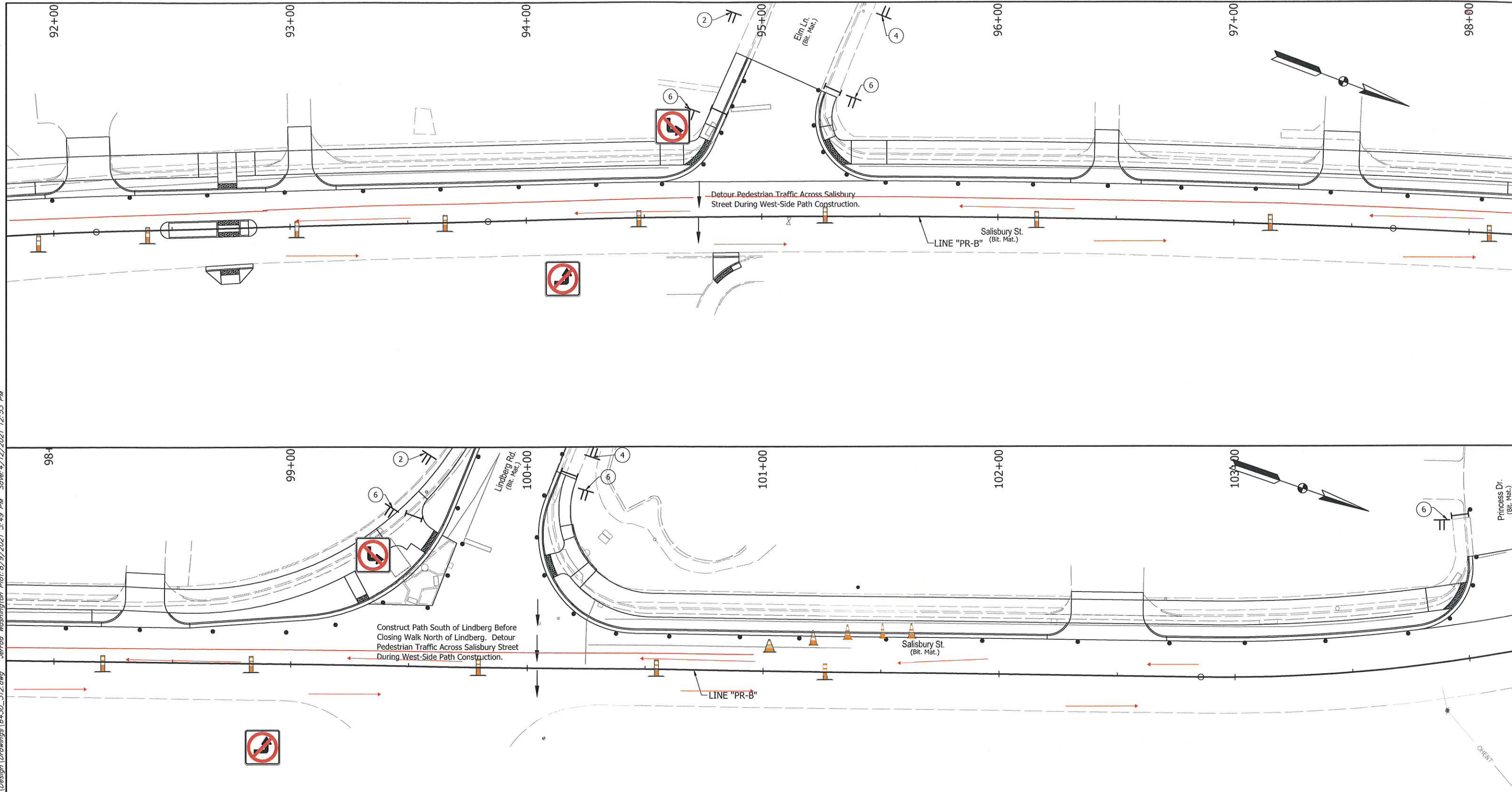

The Street Department respectfully requests approval by the West Lafayette Board of Public Works and Safety to enter into an agreement with Pawnee Woods Homeowners Association (HOA) in an amount not-to-exceed \$1,000.00 annually. The Street Department will provide snow plowing services as needed on 0.21 roadway miles.

**AGREEMENT TO PROVIDE SNOW PLOWING SERVICES TO THE PAWNEE
WOODS HOMEOWNERS ASSOCIATION, INC.**

WHEREAS, the City of West Lafayette, Indiana (the "City") has established, acquired, and financed its Wastewater Treatment Utility ("WWTU") pursuant to Ind. Code § 36-9-23-1 *et seq.* for the purpose of, among other things, the removal of snow from streets in and around the City;

WHEREAS, the WWTU is empowered pursuant to Ind. Code § 36-9-23-6(a) to "enter into all contracts or agreements necessary or incidental to the performance of its duties and the execution of its powers under [Ind. Code § 36-9-23-1 *et seq.*]";

WHEREAS, "sewage works" includes, pursuant to Ind. Code § 36-9-1-8(12), "the collection, treatment, purification, and sanitary disposal of liquid waste, solid waste, sewage, storm drainage, and other drainage of the municipality" including snow;

WHEREAS, the WWTU, through its Street Department, is responsible for plowing snow from all streets owned by the City;

WHEREAS, the Pawnee Woods Homeowners Association, Inc. (the "HOA") is an HOA and domestic nonprofit corporation located in the City;

WHEREAS, the HOA owns and is responsible for maintaining Pawnee Drive, Pawnee Place, Pawnee Circle, and Pawnee Park (the "Streets"), which account for approximately 0.21 miles of roadway. A true and accurate image of the area and properties that form the HOA is attached hereto as Exhibit A;

WHEREAS, the HOA currently contracts with the City for the removal and disposal of trash by the WWTU. A true and accurate copy of the agreement to remove and dispose of trash is attached hereto as Exhibit B; and

WHEREAS, the HOA wishes to further contract with the City for snowplowing services by the WWTU.

NOW, THEREFORE, in consideration of the premises hereof and the mutual covenants and conditions hereinafter set forth and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

1. **Recitals.** The foregoing recitals are true, accurate, and complete statements of fact and are hereby incorporated into and made a part of this Agreement as if set forth verbatim.
2. **Services.** The City, through the WWTU, agrees to provide snow plowing services, which includes salting and street pretreatment, to the HOA in accordance with the City's current snow plowing guidelines and procedures.

3. **Cost.** In exchange for providing snow plowing services to the HOA, the HOA shall pay the City \$1,000.00 annually on November 1 of each year that this Agreement is in effect.

4. **Term.** The term of this agreement shall extend from year to year unless terminated by either party in writing in accordance with Paragraph 5.

5. **Termination of Agreement.** Any party may terminate this Agreement by providing written notice of its intent to terminate this Agreement to the other party between May 1 and October 1 of each year that this Agreement is in effect.

Any party may terminate this Agreement upon a material breach of any of the terms of this Agreement following written notice of said breach and a failure to cure said breach within fourteen (14) days of the aforementioned written notice.

6. **Waiver and Indemnification.** The HOA agrees to waive, indemnify, and hold harmless the City, the WWTU, and its respective elected officials, employees, agents, contractors, and subcontractors from and against liability for all claims, losses, damages, and expenses to the Streets, including reasonable attorney fees, that occurs as a result of trash removal and/or disposal or snow plowing, salting, and street pretreatment for the benefit of the HOA and its members.

7. **Entire Agreement; Modifications.** This Agreement constitutes the entire agreement between the City and the HOA respecting the matters herein. This Agreement shall not be modified or amended except in a writing signed by the City and the HOA and/or their respective successors-in-interest and assigns.

8. **Notice.** Any notices under or pursuant to this Agreement shall be deemed duly sent when delivered in hand or when mailed by registered or certified mail, return receipt requested, addressed as follows:

Any party hereto may change such address by sending written notice of the change to the other party.

9. **Binding Effect.** This Agreement is made to bind each of the parties hereto in any capacity in which they have rights or authority and their respective assigns.

10. **Interpretation.** The captions used herein, if any, are for convenience of reference only and shall not be deemed to modify or construe this Agreement.

11. **Invalidity and Severability.** If any provision of this Agreement or the application thereof to any person or circumstance, for any reason and to any extent, shall be held to be invalid or unenforceable, then neither the remainder of this Agreement nor the application of such provision to any other person or circumstance shall be affected thereby, but rather the same shall be enforced to the greater extent permitted by law. The invalid or unenforceable provision shall be deemed modified to the minimum extent necessary to make the provision valid or enforceable; and, in modified form, that provision shall then be enforceable and enforced.

12. **Governing Law; Venue.** This Agreement shall be governed by, and construed in accordance with the laws of the State of Indiana without regard to its conflicts of law principles. Each party consents to the jurisdiction of any state court within Tippecanoe County, Indiana and also consents to service of process by any means authorized by Indiana law.

13. **Counterparts.** This Agreement may be executed in multiple counterparts, each of which, when so executed, shall be deemed an original, but all such counterparts, taken together, shall constitute one and the same Agreement.

14. **Prevailing Party – Attorney Fees.** Notwithstanding any term or condition in this Contract to the contrary, in the event litigation is commenced to enforce any term or condition of this Contract, the prevailing party shall be entitled to costs and expenses of litigation including a reasonable attorney fee.

15. **Survival.** Paragraphs 6 and 8-14 shall survive termination of this Agreement.

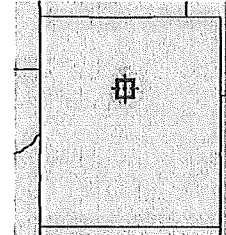

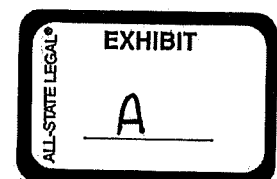

WHEREAS, the City, through its Street Department, provides various services to residents of the City; and

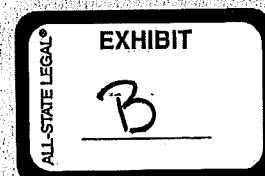
WHEREAS, Pawnee Woods desires to provide services rendered by the Street Department to its residents.

2. Pawnee Woods will pay to the City the sum of \$9.00 per unit, each resident will be billed monthly thru Waste Water Billing, subject to adjustment on 30 days written notice for trash pickup, recycling, brush removal and leaf pickup. Payment shall be made to the City.
3. Carts optional shall be billed individually to each property owner and checks shall be made to the City of West Lafayette. Cost per cart shall be \$55.00 including tax. Cart cost shall be confirmed before delivery. Cart maintenance is the responsibility of the property owner.
4. The term of this agreement shall extend from month to month unless terminated by either party in writing.
5. Pawnee Woods agrees to indemnify and hold the City harmless for any damages caused to the streets located in the Pawnee Woods Subdivision.
